COMMENT SOUGHT ON PETITION FOR DECLARATORY RULING OR RULEMAKING ON UNIVERSAL SERVICE CONTRIBUTIONS FOR CONFERENCE BRIDGE PROVIDERS

On June 4, 2010, Brennan Lynch LLP submitted on behalf of a petitioner that wishes to remain anonymous a petition requesting that the Commission issue a declaratory ruling setting a universal service contribution safe harbor percentage for conference bridge providers that offer jurisdictionally mixed service.¹ In the alternative, the petitioner requests that the Commission initiate a rulemaking proceeding to determine whether a teleconferencing safe harbor is appropriate.²

Interested parties may file **comments on or before July 22, 2010**, and **reply comments on or before August 6, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://fjallfoss.fcc.gov/ecfs2/</u>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
