## COMMENT SOUGHT ON MEETINGONE.COM CORP APPLICATION FOR REVIEW OF A DECISION OF THE WIRELINE COMPETITION BUREAU

On December 15, 2011, MeetingOne.com Corp. (MeetingOne) filed an application for review of a decision of the Wireline Competition Bureau (Bureau). In that decision, the Bureau found that: (i) the Internet Protocol audio bridging services offered by MeetingOne are subject to federal universal service fund (USF) reporting and contribution obligations; and (ii) prospective-only application of MeetingOne's direct USF reporting and contribution obligations in connection with its provision of audio bridging services is not warranted.<sup>2</sup>

Interested parties may file **comments on or before January 12, 2012**, and **reply comments on or before January 27, 2012**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
