## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON NORTHEAST MONTANA HEALTH SERVICES REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On November 15, 2011, Northeast Montana Health Services (Northeast Montana) filed a request seeking review of a decision of the Universal Service Administrative Company (USAC) in which USAC reduced Northeast Montana's funding request for Funding Year 2010 under the Rural Health Care program.<sup>1</sup> In its request, Northeast Montana asserts that USAC erroneously determined the service contract termination date.<sup>2</sup>

Interested parties may file **comments on or before January 18, 2012**, and **reply comments on or before February 2, 2012**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs2/>. Filers should follow the instructions provided on the website for submitting comments.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
