COMMENT SOUGHT ON UNIVERSAL SERVICE ADMINISTRATIVE COMPANY'S REQUEST FOR UNIVERSAL SERVICE FUND POLICY GUIDANCE

On March 1, 2011, the Universal Service Administrative Company (USAC) requested guidance from the Federal Communications Commission on certain issues related to universal service fund contributor reseller processes.¹ Specifically, USAC seeks guidance regarding situations in which a contributor attempts to provide post-dated certificates for its resellers after a finding by USAC that the contributor does not have appropriate documentation to justify its reseller classifications.²

Interested parties may file **comments on or before April 6, 2011**, and **reply comments on or before April 21, 2011**. All pleadings are to reference **WC Docket 06-122** and **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.³

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
