## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON PEERLESS NETWORKS, INC. EMERGENCY REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY AND REQUEST FOR WAIVER OF DEADLINE FOR FILING REVISIONS TO FCC FORM 499-Q

The Wireline Competition Bureau seeks comment on a request filed by Peerless Networks, Inc. (Peerless).<sup>1</sup> Peerless seeks expedited review of a decision by the Universal Service Administrative Company (USAC) that denied Peerless' request to revise its February and May 2013 FCC Forms 499-Q outside the 45-day filing deadline for revising those forms.<sup>2</sup> Peerless asks the Commission to waive the 45-day filing deadline for its February and May 2013 FCC Forms 499-Q and direct USAC to accept its revised forms.<sup>3</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules,<sup>4</sup> interested parties may file **comments on or before September 16, 2013 and reply comments on or before October 1, 2013**. All pleadings are to reference **WC Docket 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup>

• *Paper Filers:* Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by firstclass or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

**Ex Parte Rules.** The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>6</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed

consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
