The Wireline Competition Bureau seeks comment on a request filed by EasyLink Services International Corporation (Easy Link). EasyLink seeks review of an August 20, 2013 decision by the Universal Service Administrative Company (USAC) that denied EasyLink's request to reverse its outstanding account balance. EasyLink asks the Commission to waive section 54.713(b) its rules and cancel the interest and penalties assessed on EasyLink for failure to make timely payments on its outstanding USF contributions, and requests that the Commission direct USAC to perform an accounting of EasyLink's account.

Pursuant to sections 1.415 and 1.419 of the Commission's rules,⁵ interested parties may file **comments on or before December 2, 2013 and reply comments on or before December 16, 2013**. All pleadings are to reference **WC Docket 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁶

If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed

consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
