**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON MORRIS  
COMMUNICATIONS, INC. REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL  
SERVICE ADMINISTRATIVE COMPANY**

The Wireline Competition Bureau seeks comment on a request filed by Morris Communications, Inc. (Morris).<sup>1</sup> Morris seeks review of an August 30, 2013 decision by the Universal Service Administrative Company (USAC) that denied Morris's request to reverse late payment penalties and interest attributable to unpaid contributions reported on Morris's 2000 FCC Form 499-A for calendar year 1999.<sup>2</sup> Morris also requests relief from any disputed contribution obligations because of financial hardship and its inability to pay.<sup>3</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules,<sup>4</sup> interested parties may file **comments on or before December 18, 2013 and reply comments on or before January 2, 2014**. All pleadings are to reference **WC Docket 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup>

- *Electronic Filers:* Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- *Paper Filers:* Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

**Ex Parte Rules.** The proceeding this Notice initiates shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission's *ex parte* rules.<sup>6</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt,
