STREAMLINED RESOLUTION OF REQUESTS RELATED TO ACTIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

CC Docket No. 02-6
WC Docket No. 02-60

Pursuant to our procedure for resolving requests for review, requests for waiver, and petitions for reconsideration of decisions related to actions taken by the Universal Service Administrative Company (USAC) that are consistent with precedent (collectively, Requests), the Wireline Competition Bureau (Bureau) grants, dismisses, or denies the following Requests.¹ The deadline for filing petitions for reconsideration or applications for review concerning the disposition of any of these Requests is 30 days from the release date of this Public Notice.²

Previously, we denied All My Children Day Care’s request for a waiver of the deadline to file its application because the school owed a debt to USAC and was on “red light” status. *See Streamlined Resolution of Requests Related to Actions by the Universal Service Administrative Company*, CC Docket No. 02-6, WC Docket Nos. 02-60, 06-122, 10-90; Public Notice, DA 20-792 (WCB July 31, 2020). On reconsideration, All My Children Day Care raises a new argument. It argues that a waiver is warranted and its application should be funded because it has since repaid the debt and is no longer on red light status. We note that subsequent repayment of the delinquent amount that is in violation of the red light rule does not reverse the earlier dismissal of the application. *See Requests for Review of Decisions of the Universal Service Administrator by Net56, Inc., Wheeling School District 21, Schools and Libraries Support Mechanism*, CC Docket No. 02-6, Order, 28 FCC Rcd. 13122, 13126, para 6 (WCB 2013) (*Net56 Inc. Order*) (denying applications for E-Rate funding even though the red light debt had been satisfied).
