STREAMLINED RESOLUTION OF REQUESTS RELATED TO ACTIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

Pursuant to our procedure for resolving requests for review, requests for waiver, and petitions for reconsideration of decisions related to actions taken by the Universal Service Administrative Company (USAC) that are consistent with precedent (collectively, Requests), the Wireline Competition Bureau (Bureau) grants, dismisses, or denies the following Requests.¹ The deadline for filing petitions for reconsideration or applications for review concerning the disposition of any of these Requests is 30 days from the release date of this Public Notice.²

We find that all the petitioners listed above were unable to complete implementation for reasons beyond their control and made good faith efforts to comply with Commission rules and procedures. For Aurora Public Schools, we waive the special construction service delivery deadlines for the funding request numbers that were left off its original timely-filed extension. For Gallup McKinley County Schools, Navajo Nation Tribal Consortium and Newark City (Ohio) School District, we waive the special construction service delivery deadline and direct USAC to provide the applicants until June 30, 2025 to complete their special construction projects. Although Central Consolidated School District 22 and Utah Education and Telehealth Network do not propose specific deadlines for completing implementation of their special construction projects, we extend their deadlines until June 30, 2025.

For these petitioners, we also waive any associated administrative or procedural deadlines, including the invoice filing deadline, that might be necessary to effectuate our ruling. See *supra* note 4.
