Overall Comments

- The draft is consensus-oriented, vague and business-as-usual, lacking concrete, bold and critical measures despite the multidimensional crises we face today.
- Action oriented, comprehensive and responsive policy action merits much more than pegging
 on humanity's resilience to withstand disasters; the Declaration should in fact focus on
 multilateral systems' ability to prevent such crises as well as ensure their effective redress
 through political will and leadership necessary.
- Means of Implementation need to be operationalized through accountable policy action from the UN ensuring that commitments around financial, technical and technological support are mobilized and failure to do so is held accountable for.
- The universality of the Agenda 2030 can be reaffirmed when rights and responsibilities are universalized in letter and spirit; ensuring rule of the law above everything specially the corporate elephant in the room that needs to be recognized and held to account for the illicit financial flows (tax evasions, trade mispricing, asset stealth, profit shifting), environmental degradation (historical taxation on emissions, deliberate denial of science esp. extractive and mining industries), the instrumentalization of Investor State Dispute Settlement and other neoliberal tactics damaging the developing countries (robbing billions of dollars and shrinking their state policy space to protect citizen rights), through the abuse of weak legal infrastructure across the global south.
- Multilateral processes need to be democratized by denying preferential status to the profit-driven corporate sector, mainly responsible for the crises confronting humanity, across negotiation tables and ensuring meaningful civil society inclusion.
- We suggest stronger language on primacy of human dignity and rights, women's human rights, right to development, and prioritization of countries and communities in natural or man-made disasters, conflicts, occupied territories, underdeveloped and indigenous communities, to realize the ambition of leaving no one behind slogan.
- Also, stronger emphasis on concrete policy action on addressing systemic barriers including Unjust Trade and Investment Agreements, Corporate Capture, Land and Resource Grabbing, Climate Change, Patriarchy and Fundamentalisms, Militarism and Conflict, and Authoritarian Governance, among other emerging dynamics like technological takeover etc.
- We recommend the need to include strong language on ensuring policy coherence across UN as well as its affiliate and cooperative arrangement based partners specially WTO and IFIs such



as the IMF and World Bank and Co. to ensure avoiding the cliche of one step forward, two steps back in the decade of action and delivery for Sustainable Development.

• We recommend inclusion of Development Justice as a crosscutting emphasis across development processes to ensure Economic Justice, Redistributive Justice, Social and Gender Justice, Environmental Justice and Accountability to Peoples to reverse the trends on regressions across the Agenda 2030.
