- Scrivener or data entry errors with supporting documentation of error

INTERSEX

- (a) born with external biological sex characteristics that are irresolvably ambiguous;
- (b) is born with 46, XX chromosomes with virilization
- (c) is born with 46, XY chromosomes with undervirilization;
- (d) has both ovarian and testicular tissue; or
- (e) has been diagnosed by a physician, based on genetic or biochemical testing, with abnormal:
 - (i) sex chromosome structure;
 - (ii) sex steroid hormone production; or
 - (iii) sex steroid hormone action for a male or female.

May be changed at any time upon an affidavit attesting that the person is intersex, including any lab results re same.

ADULTS & EMANCIPATED MINORS

- No fraudulent purpose
- No effort to change conditions of imprisonment
- Outward expression of the sex designation sought in the petition for at least 6 months.
- Clinical distress due to current designation
- Court shall also consider the medical history and care as well as whether the change is a sincerely held part of the core identity.

- 15.5 to apply, order effective no earlier than age 16.
- Parental permission
- Child's best interest by clear and convincing evidence
- Guardian ad litem provides evidence:
 - Child is capable of making decisions independent of parent, guardian, custodian
 - Child appreciates the implications of the decision
 - Child meets other criteria



**OBJECTING
PARENT**

OBJECTING PARENT

Applicant must provide status of any divorce or custody matter pertaining to the child.

Notice to any parent must be provided with a chance to receive objection.

Court must consider these factors in its determination.

MINORS

All the requirements of adults/EM plus:

- 15.5 to apply, order effective no earlier than age 16.
- Parental permission
- Child's best interest by clear and convincing evidence
- Guardian ad litem provides evidence:
 - Child is capable of making decisions independent of parent, guardian, custodian
 - Child appreciates the implications of the decision
 - Child meets other criteria
