

2024–25 COMMUNITY ALL-STAR CONTEST

OFFICIAL CONTEST RULES

- **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.**

1. Sponsor and Administrator: 2024-25 COMMUNITY ALL-STAR CONTEST (“Contest”) is sponsored and administered by Boston Professional Hockey Association, Inc. (“Sponsor”).

2. General: The Contest begins on Monday, October 21, 2024, and runs until the Boston Bruins’ last home game of the 2024-2025 regular season on Tuesday, April 15th, 2025. Should the Boston Bruins compete in the 2025 postseason, Contest will run until the Boston Bruins are no longer active in the NHL postseason (collectively the “Contest Period”). One (1) winner will be chosen from all eligible entries approximately one day before each Boston Bruins regular season home game beginning October 10, 2024, and ending when the Bruins are no longer active in the NHL postseason. The odds of winning a prize depend on the total number of eligible entries received during the Contest Period (each an “Entry”). Sponsor cannot accurately predict the number of entrants who will participate in the Contest (each an “Entrant”). All times in this Contest refer to Eastern Time. By participating in the Contest, the Entrant acknowledges and agrees to be bound by these Official Rules, and agrees that all decisions of Sponsor, whose decisions are in its sole discretion, are binding and final. Failure to comply with these Official Rules will result in disqualification from the Contest.

3. Eligibility: The Contest is open only to Entrants and their nominees who are legal U.S. residents of MA, CT, NH, VT, and ME who are at least 18 years of age as of Monday, October 21, 2024. Void where prohibited. Employees of Sponsor, Delaware North Companies, Inc. - Boston (“DNCB”), Massachusetts State Lottery, New England Sports Network (“NESN”), and their respective parent companies, subsidiaries and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are ineligible to enter.

4. How to Enter: No Purchase Necessary to Enter or Win. To enter the Contest, nominate a Community All Star by filling out the form and submitting a photo and story of your nominee at <https://www.nhl.com/b Bruins/community/community-all-star>. The nomination should include a valid reason as to why the individual should be selected for this honor because of the work they have done in their community. Judging of all Entries and selection of the winner will be made by Sponsor. By submitting an Entry, each Entrant represents that the Entry is true and correct, and that he or she is

authorized to submit such Entry. By submitting a photo to the Contest, Entrant affirms that they have obtained written permission to submit the photo from all individuals whose image or likeness appears in the photo (or from the individuals' parent/legal guardian if any such individuals in the photo are under age 18). Entrant further affirms that they can provide reliable documentation of such permission upon request. Failure to obtain such permission may result in the disqualification of the submission at the Sponsor's sole and absolute discretion. Only one Entry per person. Sponsor will select the Entry with the best story from all the completed Entries (selected Entry is the "Winner").

Sponsor reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant and Winner understands and agrees that their Entry, including individual name may be posted online and further exploited by Sponsor for promotional purposes, without further compensation or review, and will not be returned. By entering this Contest, Entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Contest.

5. Prizes: Odds of winning a prize will vary based on the number of nominees in the Contest. One (1) prize per Boston Bruins home game, including the 2025 postseason, will be awarded during the Contest Period. Winners are eligible to win one (1) prize each only. The prize includes a dedicated post honoring the winner on the official Boston Bruins X and Facebook channels and four (4) loge tickets to a Bruins home game. Sponsor will determine an acceptable Bruins home game for the prize. Winner will also be shown on Hub Vision (Jumbotron) during the prize game, highlighting that they were that game's Community All-Star. The approximate value of the prize is \$220 per ticket, \$880.00 total. Sponsor reserves the right in its sole discretion to substitute or award an alternative prize of approximately equal value with no further obligation to the winner. The prizes cannot be exchanged for cash and there are no date or seat substitutions. Transfer of any prize is prohibited unless approved by Sponsor.

6. Determination of Winners: One (1) winner will be chosen from all eligible entries around 24 hours prior to each Boston Bruins regular season home game beginning October 10, 2024, and ending when the Bruins are no longer active in the NHL regular season or postseason. Sponsor will notify the Winner via the email provided in the Contest Entry form, and the Winner will be required to provide written consent of release giving Sponsor the irrevocable right without any further notice, review or consent to print, publish, broadcast, distribute, and use his or her photo, name and biographical information as news, publicity or information without any further compensation.

If any prize notification is undeliverable, if the Winner is not responsive within 24 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited and an alternate Winner will be selected from the remaining pool of eligible Entries.

Sponsor will have complete discretion over the interpretation of these Official Rules, of administration of the Contest, and of selection of the Winners. Sponsor's decisions are final, binding and conclusive on all matters related to the Contest.
