**ICIJ'S MEDICAL DEVICES STORY FOR 2018 WAS ONE OF THE HIGHEST-PROFILE, MOST IMPACTFUL STORIES OF THE YEAR. THIS FOLLOWS PARADISE PAPERS IN 2017 AND THE ACCLAIMED PANAMA PAPERS WHEN ICIJ AND ITS PARTNERS WERE AWARDED A PULITZER PRIZE FOR THIS PROJECT. THE IMPLANT FILES WAS THE FIRST-EVER GLOBAL EXAMINATION OF THE MEDICAL DEVICE INDUSTRY AND ITS OVERSEERS.
