Panasonic Announces Share Transfer of American Lighting Device Company

Osaka, Japan - Panasonic Corporation today announced that it has transferred all shares of Panasonic Lighting Americas Inc. (PLTA), its wholly owned consolidated subsidiary focusing on the lighting device and lighting control system business in North America, to global investment firm Atar Capital, LLC (Atar).

With the aim to expand its lighting business in North America, Panasonic acquired U.S. lighting device manufacturer Universal Lighting Technologies (ULT) in December 2007 and Canadian lighting system manufacturer Douglas Lighting Controls (DLC) in August 2010, making them wholly owned subsidiaries of PLTA, and worked to strengthen its sales to North American lighting fixture manufacturers, offering lighting devices for conventional light sources such as fluorescent lamps and mercury lamps, as well as power units for LED devices and lighting control systems.

In recent years, PLTA is expanding the lighting fixture business for stores which leverages the assets of ULT and DLC by integrating lighting fixtures and lighting control systems. In order to accelerate this business, Panasonic has determined to transfer the shares of PLTA to Atar, whose investment targets include companies in the same industry as PLTA. As Atar highly evaluates the technologies and product strengths PLTA has accumulated, Panasonic believes Atar is able to grow the business in North America on a sustainable basis. The shares of PLTA were transferred to Atar as of March 12, 2021.

Going forward, Panasonic will step up its effort to accelerate the replacement of conventional lighting fixtures with LEDs in Japan and broaden the use of new and high value-added products in order to maintain growth and expand the lighting business. With lighting fixture sales in Southeast Asia, India, and China as its growth engine, the company will work to achieve sustainable growth with profitability both in Japan and abroad.
