


WFAE DEVELOPED MORE DIGITAL ON-RAMPS TO DISTRIBUTE NEWS, POST IT QUICKLY ONLINE, SHARE IT ON SOCIAL MEDIA AND FIND IT ON DIGITAL DEVICES. INDEED, NPR METRICS RANKED THE STATION AS AMONG THE NATION'S TOP 25 IN DIGITAL GROWTH FOR THE FIRST QUARTER OF 2018. NEWS REPORTS BECAME MORE SUBSTANTIVE WITH MORE REPORTERS ON STAFF, MORE AGGRESSIVE LOCAL REPORTING ON WEEKDAYS, ENHANCED NEWS ON THE WEEKENDS AND THE INTRODUCTION OF NEW NATIONAL PROGRAMMING. IN ADDITION, WFAE'S JOURNALISTS ARE ENGAGING IN MORE LONG-FORM AND INVESTIGATIVE STORYTELLING, INTENTIONALLY REACHING OUT TO ADD DIVERSE VOICES AND ASKING QUESTIONS IN THE COMMUNITY MORE FREQUENTLY.
