Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office for Victims of Crime</u> (OVC) seeks applications for funding for the Fiscal Year (FY) 2023 Developing Future Victim Specialists to Serve American Indian/Alaska Native Victims of Crime program. This program furthers the DOJ's mission by focusing on cultivating and training a workforce that will be integral to increasing access to victim services for American Indians and Alaska Natives (AI/AN).

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Solicitation Categories

Eligible Applicants:

For profit organizations other than small businesses, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other

than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Small businesses

OVC will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the OJP Grant Application Resource Guide.

OVC may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Submission Information

<u>Registration</u>: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

<u>Submission</u>: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OVC seeks to develop a workforce of victim service providers to serve American Indian and Alaska Native (Al/AN) victims of crime in isolated locations. By identifying and training prospective victim service professionals in, or from, the communities to be served, Tribal and Bureau of Indian Affairs (BIA) victim service programs will be better able to fill these positions in remote Indian Country and Alaska Native locations, and in turn ensure that victims in these locations get the services they need.

Statutory Authority

34 U.S.C. § 20103(c)(1)(B)

Specific Information

One major issue facing BIA and many Tribally based victim service providers is that they are often unable to hire and retain qualified victim specialists and advocates that serve victims in remote Indian Country or Alaska Native locations.

There is little to no research available on best practices for recruiting and retaining victim service professionals specifically for Indian Country and Alaska Native communities. However, for the victim services field in general, it is known that "partnerships between universities and community providers are promising in their ability to improve fragmented service systems through coordination, streamlining, and capacity building [including workforce development]."[i] Practices from other fields, such as education and health care, provide valuable insight about how to recruit and retain staff for positions in rural and isolated areas. For example, in the field of education, there is evidence showing that it is easiest to fill positions in rural locations when staff have interpersonal connections to the location and are recruited from and have similar backgrounds to the service population.[ii]

In addition, nursing professionals have successfully implemented internship and other workforce development programs using a "grow your own" [iii] approach that requires recruiting and developing students that live and attend school in those communities. In

many cases, these initiatives have resulted in steady or decreased staff turnover rates, decreased vacancies for critical positions, and a larger, educated, and more engaged workforce.[iv]

Through this initiative, OVC seeks to have a similar long-term impact on the Tribal victim services workforce.

Successful applicant(s) will work to identify individuals who are interested in victim service positions specifically serving Tribal communities. Applicants will create (or continue operating) a victim service internship program that will place individuals in victim service positions either with a BIA or Tribally based victim service program (this can include victim service programs run by Tribal consortia). Applicants are responsible for creating and proposing the structural and administrative makeup of the program, which will include the process for identifying and selecting interns, setting requirements for the program, and addressing privacy issues associated with interns serving in direct service positions. Applicants are also responsible for working with their BIA district or a local Tribally based victim service program to place participants in internship, residency, or practicum experiences for credit or pay.

While applicants may focus their programs on recruitment, training, and placement of current or recent college/university students, applications proposing programs that focus on training other interested individuals (e.g., mid-career professionals seeking a career change, community members without a college education, etc.) are also welcome.

Geographic diversity will be an important consideration in selection, and OVC hopes to fund various programs across the contiguous United States and Alaska.

Goals, Objectives, and Deliverables

Goals

The goal of this project is to develop victim service professionals who will provide direct services to AI/AN victims in locations that are remote and where positions are hard to fill. This will be accomplished by engaging interested individuals, including but not limited to, college and university students, who are from, live, and/or attend school in these areas.

Objectives

An applicant should address all the objectives listed below:

 Establish (or continue operating) and administer a structured program that links individuals interested in victim service careers to internship or residency opportunities with either a BIA or Tribally run victim services program. (This can include programs run by Tribal consortia.) Applicants may include incentives for participants, including, but not limited to, a stipend, course credit, tuition

- assistance, or priority consideration for future employment opportunities.
- Provide supervision and training to participants in the program by experienced victim service professionals.
- Establish baseline data and a data collection process for performance metrics. In addition to satisfying OVC reporting requirements, this data could potentially be used in an additional OVC evaluation or assessment of the program or to inform recruitment and workforce-building practices for other victim service programs that serve Al/AN communities.

Deliverables and Activities

Successful applicants will complete the following activities to accomplish the above objectives:

- Demonstrate the existence of a relationship between a Tribal victim service program and an organization, such as a university program or Tribal coalition, that will refer, train, and supervise individuals interested in paid victim services internships or residencies in AI/AN communities.
- Identify victim service program staffing needs and determine how victim service internships/residencies would address these needs. Provide the number of internships/residencies necessary and sample job descriptions for the participants.
- Develop a list of selection criteria that participants must meet to be selected as victim service interns/residents.
- Determine the program requirements a participant must meet to successfully complete the program.
- Identify, recruit, and hire individuals who meet the necessary criteria.
- Provide training and other necessary support, including safety planning, to interns/ residents. Training and support needs will be identified by the grantee and should consider differences in training needs depending on the types of interns/residents participating. (For example, if the program accepts interns who are current college/ university students, recent college graduates, and interns without a college education, the applicant should explain how training will be tailored to meet the needs of these different intern groups.)
- Work with OVC, or an OVC designee, to measure the success of the program by assessing the impact that the participants have had on the victim services program and the community served, and the number of participants who pursue (or plan to pursue) a career in providing victim services for Tribal communities after completion of the internship/residency.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants webbased form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 20 double-spaced and numbered pages. If the Proposal Narrative fails to comply with these length restrictions, OVC may consider such noncompliance in peer review and in final award decision. Tables, charts, and graphs included in the proposal narrative count toward the page limit.

The Proposal Narrative must include the following sections:

a. Description of the Issue

- Include a description of the service area for the proposed program, including demographic information that describes the Al/AN population in the service area.
- Describe the victim services needs in the community that will be served.
- Describe the difficulties that the associated victim services program has had with hiring or retaining necessary, direct victim services staff in the past.
- Provide a clear statement about how funding will support recruitment, hiring, training, and supervision of victim services interns/participants; and how paid internships/residencies will support both the individual program and the AI/AN community served.

b. Project Design and Implementation

Applicants must provide a coherent, concise, comprehensive plan describing how the proposed program will be implemented, including the following:

- Detailed goals and objectives that will be completed during the 36-month award period that align with the project goals and objectives in the Goals, Objectives, and Deliverables section of the solicitation.
- A detailed, 36-month project timeline. The timeline can be submitted as a separate attachment.

c. Capabilities and Competencies

Applicants must demonstrate the ability to identify, recruit, hire, train, supervise, and retain individuals interested in working in the victim services field; coordinate and manage key stakeholders; and work with Tribal governments, Tribal organizations (including Tribal coalitions), Federal Government offices, colleges and universities, and other stakeholders to identify staffing needs for victim services programs serving Tribal communities. Applicants must describe their experience working with Tribal governments and Tribal organizations and an understanding of cultural sensitivity in working with Tribal populations.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the project's impact. Describe the process for accurately reporting data.

Note: An applicant is not required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

OJP will require each award recipient to submit regular performance data that show the completed work's results. The performance data directly relate to the goals, objectives, and deliverables identified in the "Goals, Objectives, and Deliverables" discussion. Applicants must submit a budget for a 36-month project period using the budget worksheet attachment. The budget must show calculations for requested funding and narrative descriptions for all proposed expenses. The proposed budget must not exceed \$500,000 and must be consistent with activities described in the proposal narrative.

For applications submitted that include subawards to other entities, applicants are encouraged to develop and submit signed MOUs or signed Letters of Intent that provide a detailed description of how the agencies will work together to meet project requirements.

Each MOU or Letter of Intent should include the following: (1) names of the organizations involved in the agreement; (2) scope of the direct service(s) and other work to be performed under the agreement; (3) duration of the agreement. Subcontracts, MOUs, or Letters of Intent should be submitted as one separate attachment to the application.

The timeline must provide for submission of required quarterly financial status reports and semi-annual progress reports. Both the project timeline and proposal narrative will be evaluated to determine scoring for the criterion "Program Design and Implementation Plan," worth 40 percent of the peer review score. (See the section titled "Review Criteria" for additional information.) The timeline can be submitted within the proposal narrative or as a separate document. If submitted within the proposal narrative, the timeline will count toward the 20-page narrative limit. If submitted as a separate document, the timeline will **not** count toward the 20-page limit for the proposal narrative.

Letters of Support

Applicants should submit letters of support from key Tribal stakeholders and other stakeholders involved in the project. In cases where the applicant has submitted a signed MOU with an entity, a letter of support from the same entity is not needed.

Research and Evaluation Independence and Integrity Statement

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity, including appropriate safeguards, before it may receive award funds. The applicant will upload documentation of its research and evaluation independence and integrity as an attachment in JustGrants. Experiencing Unforeseen Technical Issues Preventing Submission of an Application

- 2. Project Design and Implementation (40%)- evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
- 3. Capabilities and Competencies (20%) evaluate the applicant's administrative and technical capacity to successfully accomplish the goals and objectives.
- 4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (5%) evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
- 5. Budget (15%) evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

Other Review Criteria/Factors

Other important considerations for OVC include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Worksheet and Narrative accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are

common requirements applicable to all OJP solicitations:
