Dear Dr. Keusch:

The Select Subcommittee on the Coronavirus Pandemic (Select Subcommittee) is investigating the origins of the coronavirus pandemic. During this investigation, the Select Subcommittee discovered that Dr. David Morens, Senior Scientific Advisor of the National Institute of Allergy and Infectious Diseases (NIAID), potentially used a personal e-mail account to avoid transparency and that he may have deleted federal records.<sup>1</sup>

The Select Subcommittee is now aware of potential further attempts by Dr. Morens to subvert public transparency. Specifically, the Select Subcommittee has been made aware of alleged communications between Dr. Morens and you regarding EcoHealth Alliance, Inc. (EcoHealth). These communications included emails from Dr. Morens' personal Gmail account to you and Dr. Peter Daszak of EcoHealth. It is unclear the extent of your communication with Dr. Morens, or others within the Federal government, but according to a whistleblower, examples of these emails include:
