(57) **CLAIM**

I claim, the ornamental design for a wireless keyboard, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a wireless keyboard showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is another side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a top, rear perspective view thereof;
FIG. 9 is a bottom, rear perspective view thereof; and,
FIG. 10 is an enlarged view of the portion A as shown in FIG. 1.

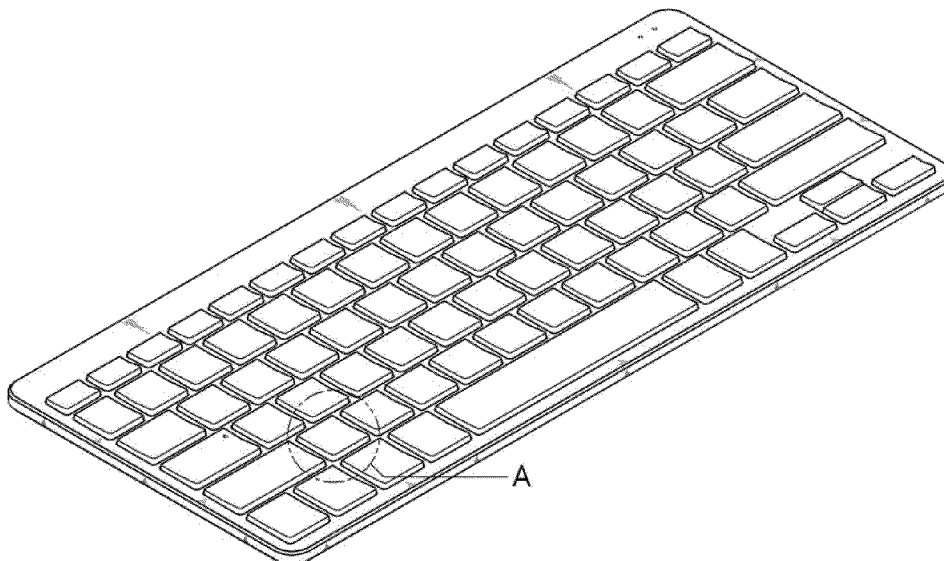

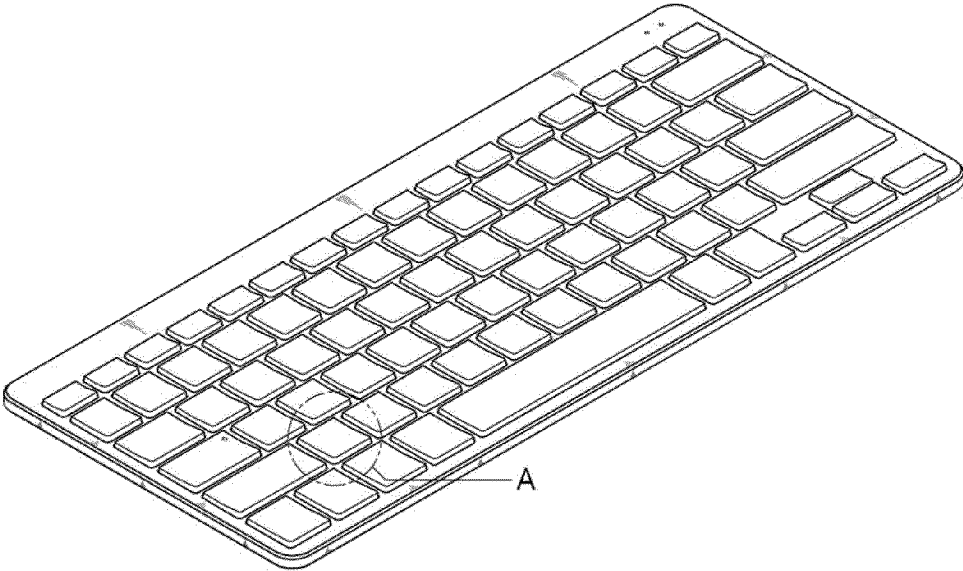

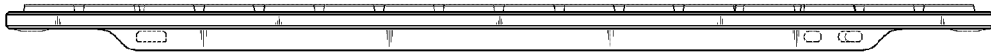

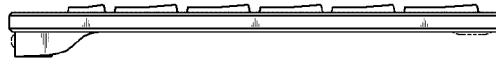

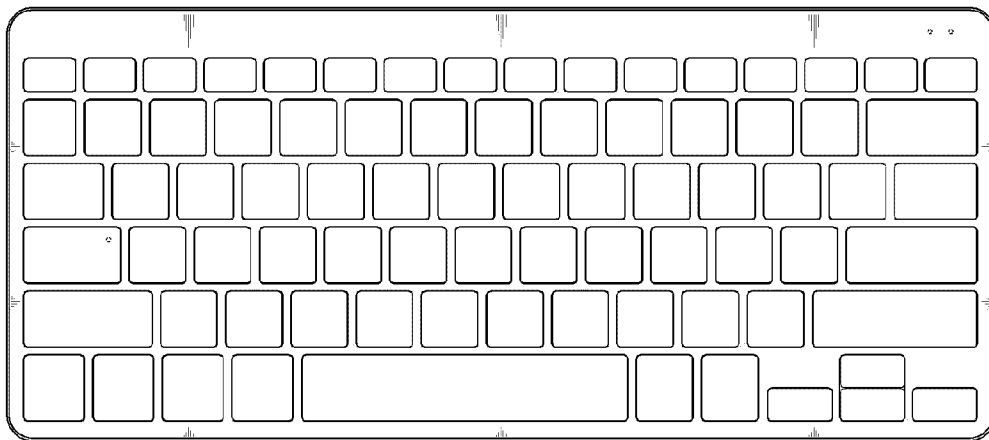

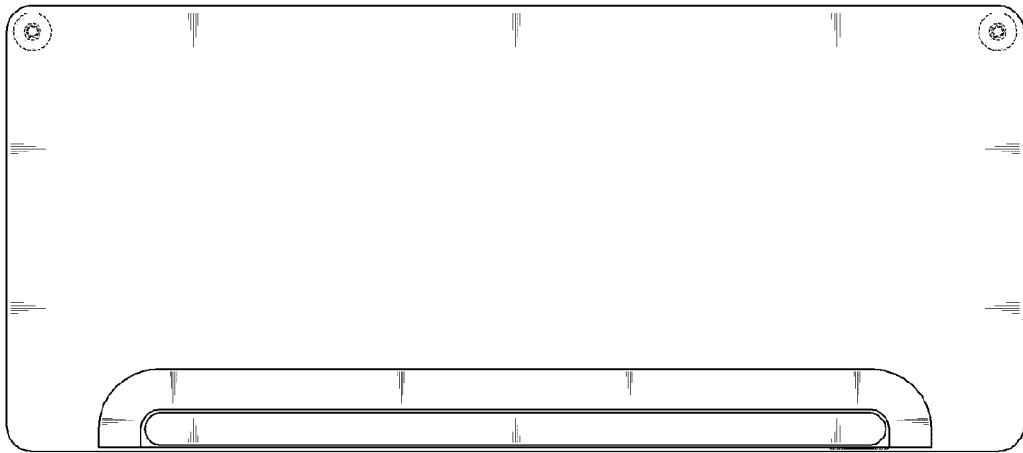

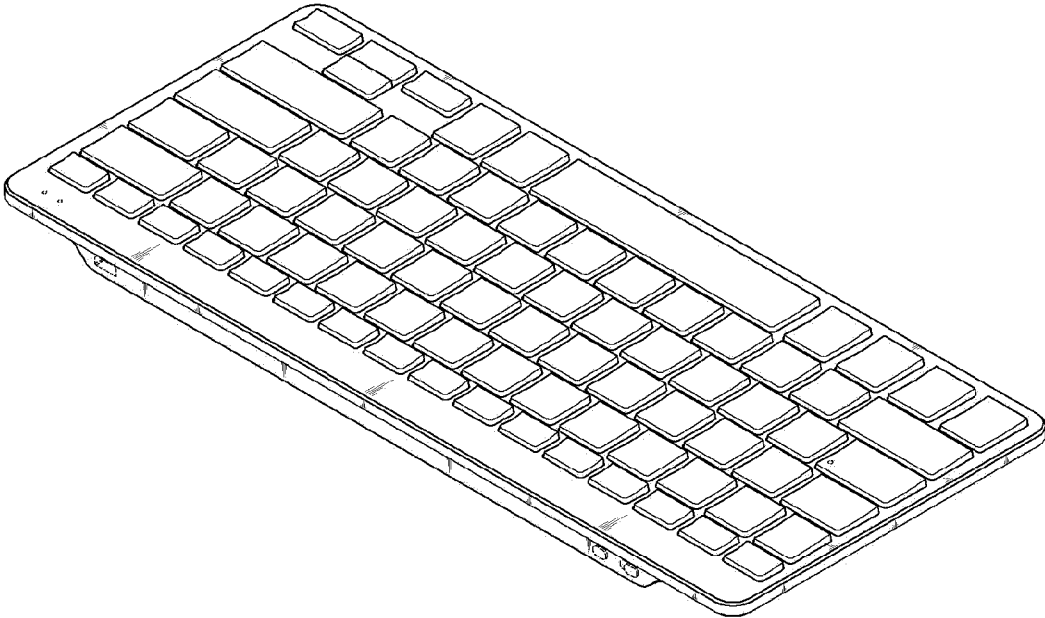

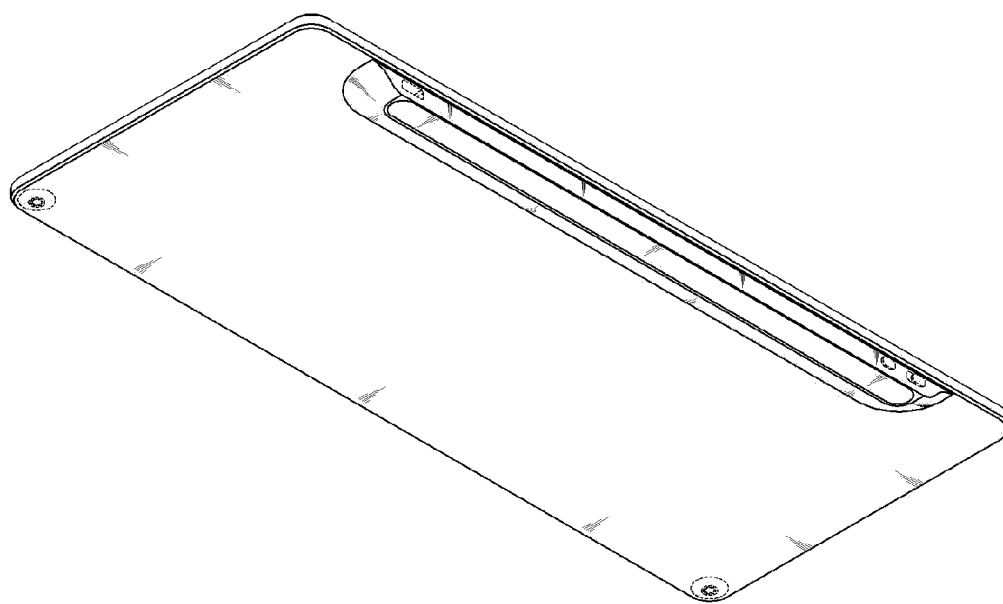
