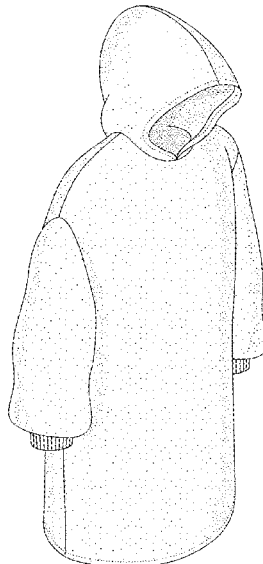

DESCRIPTION

FIG. 1 is a perspective view of a hoodie, showing my design; FIG. 2 is a left side view of the hoodie of FIG. 1; FIG. 3 is a right side view of the hoodie of FIG. 1; FIG. 4 is a front view of the hoodie of FIG. 1; FIG. 5 is a rear view of the hoodie of FIG. 1; FIG. 6 is a top view of the hoodie of FIG. 1; and FIG. 7 is a bottom view of the hoodie of FIG. 1. Dashed lines represent stitching. Any broken lines are for the purpose of illustrating portions of the hoodie that form no part of the claimed design.

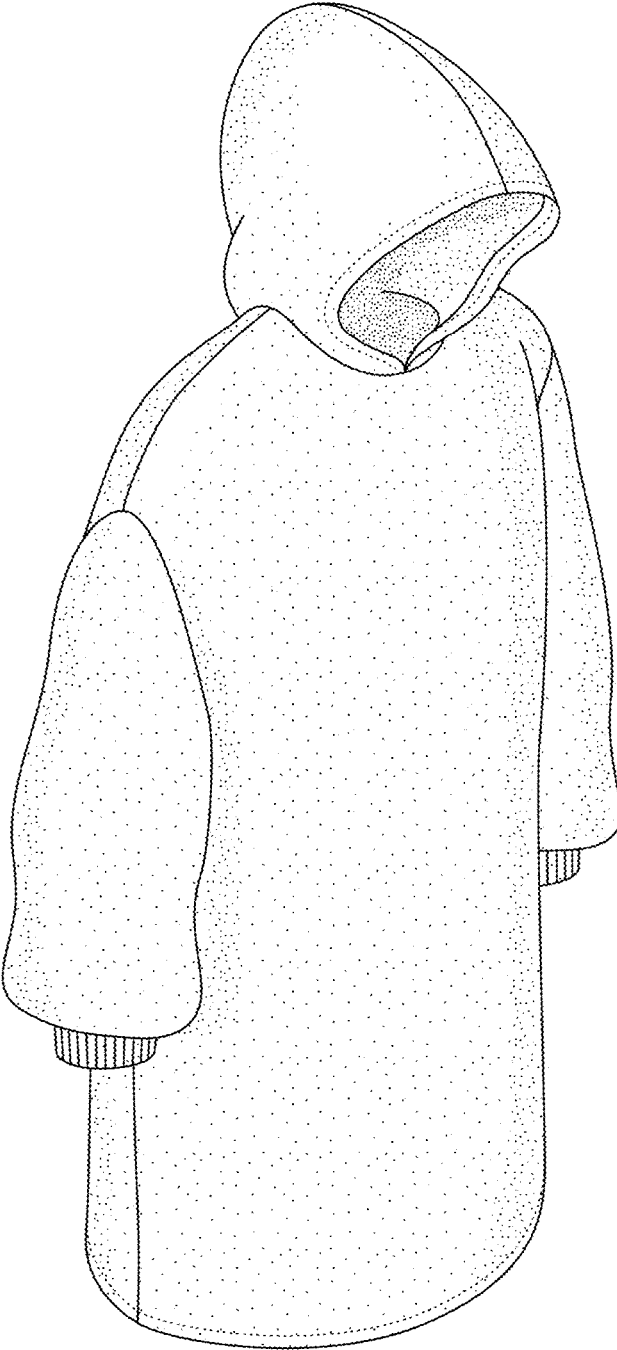

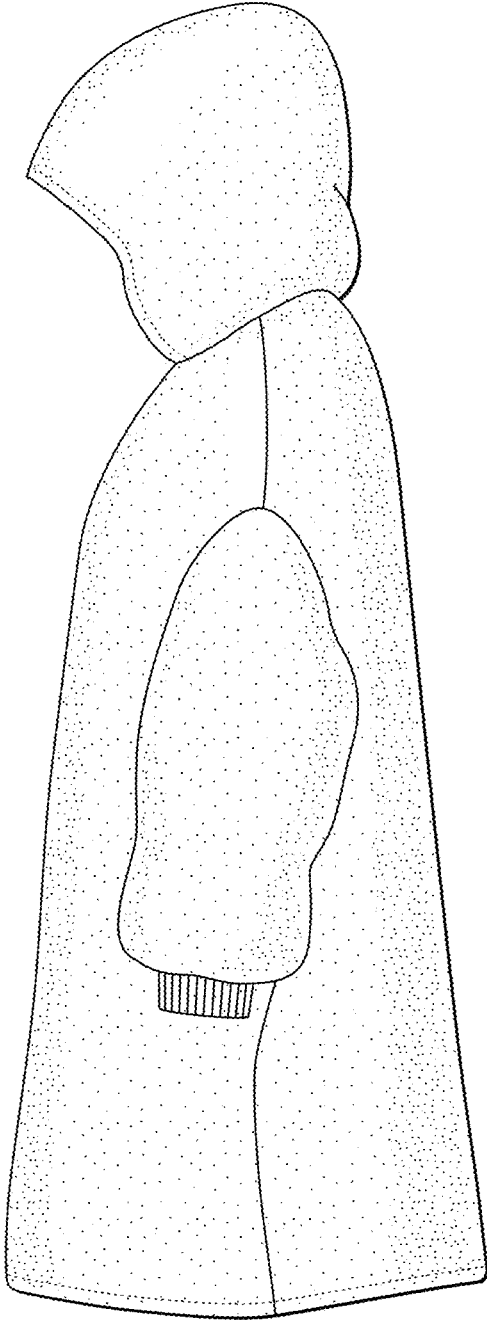

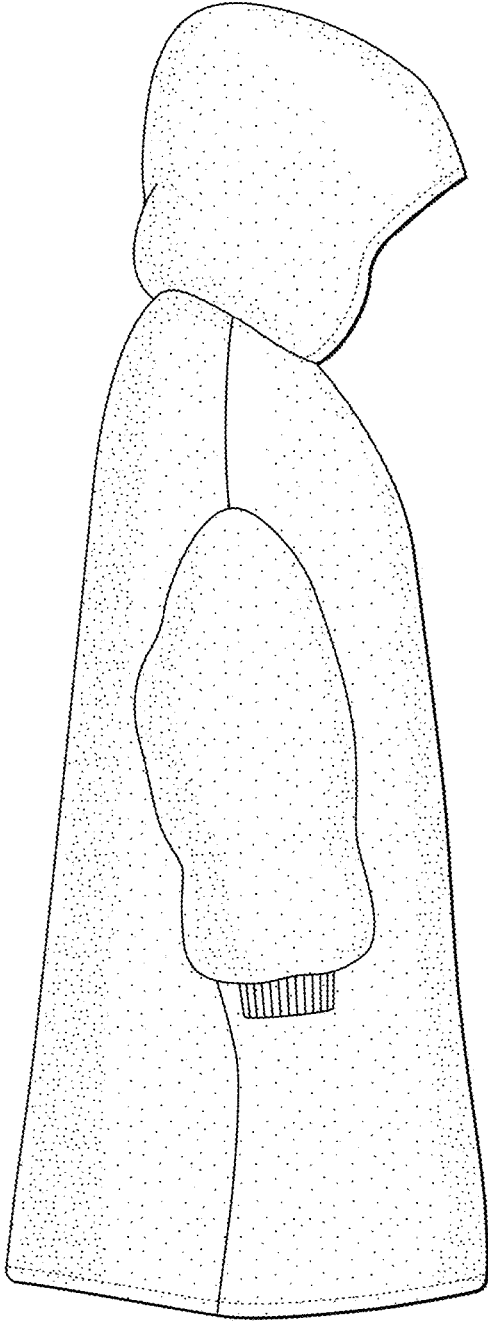

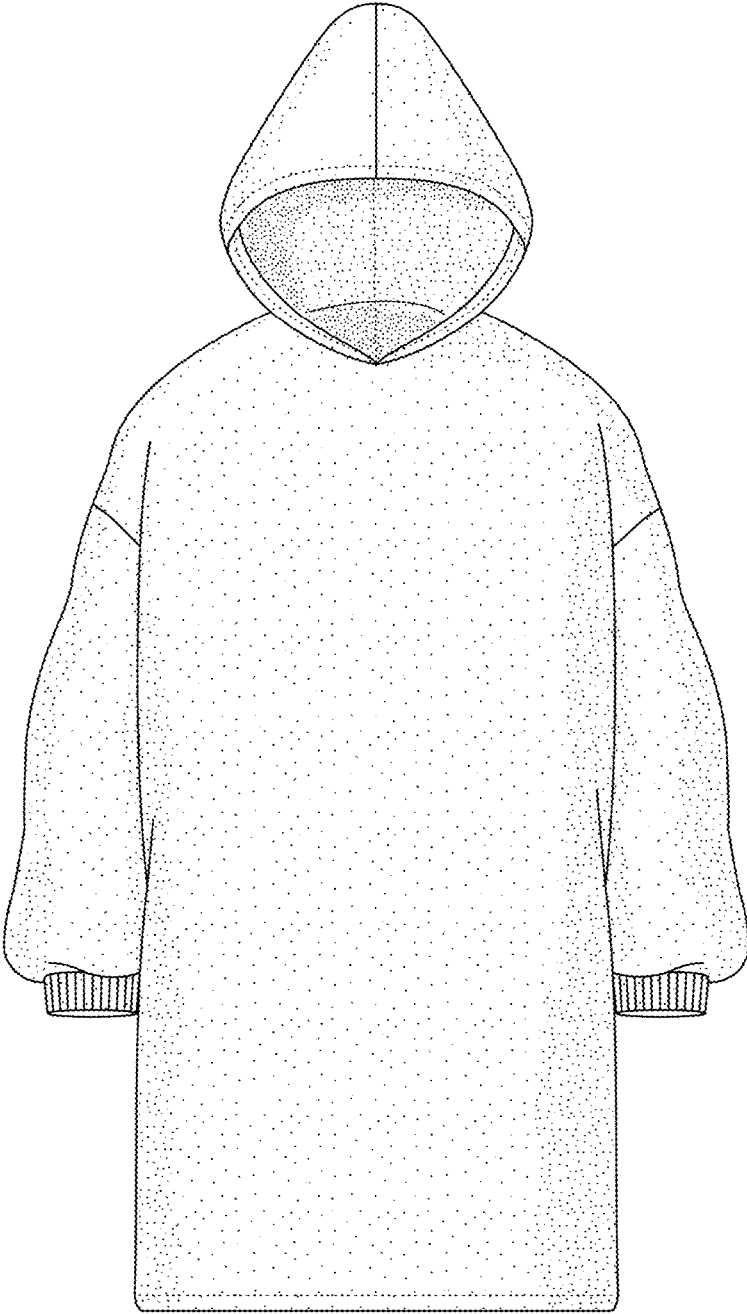

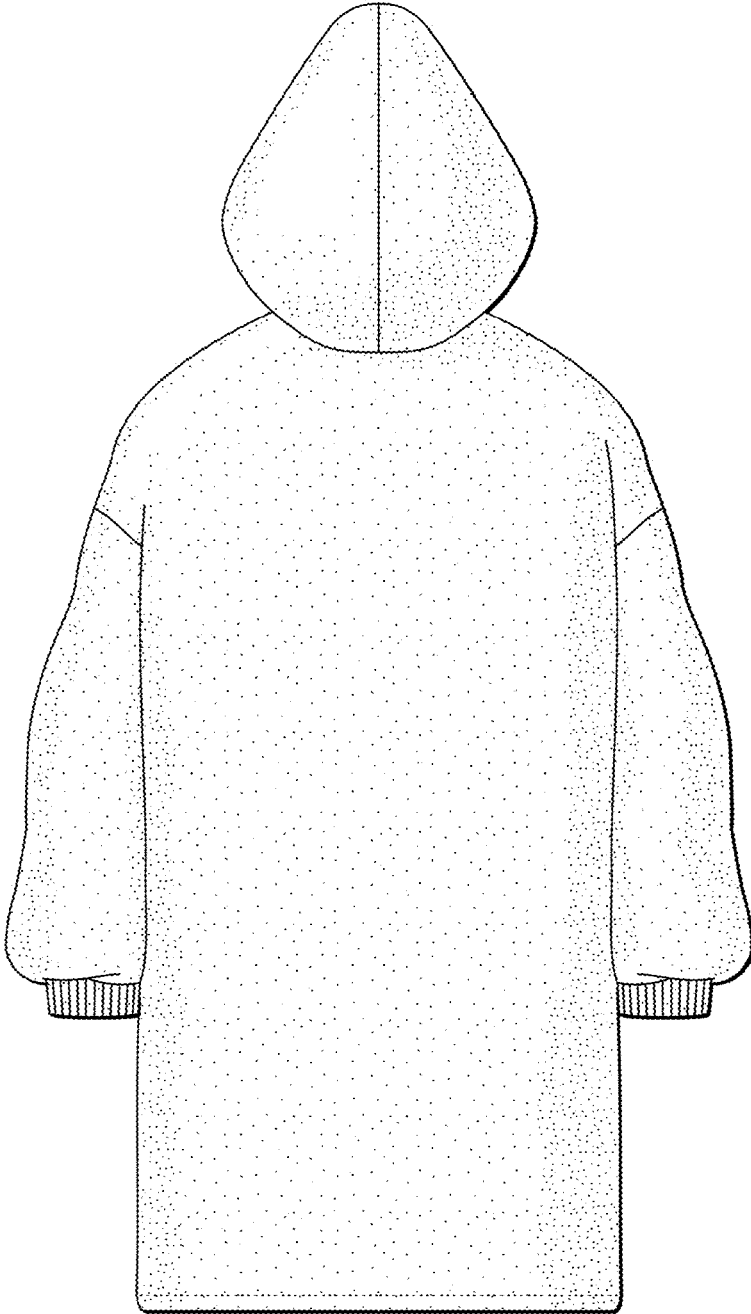

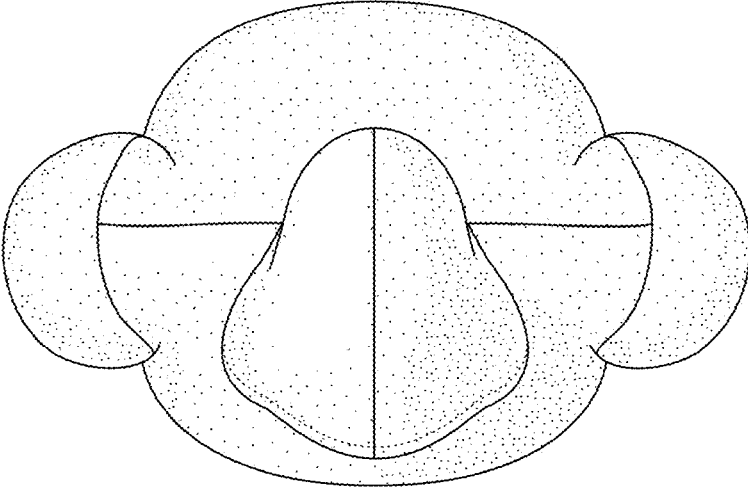

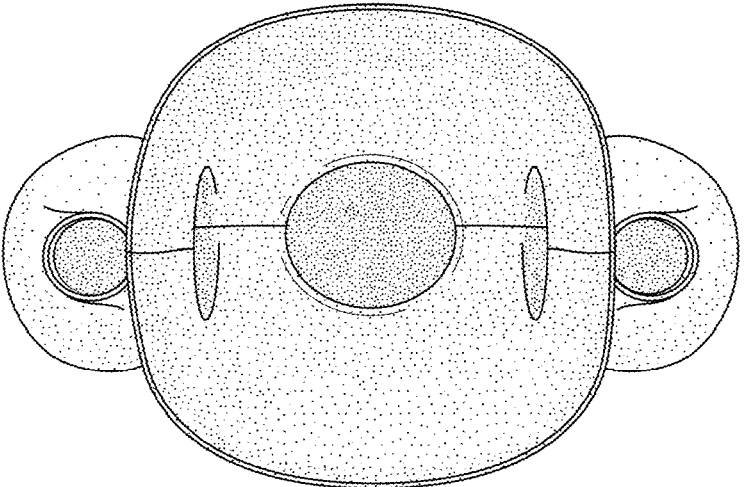
