The ornamental design for a handle, as shown and described.

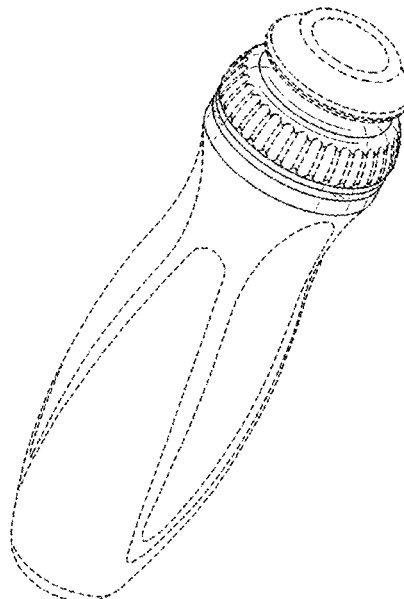
DESCRIPTION

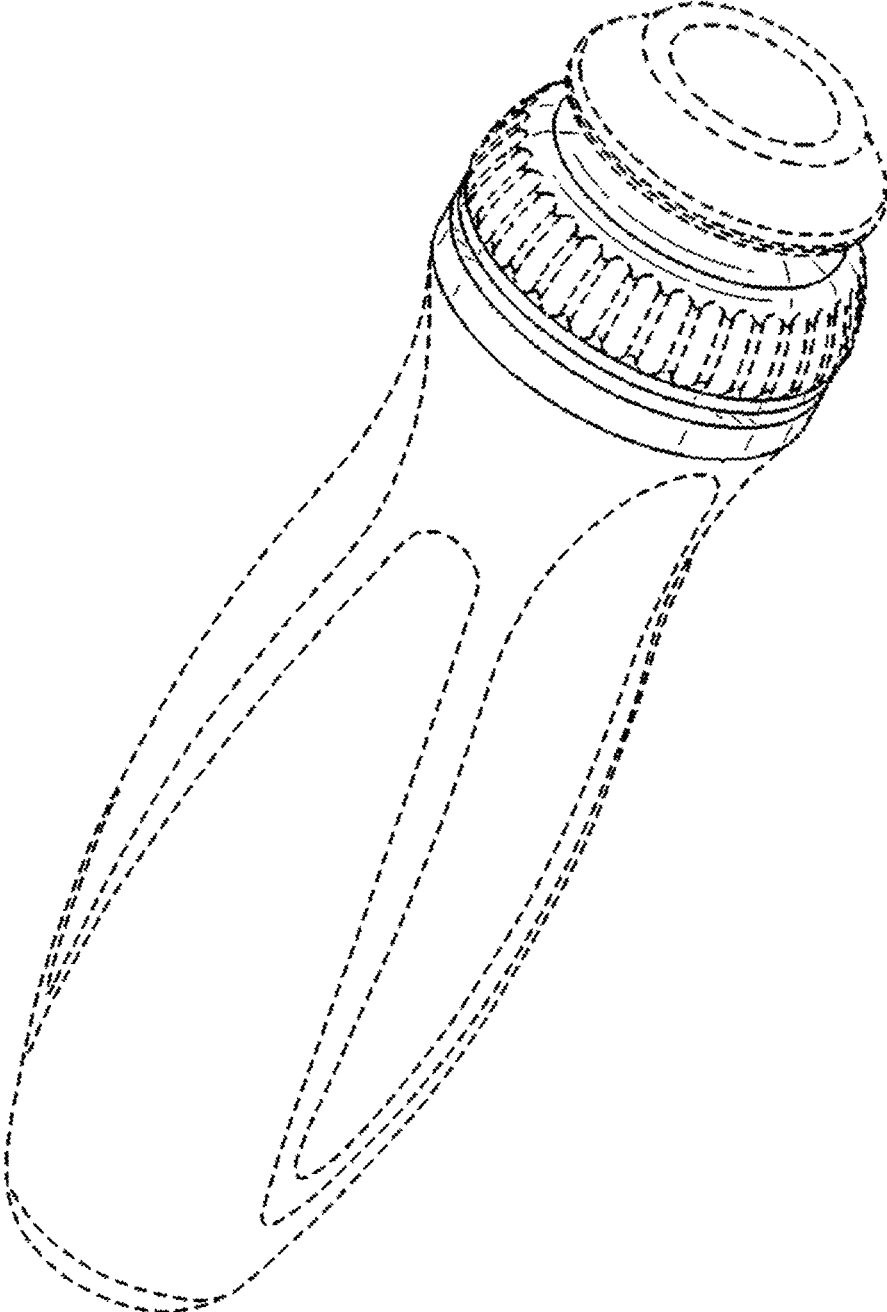

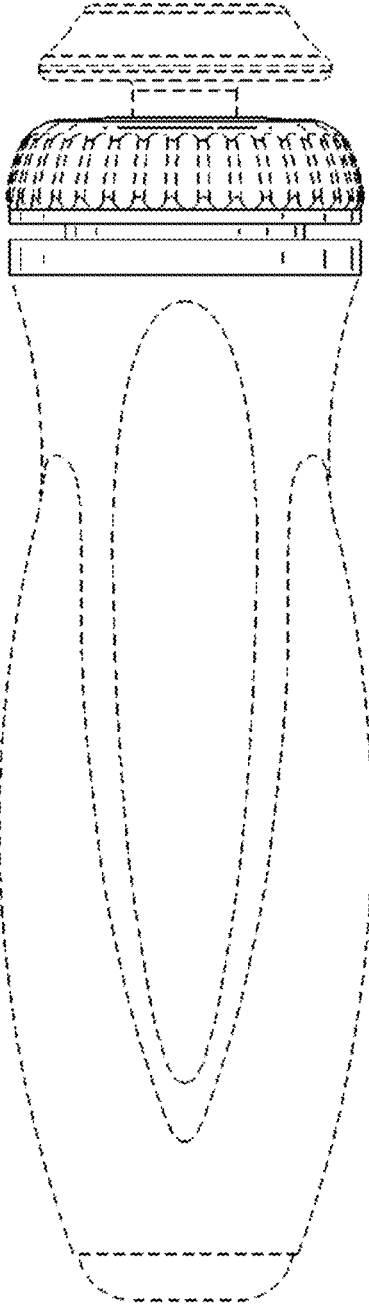

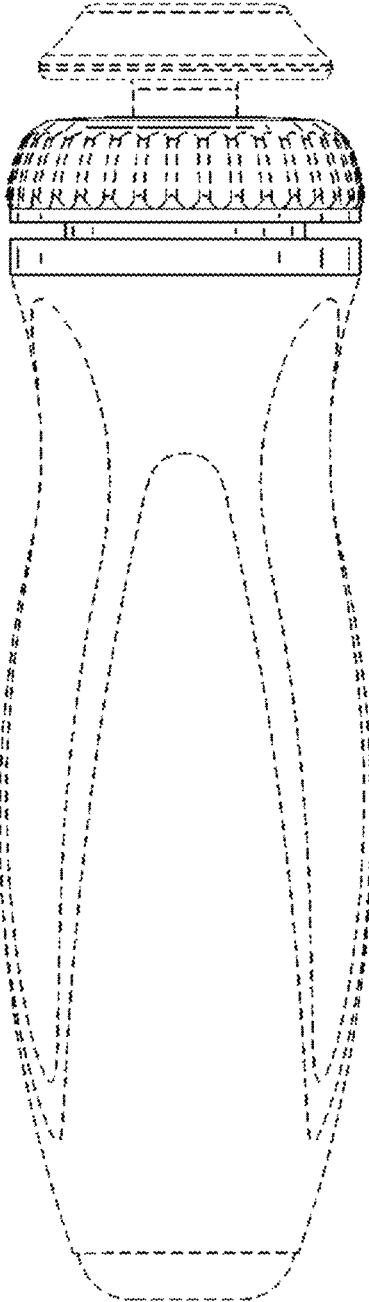

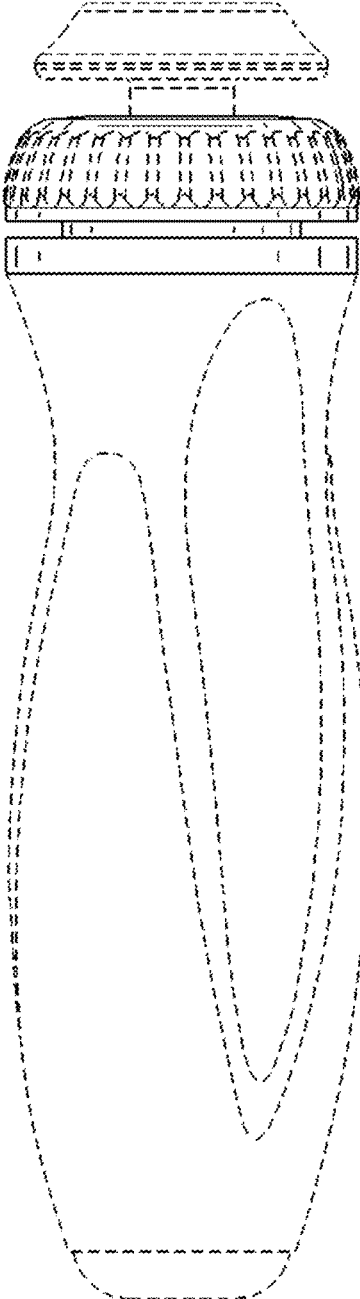

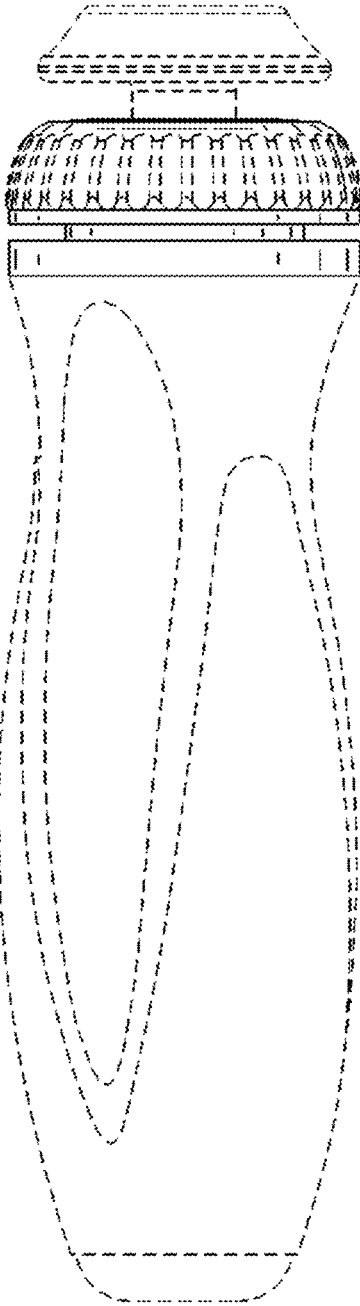

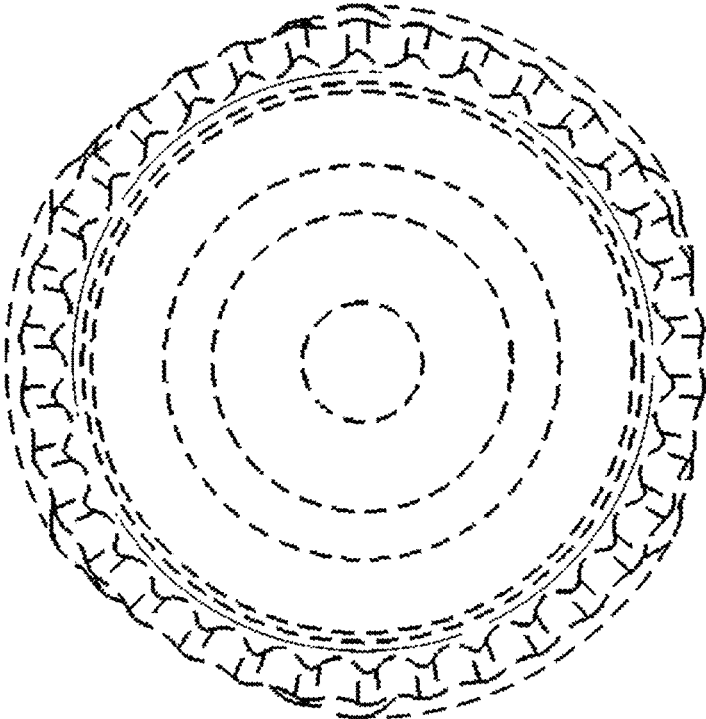

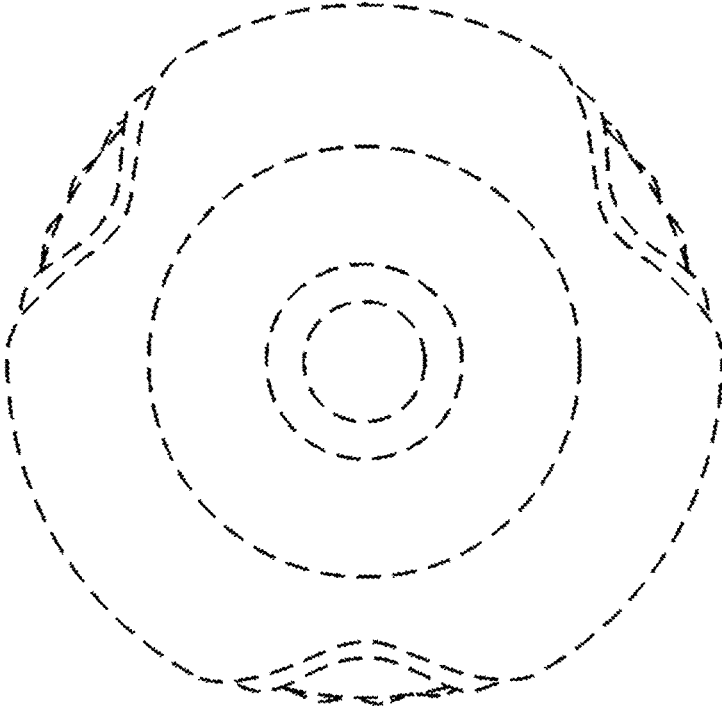
