

(57) Abstract: A method and apparatus for requesting selected interlace mode with a particular sector is provided, comprising generating a SelectedInterlaceRequest message comprising an 8 bit MessageID field, a 12 bit PilotPN field wherein the PilotPN field indicates a value of PilotPN of the sector to which the message is directed and a 4 bit InterlacesRequested field wherein the InterlacesRequested field indicates a value of requested number of interlaces and transmitting the SelectedInterlaceRequest message over a communication link. A method and apparatus for receiving and processing the SelectedInterlaceRequest message is further provided.
