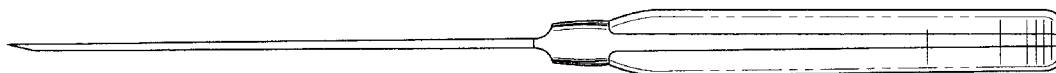
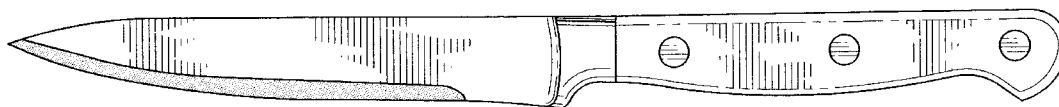
(57) **CLAIM**

The ornamental design for a knife with a colored beveled edge, as shown.

**DESCRIPTION**

FIG. 1 is a side elevation view of a knife with a colored beveled edge showing our new design;  
FIG. 2 is a top view of the knife illustrated in FIG. 1;  
FIG. 3 is an opposite side view of the knife illustrated in FIG. 1;  
FIG. 4 is a bottom view of the knife illustrated in FIG. 1;  
FIG. 5 is a blade end view of the knife illustrated in FIG. 1; and,  
FIG. 6 is a handle end view of the knife illustrated in FIG. 1.

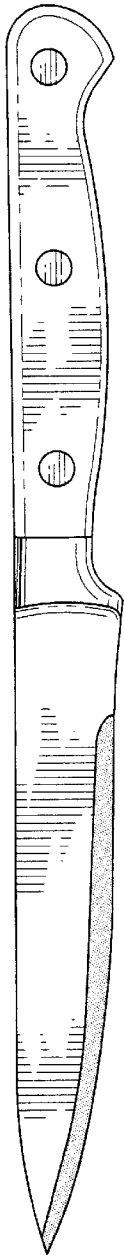

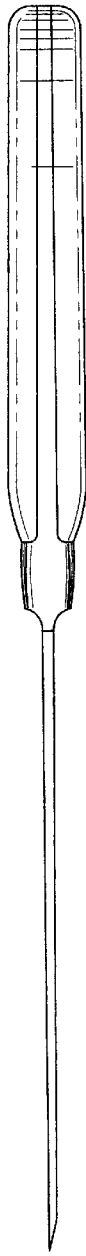

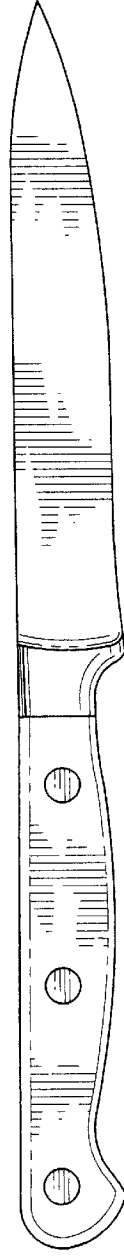

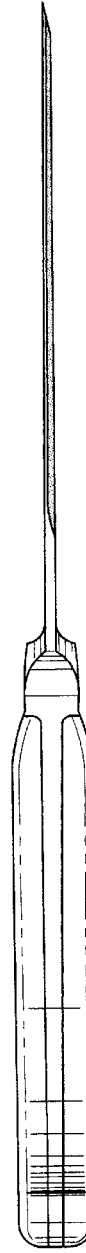

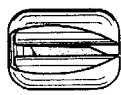

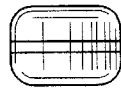
