(57) **CLAIM**

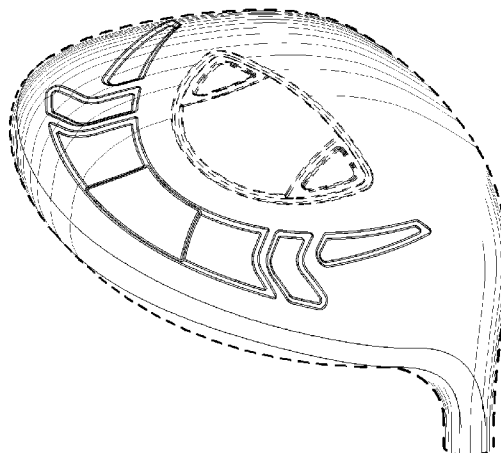
The ornamental design for a sole for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sole for a golf club head; FIG. 2 is a plan view of FIG. 1; FIG. 3 is a perspective view of a second embodiment of a sole for a golf club head; FIG. 4 is a plan view of FIG. 3; FIG. 5 is a perspective view of a third embodiment of a sole for a golf club head; and, FIG. 6 is a plan view of FIG. 5.

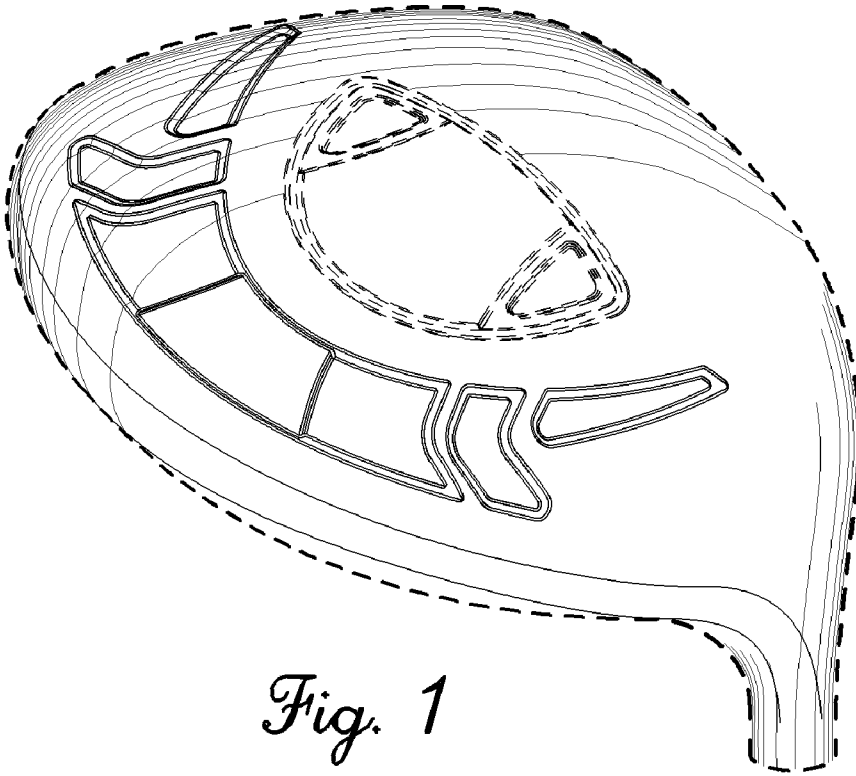

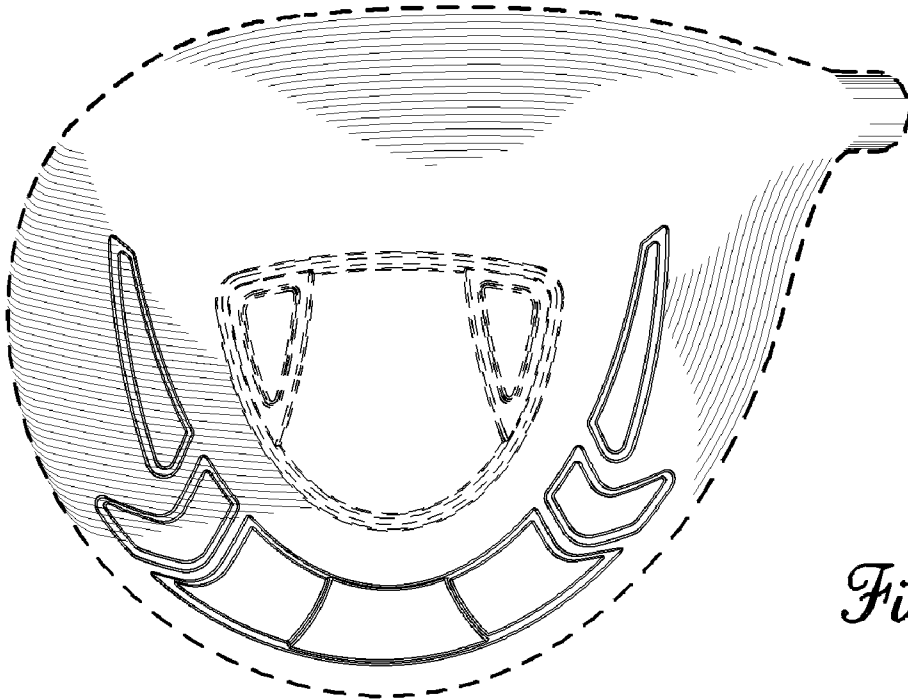

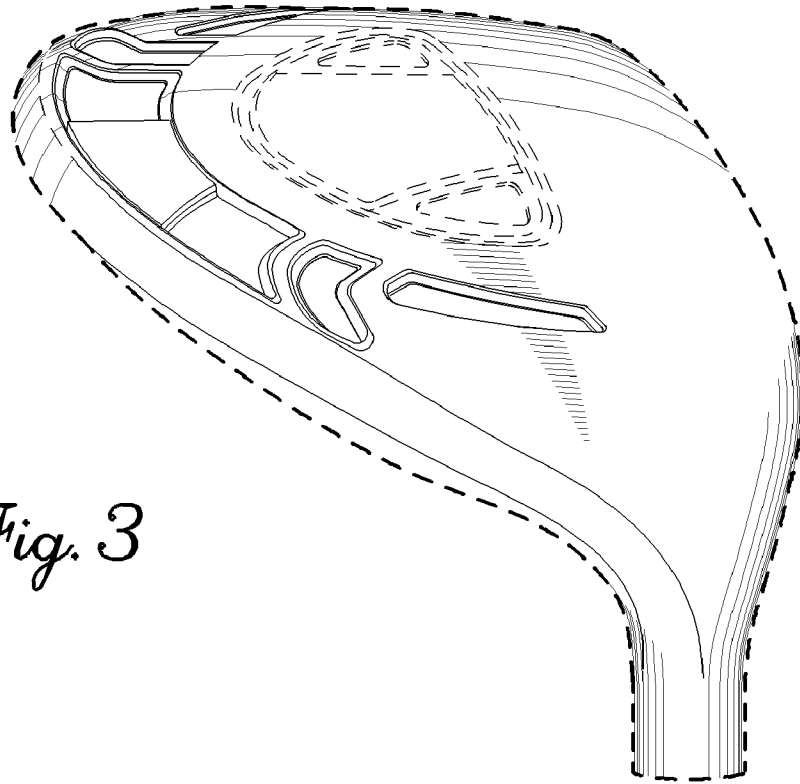

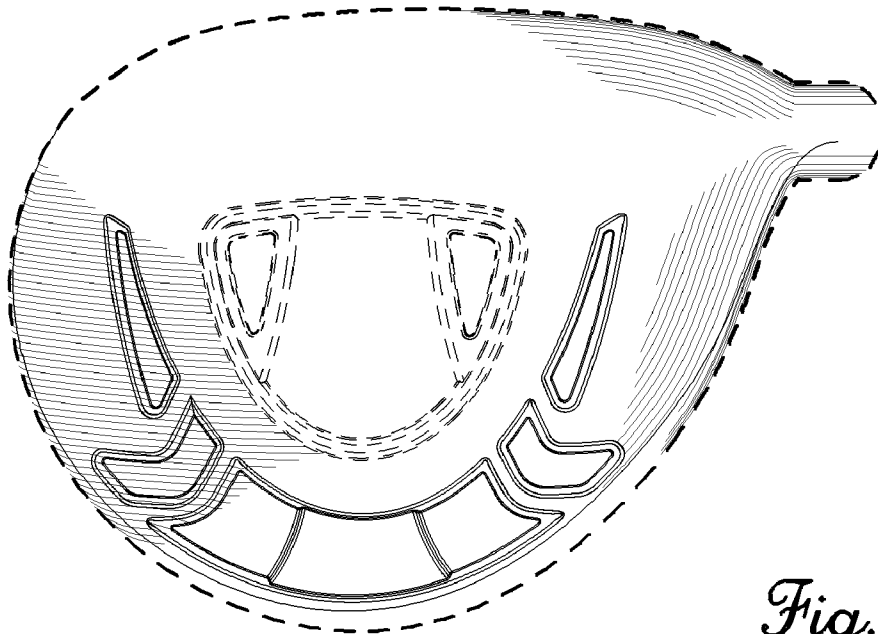

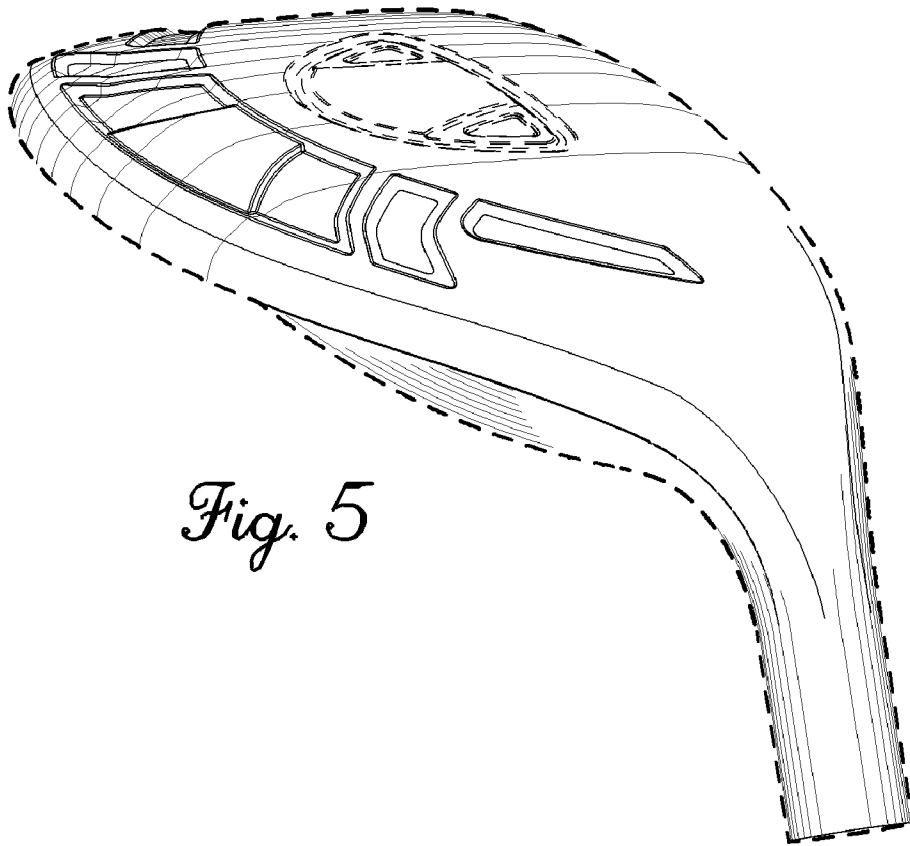

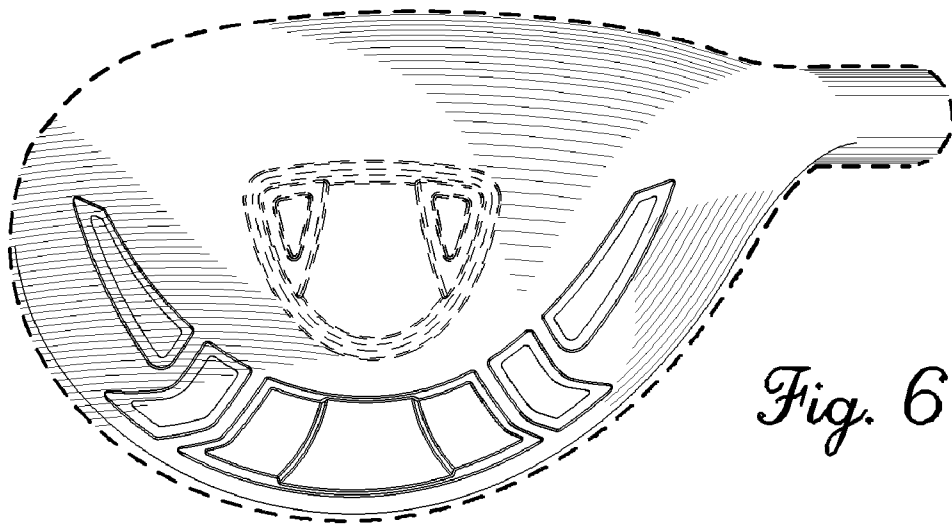
