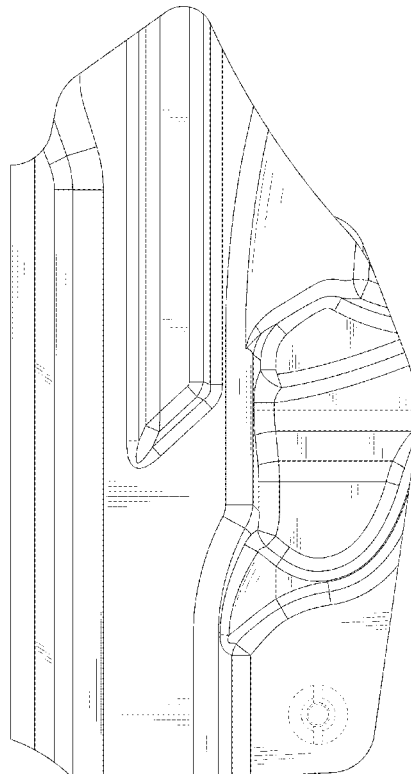
The ornamental design for a holster, as shown and described.

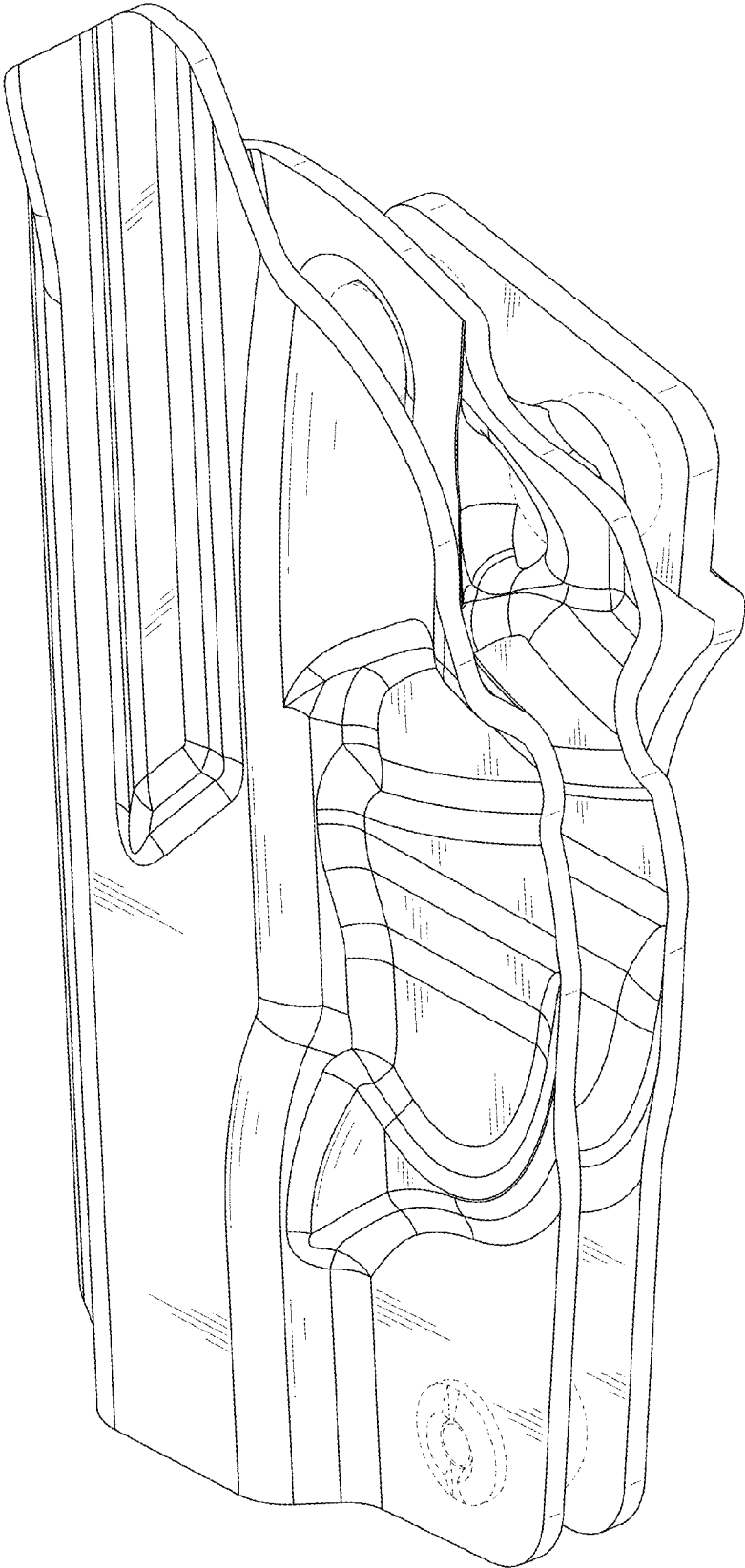

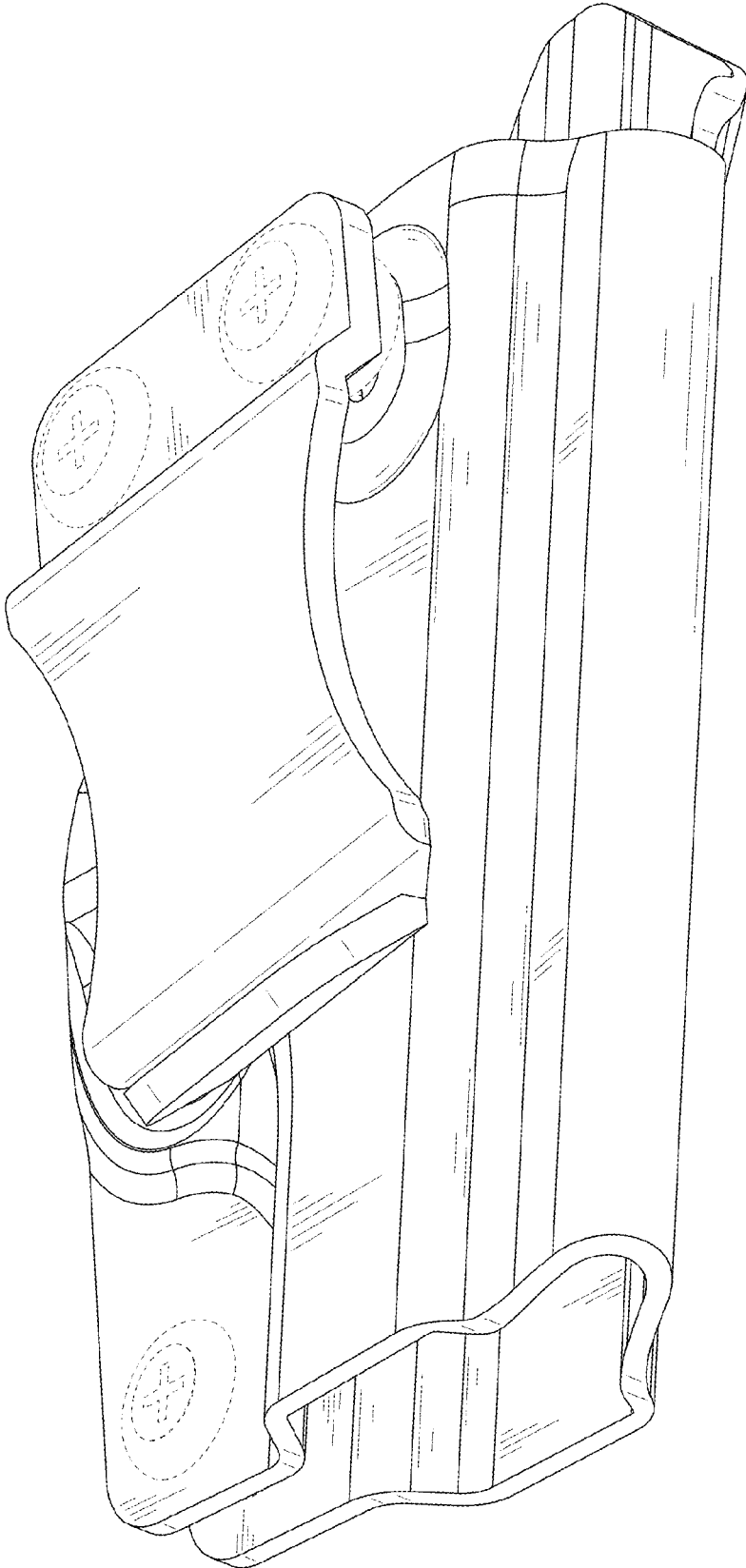

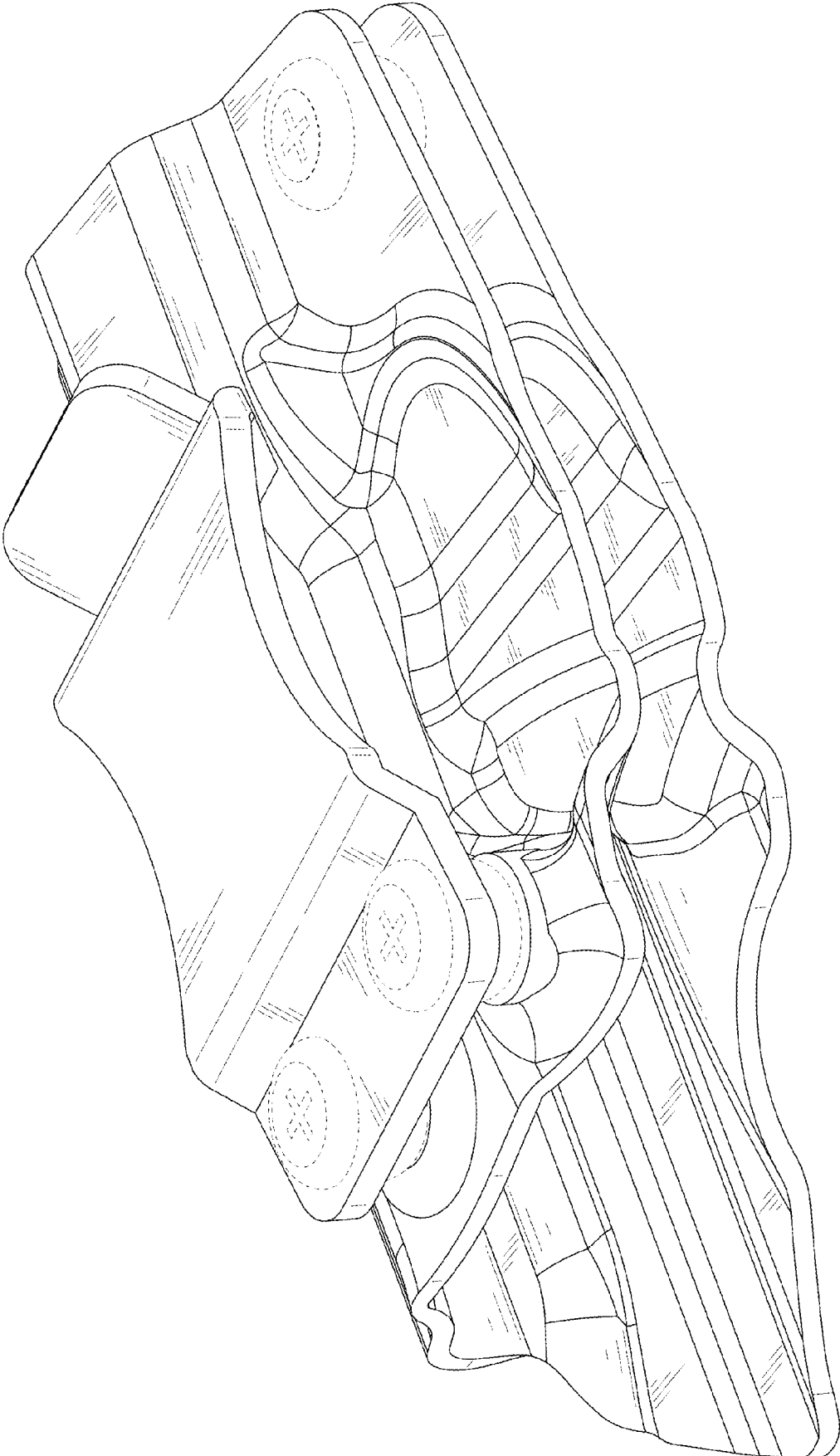

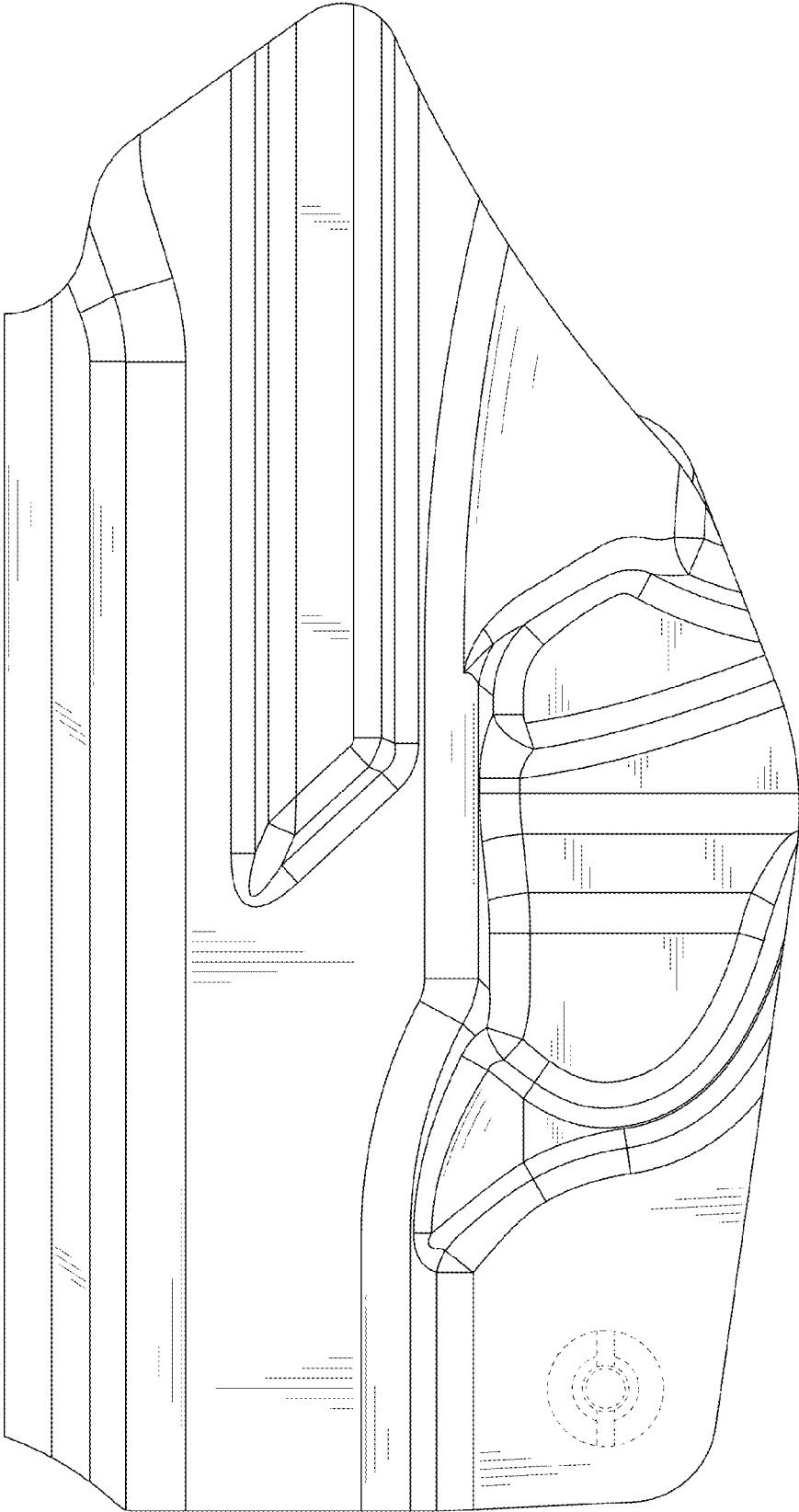

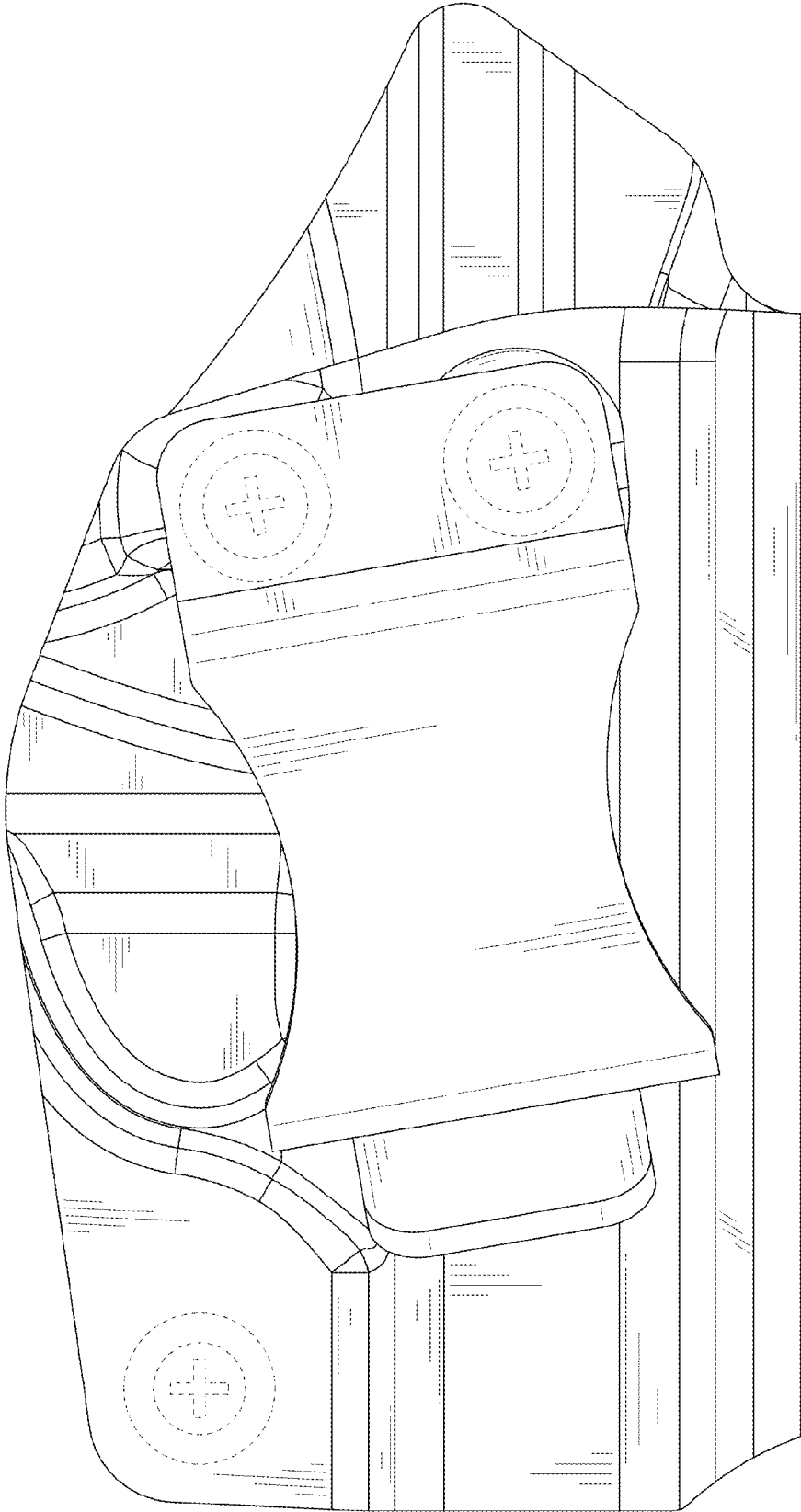

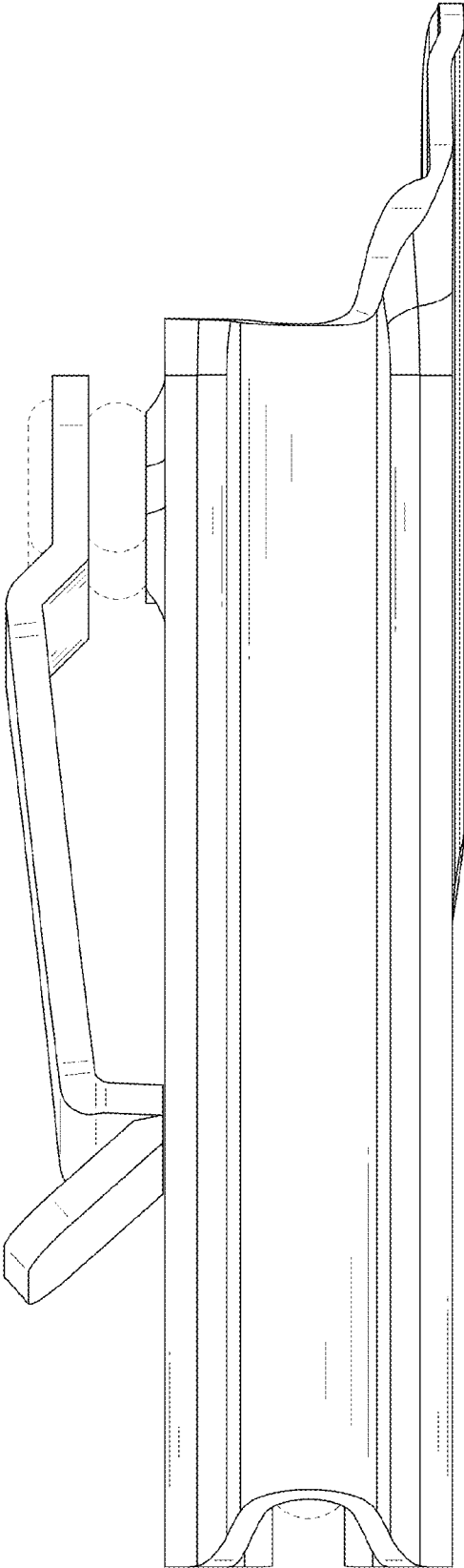

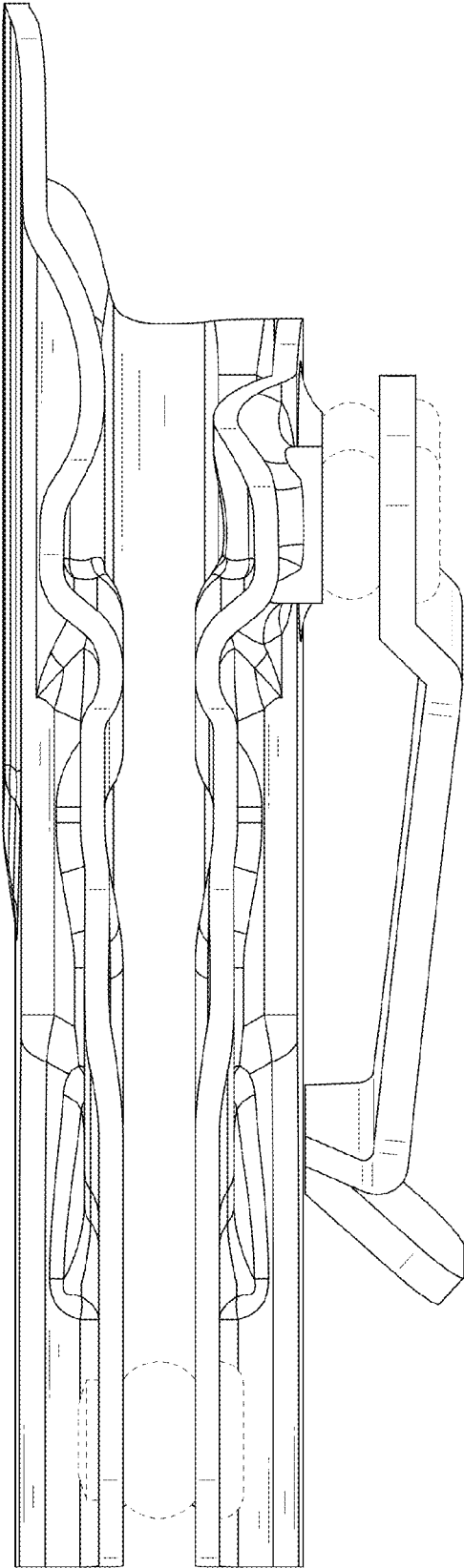

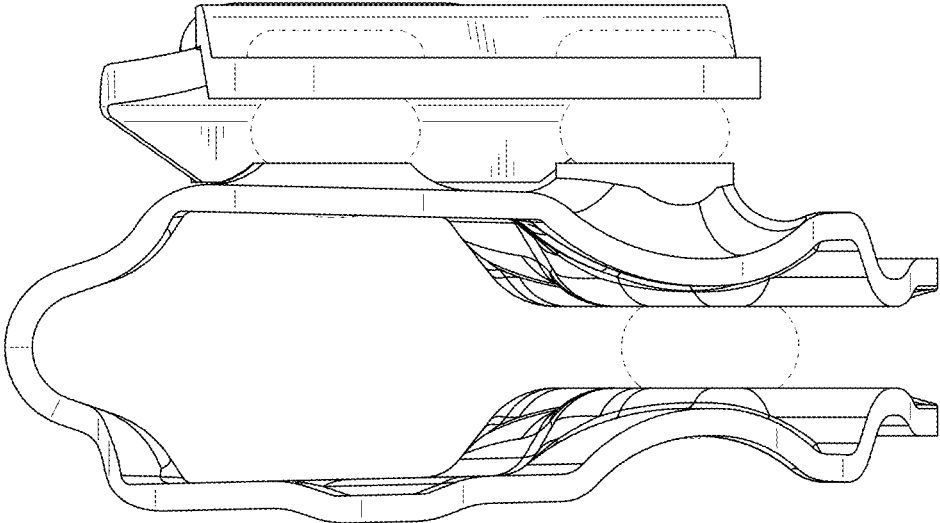

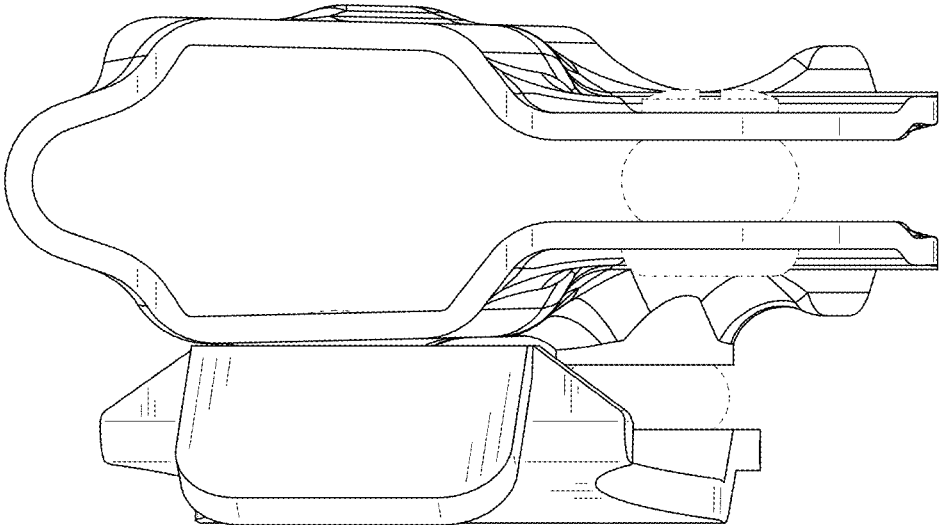
