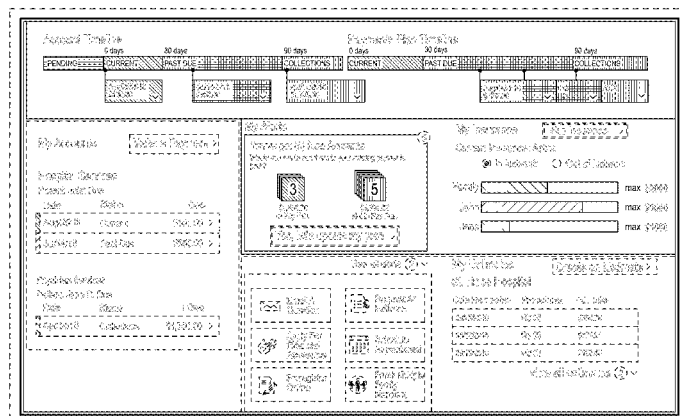


FIG. 10 is a front view of a display screen with a graphical user interface according to another embodiment, showing the new design;

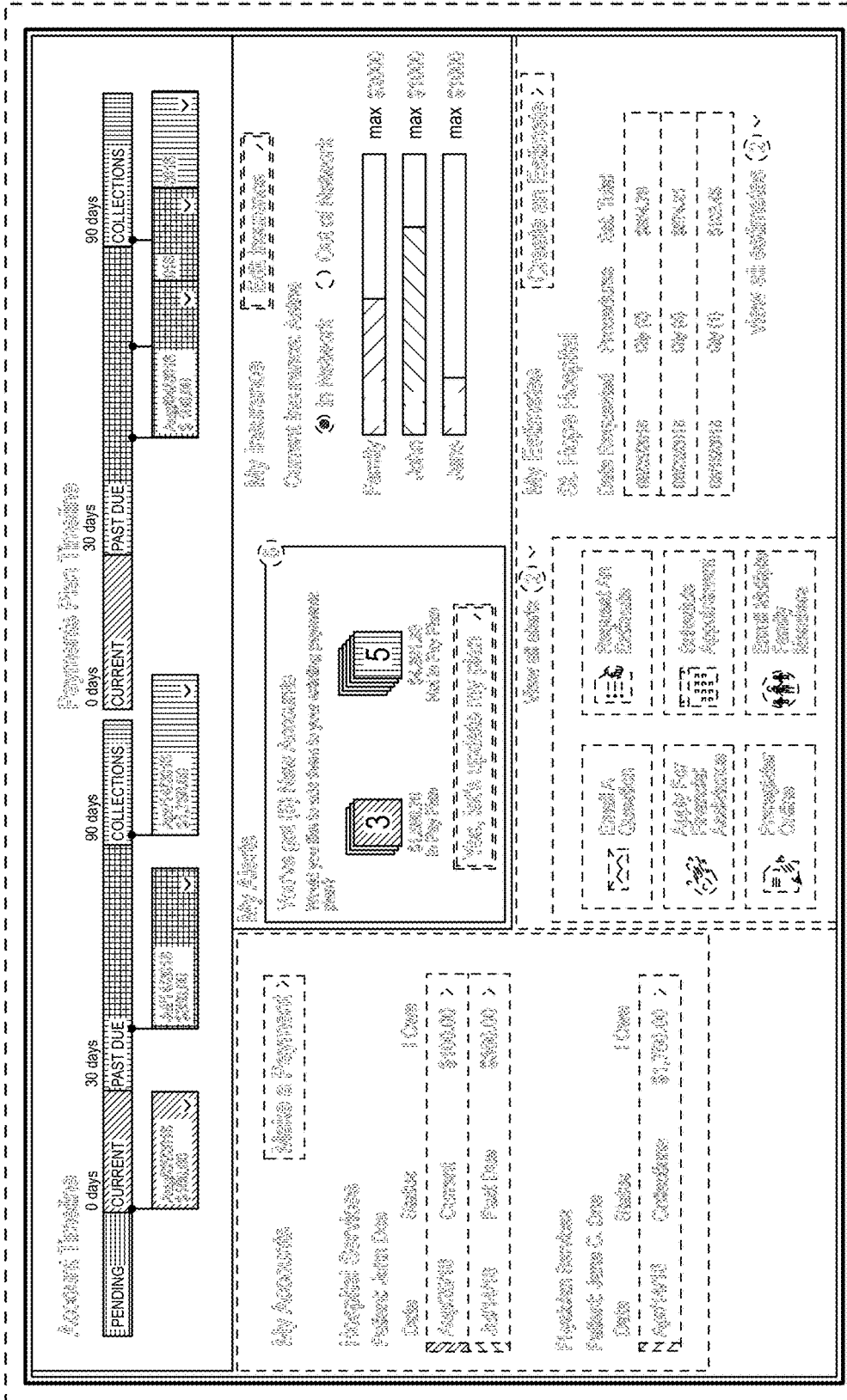

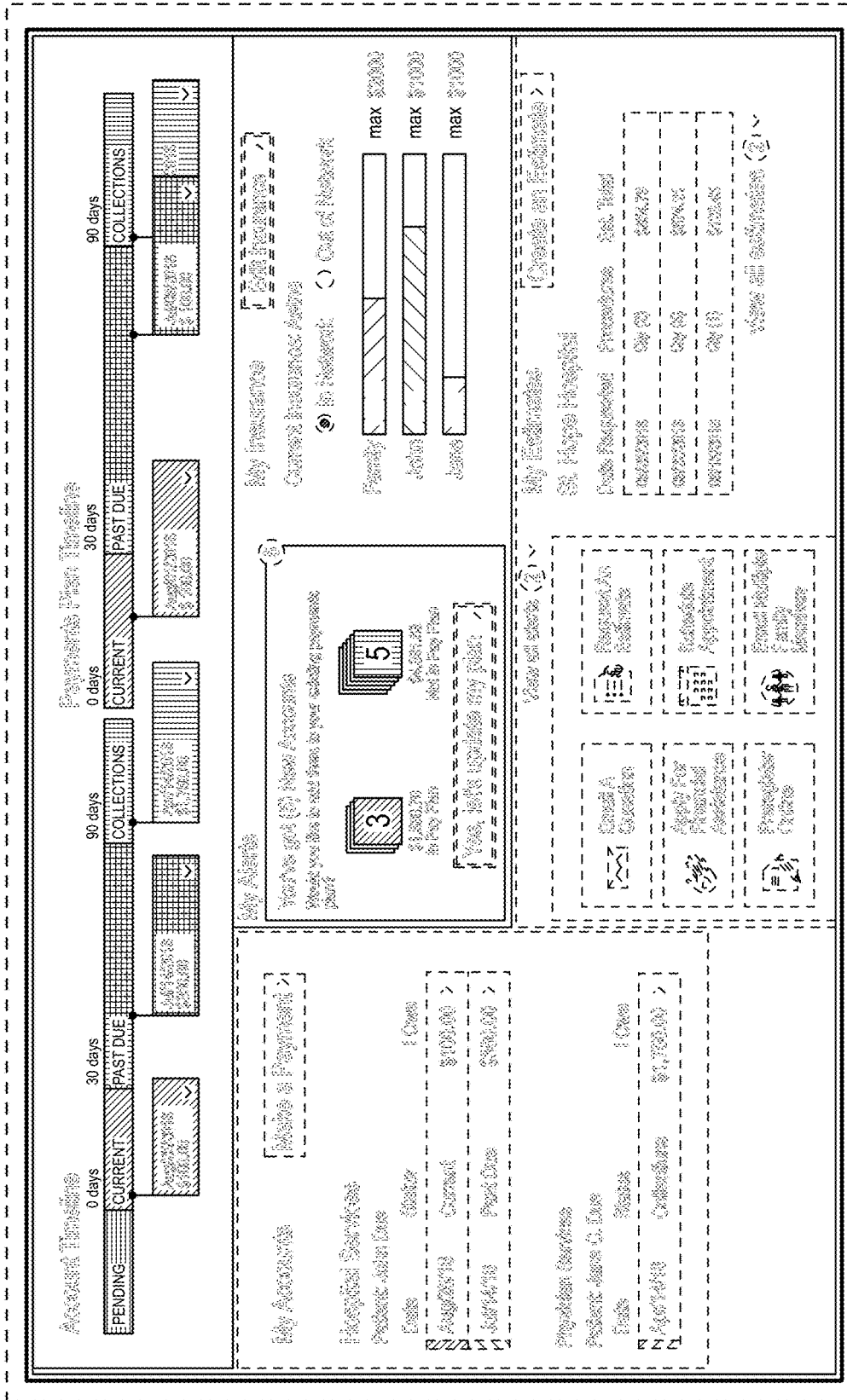

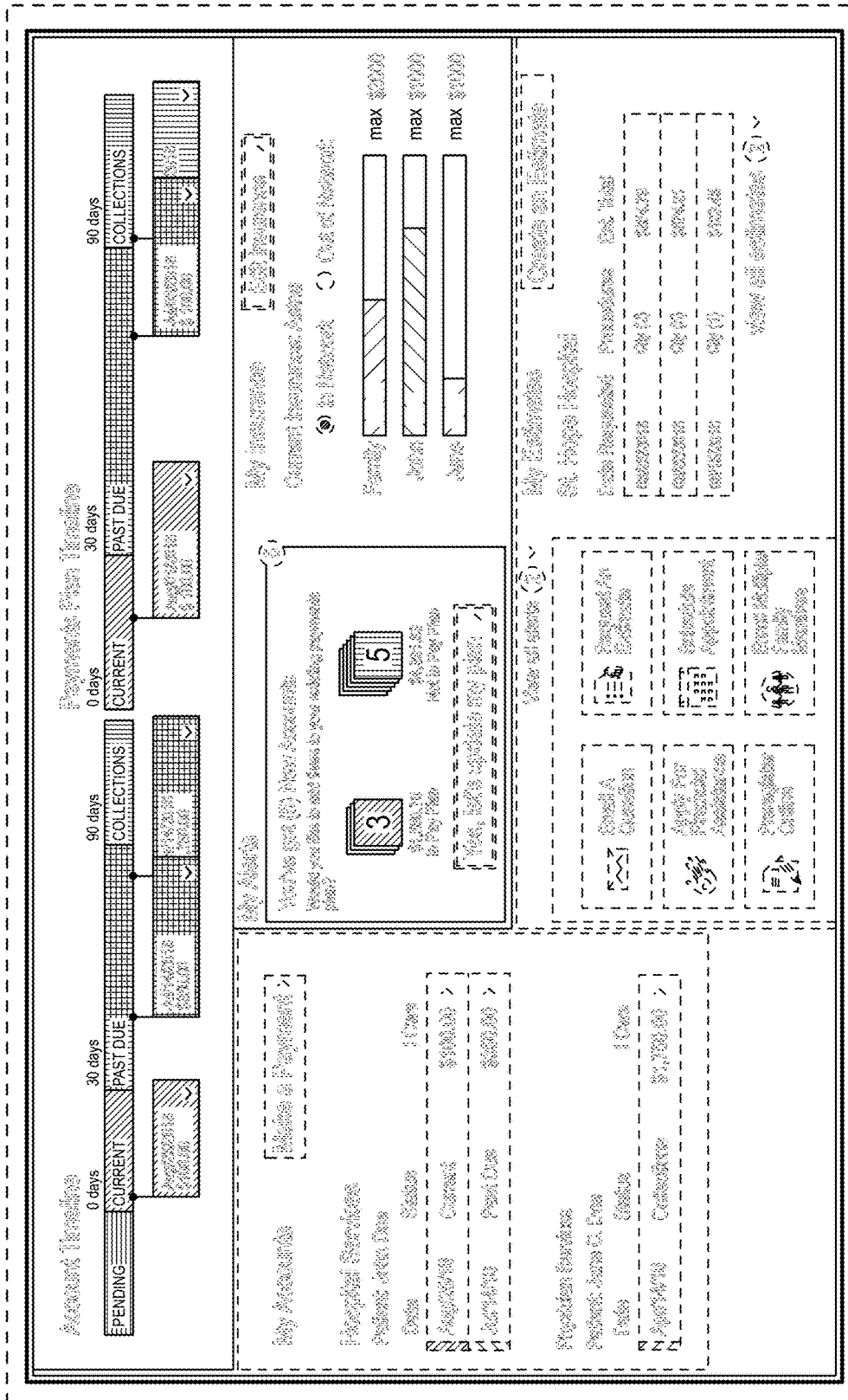

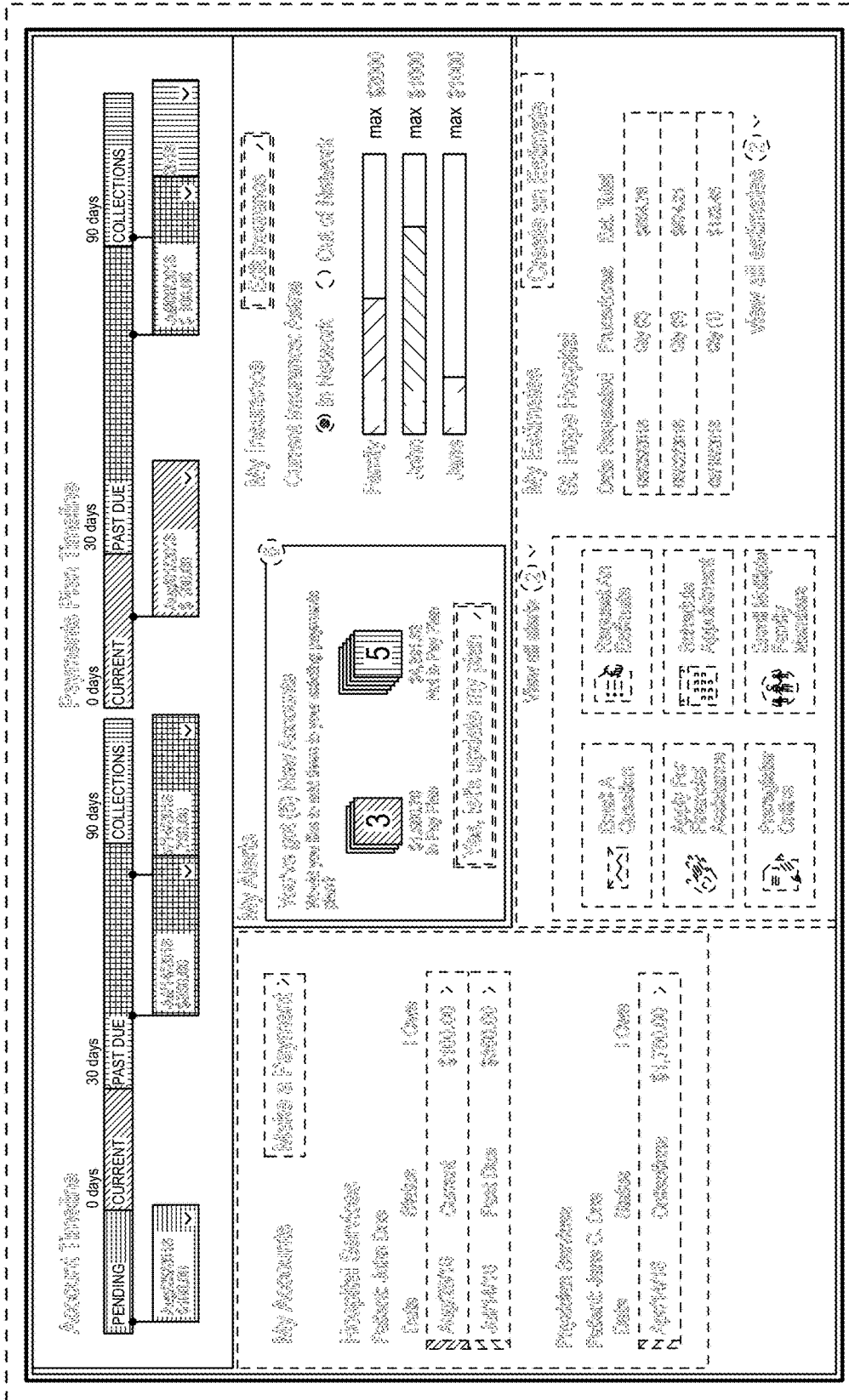

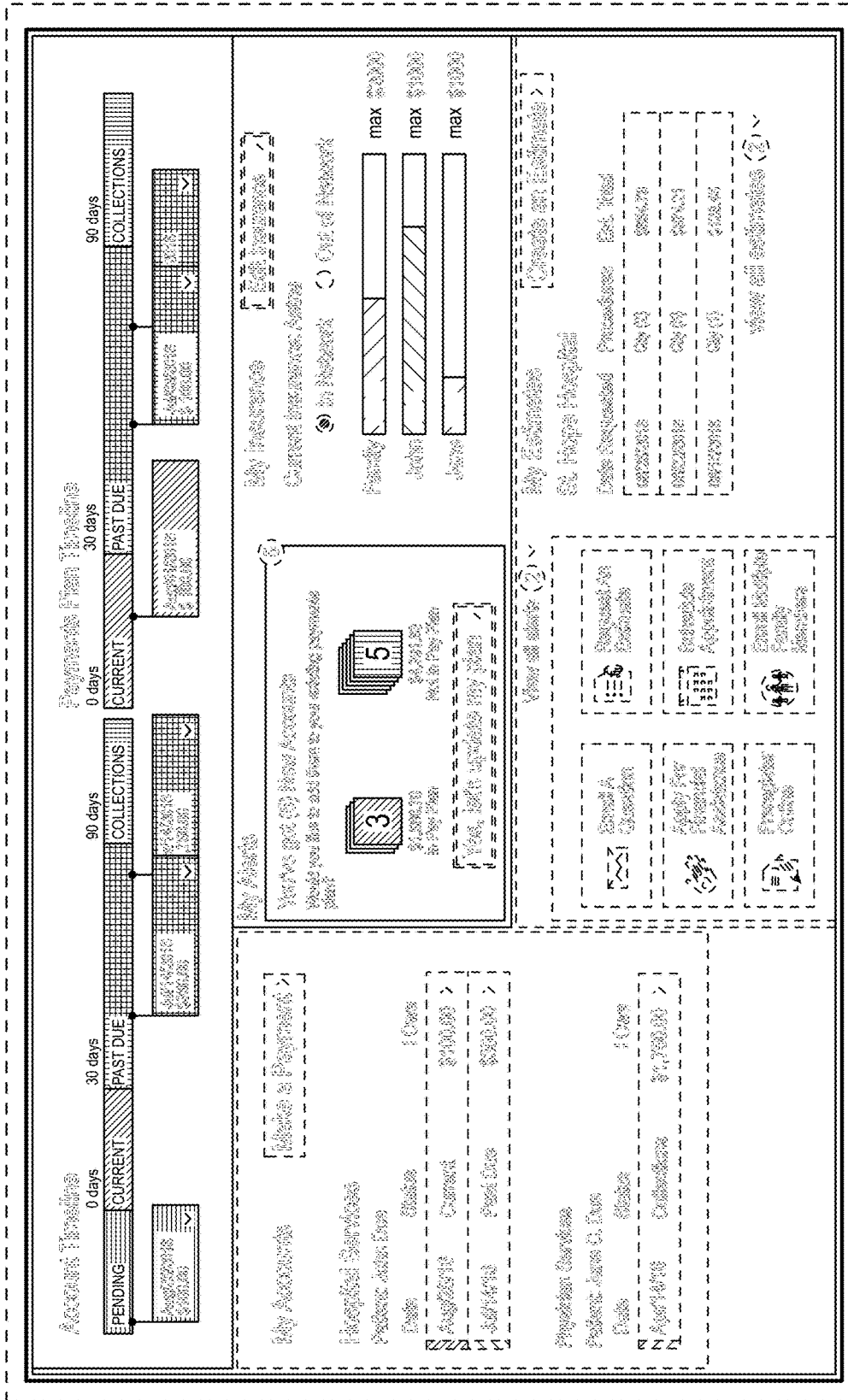

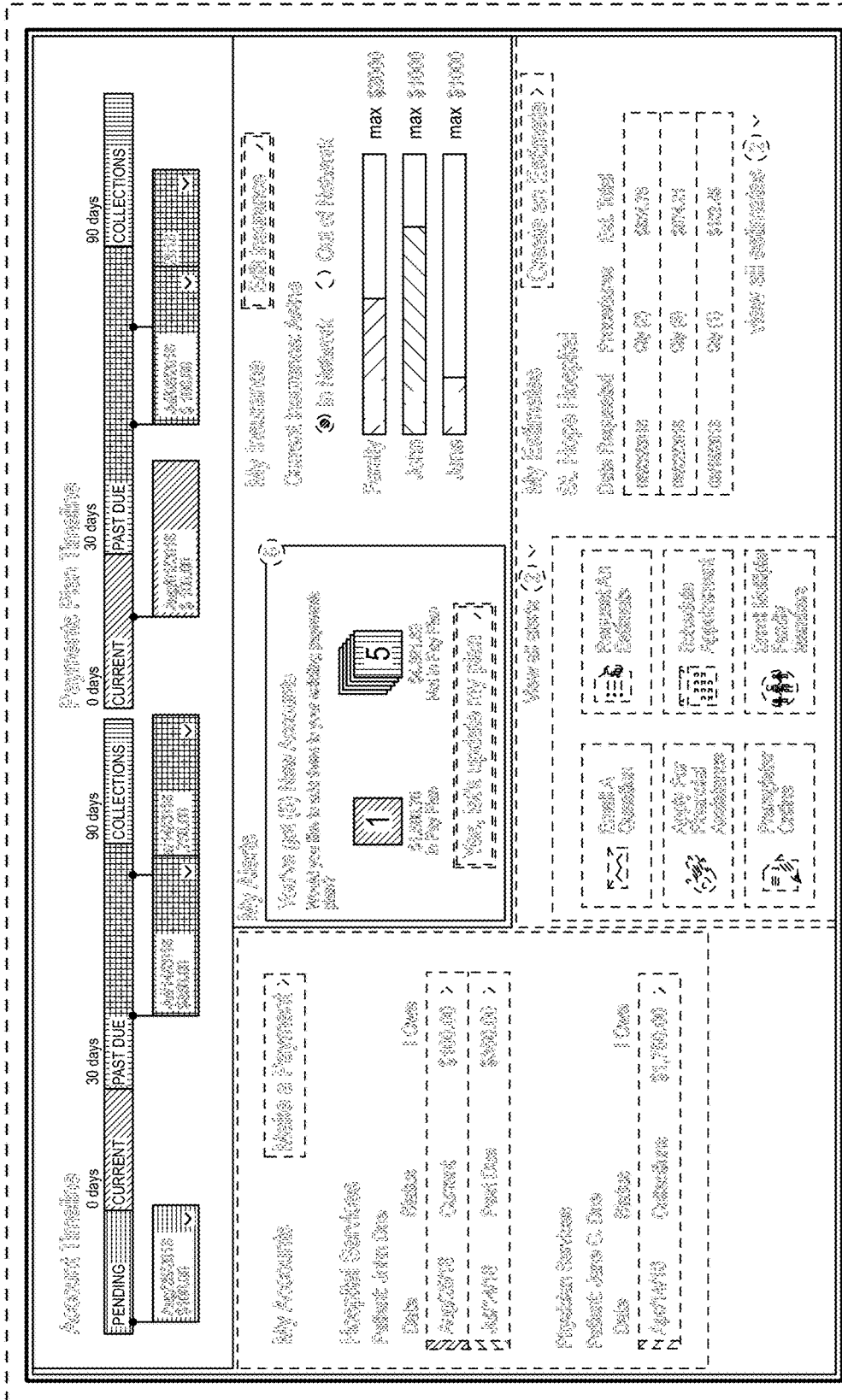

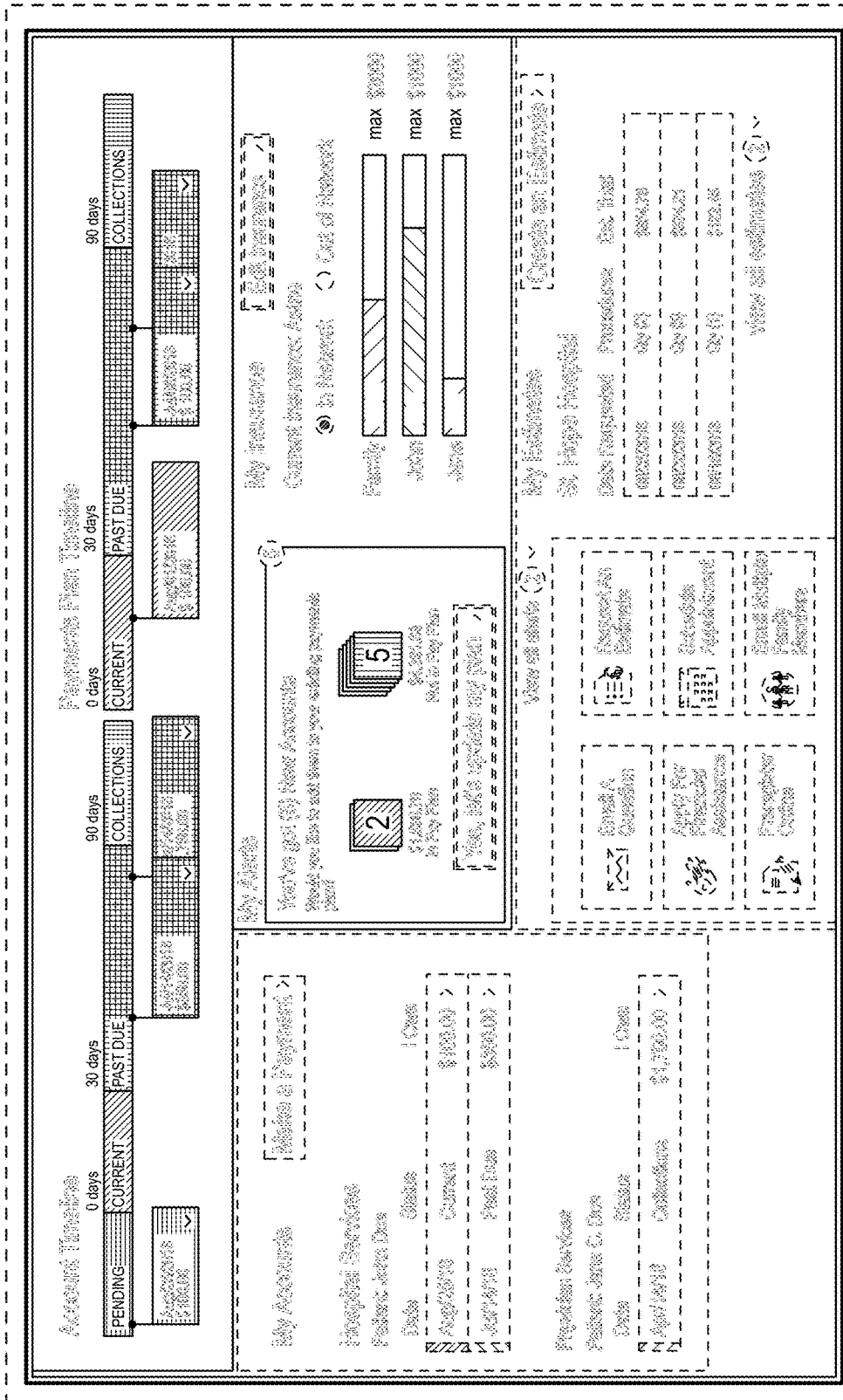

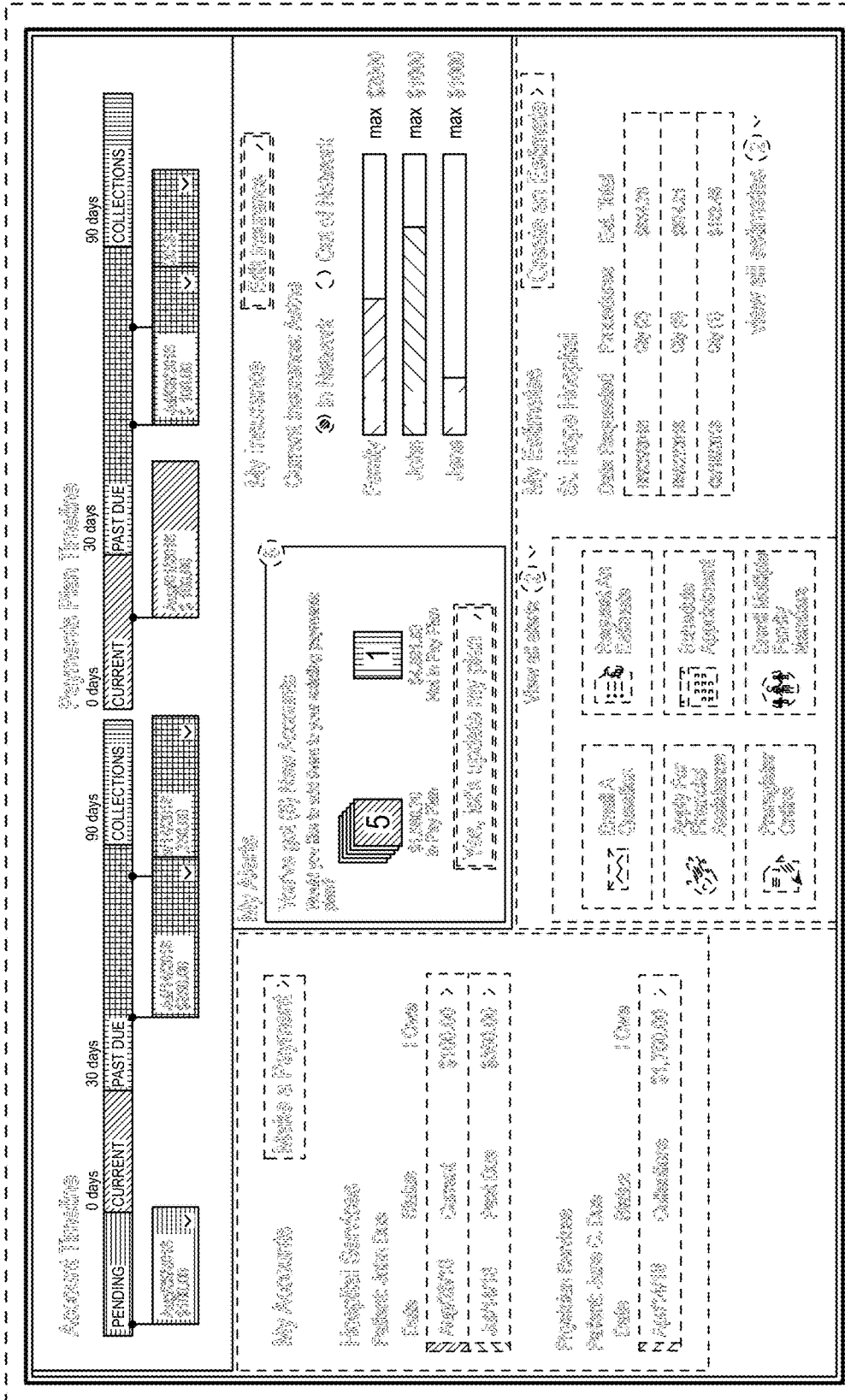

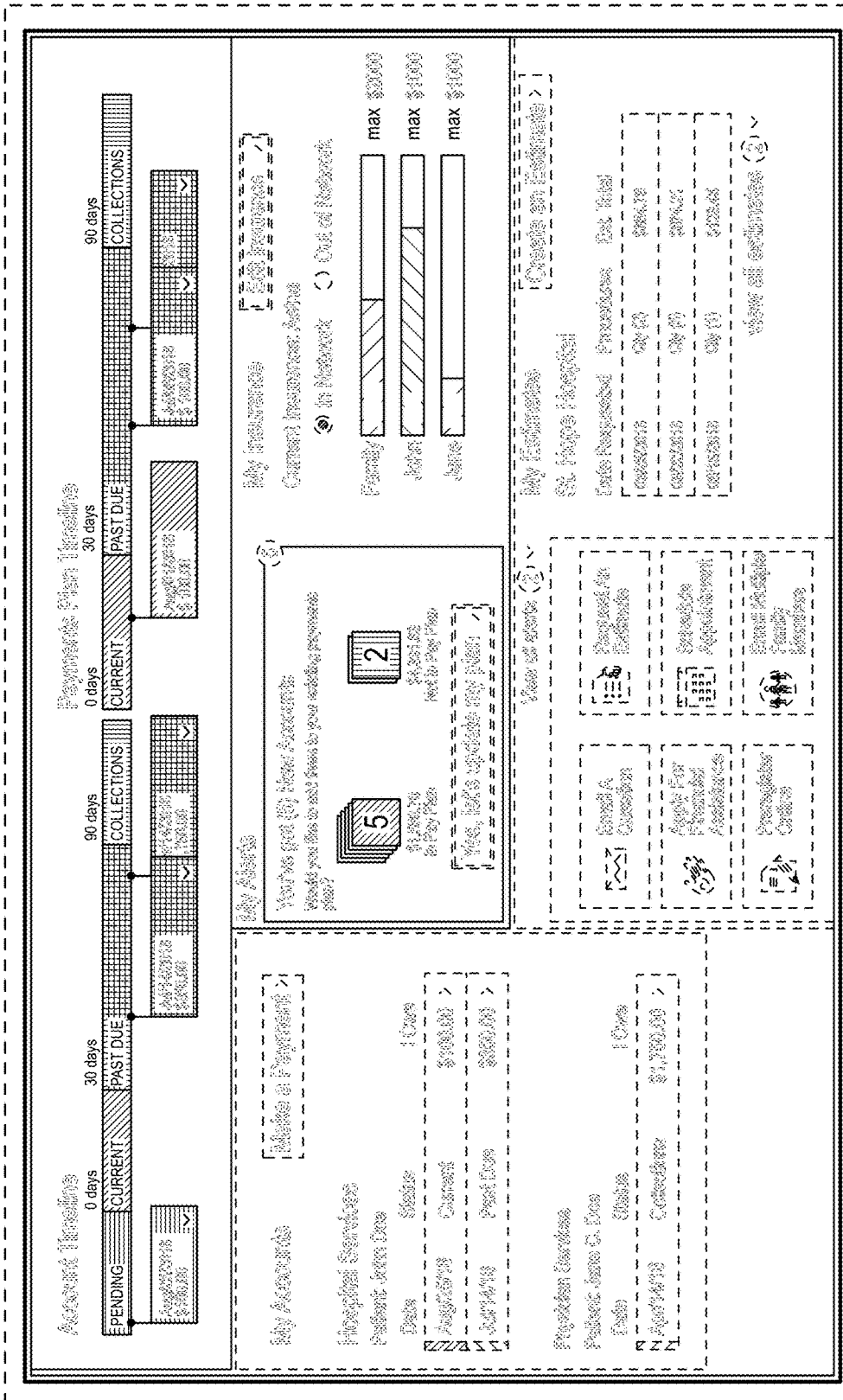

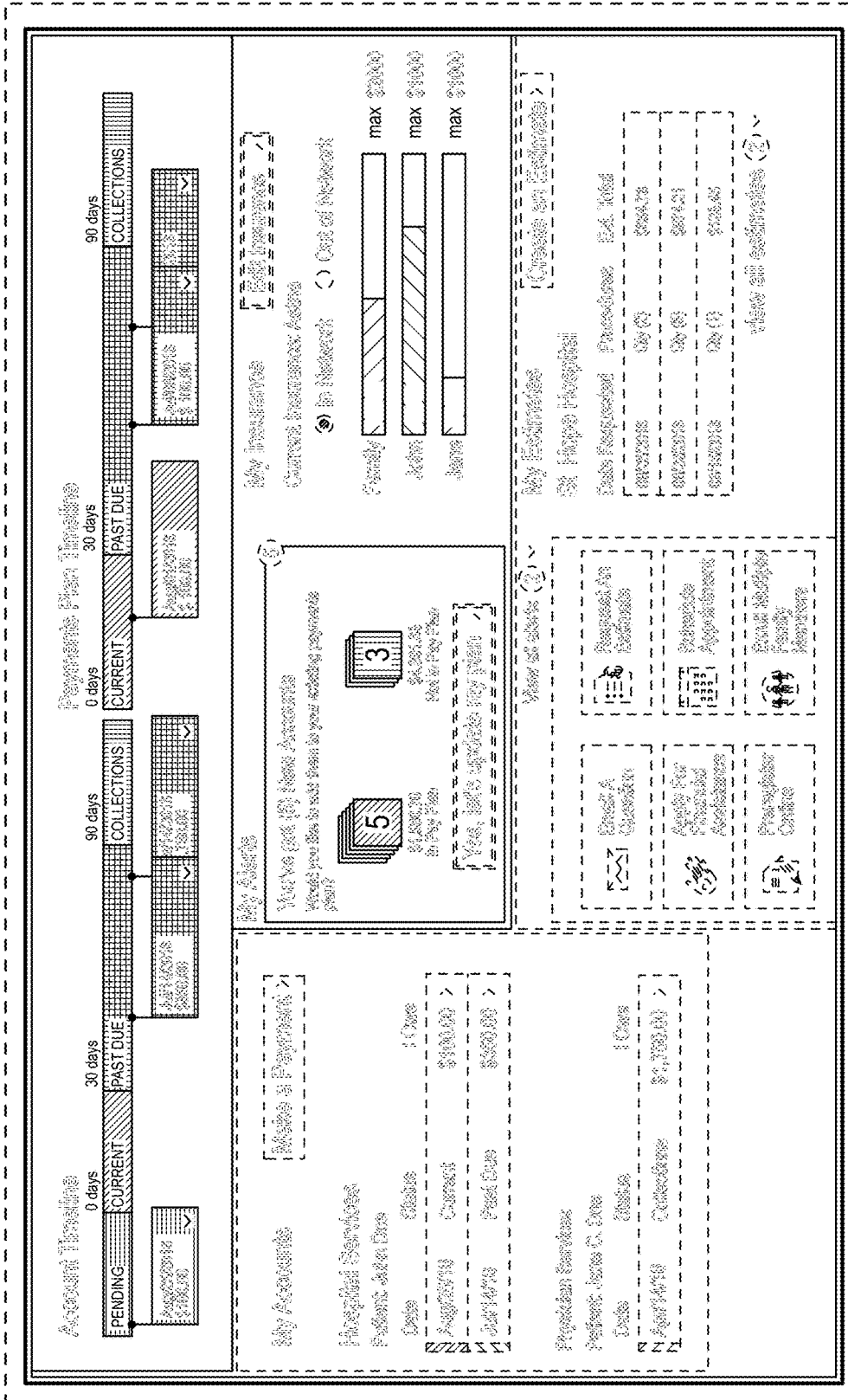

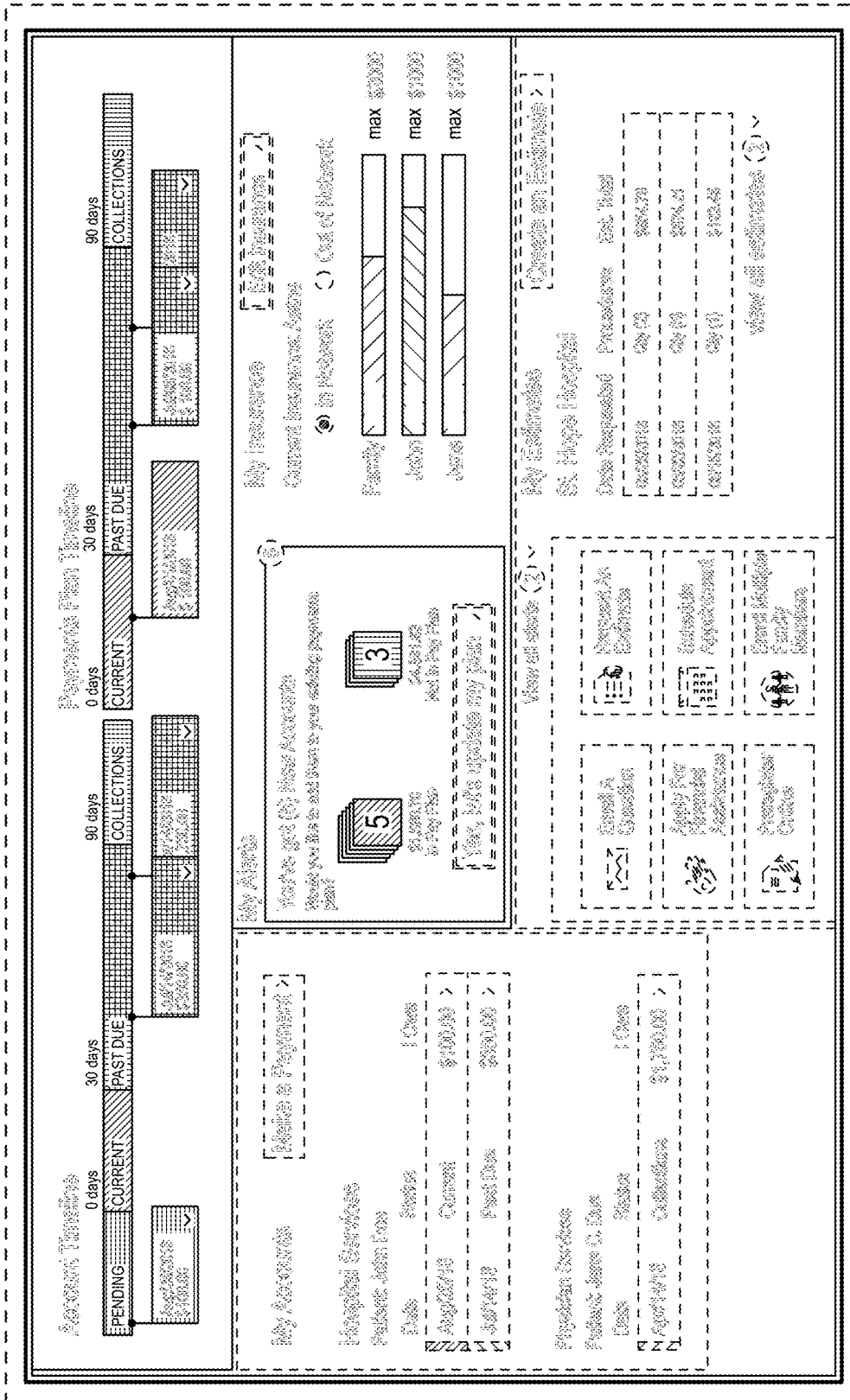

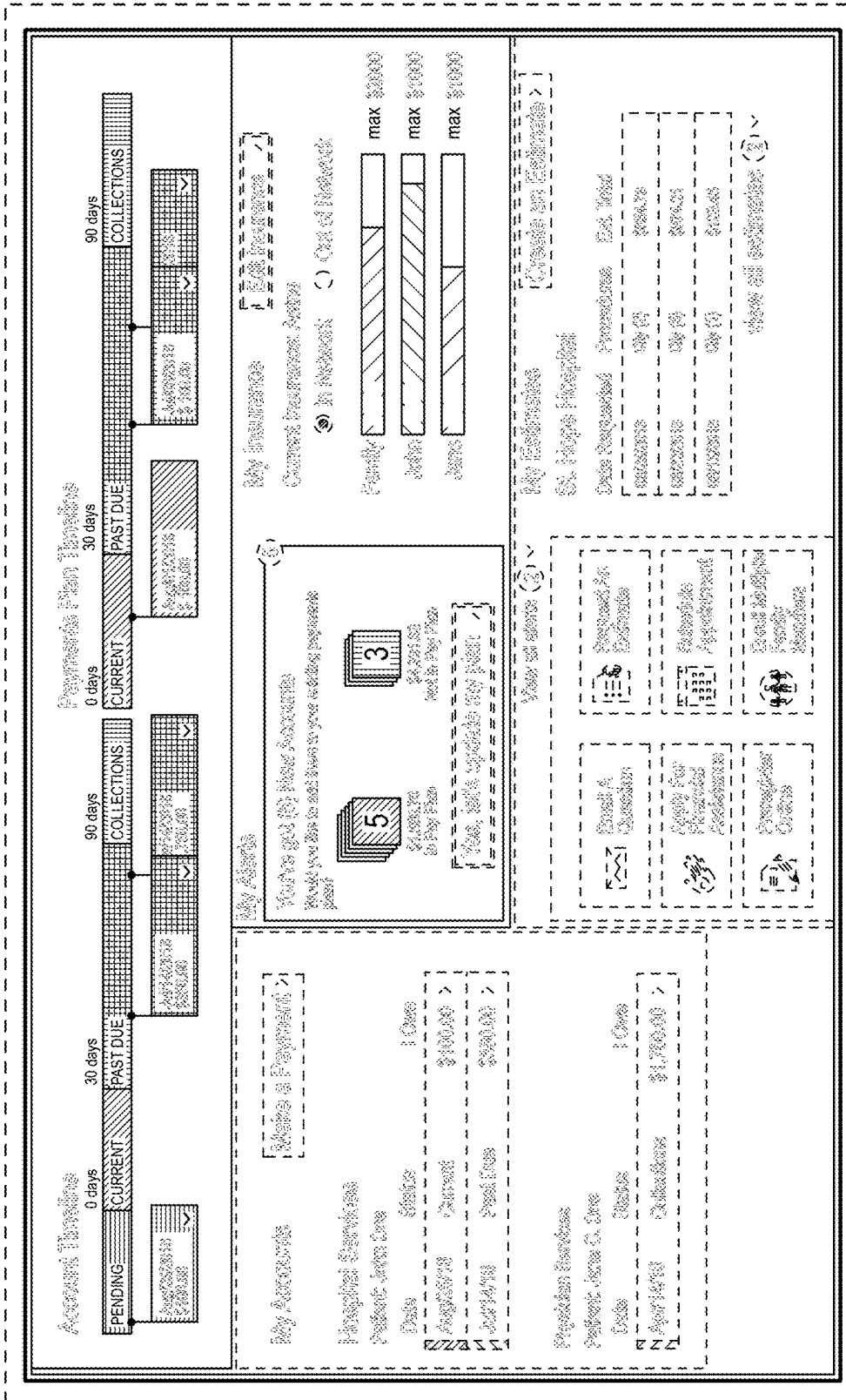

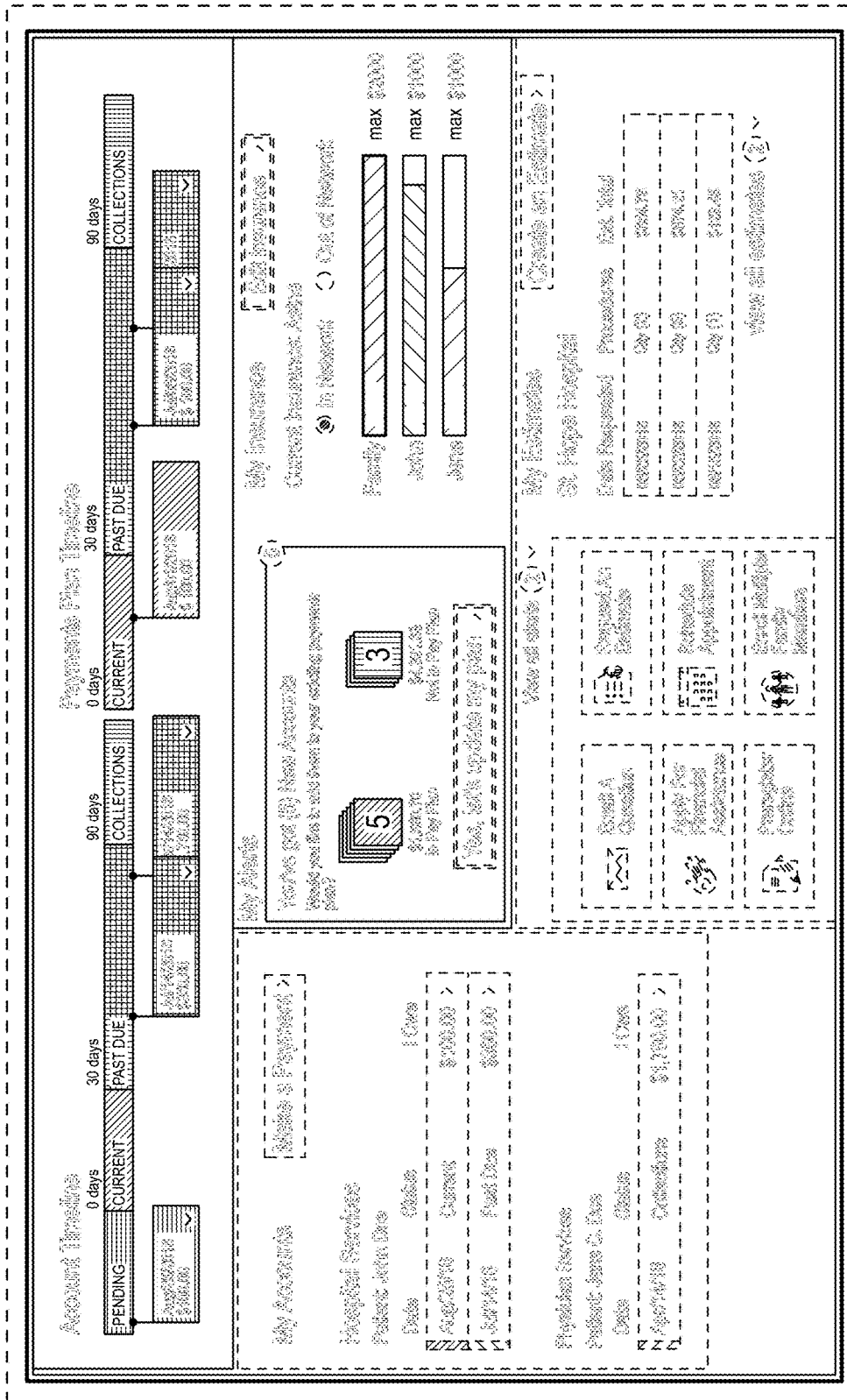

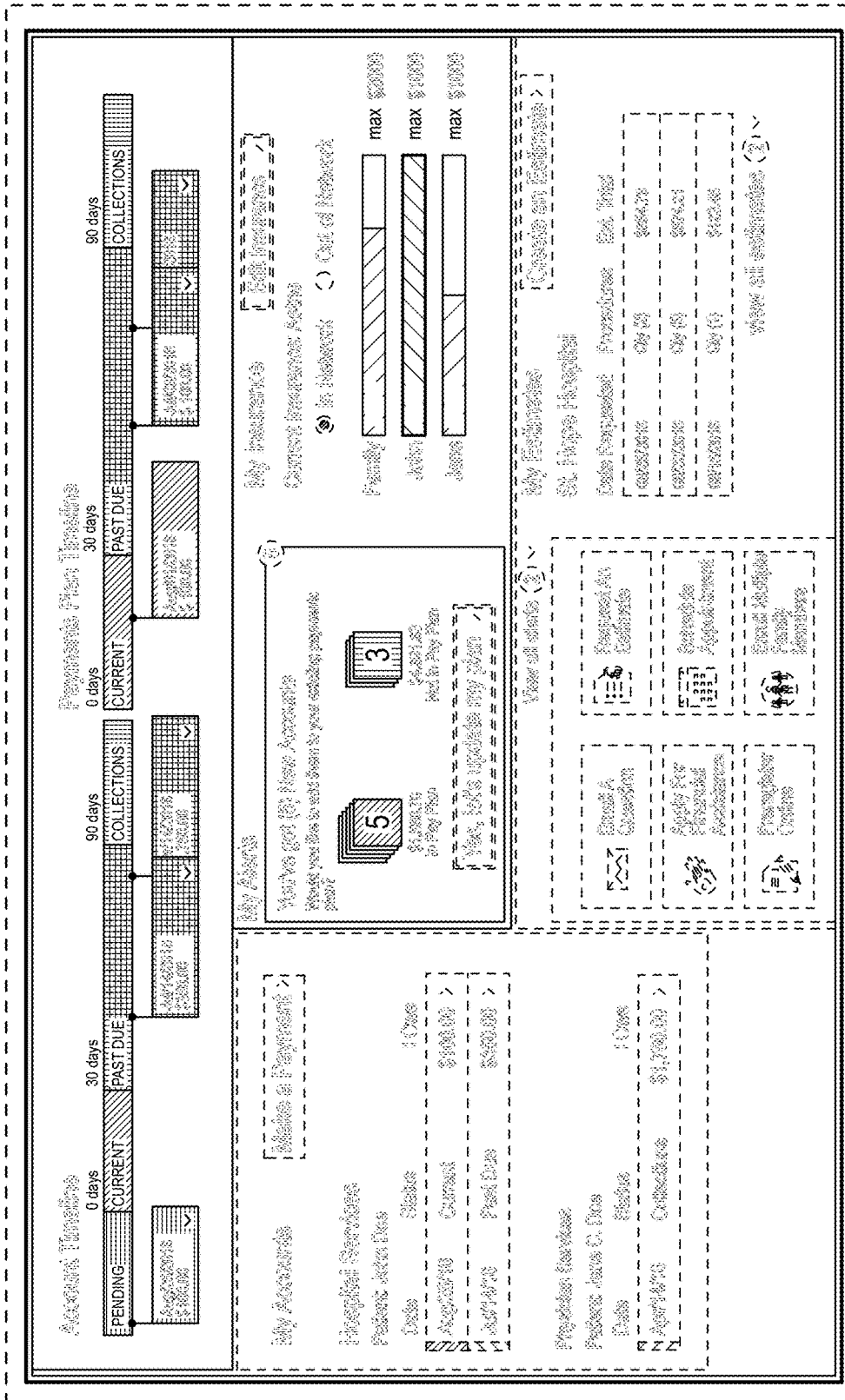

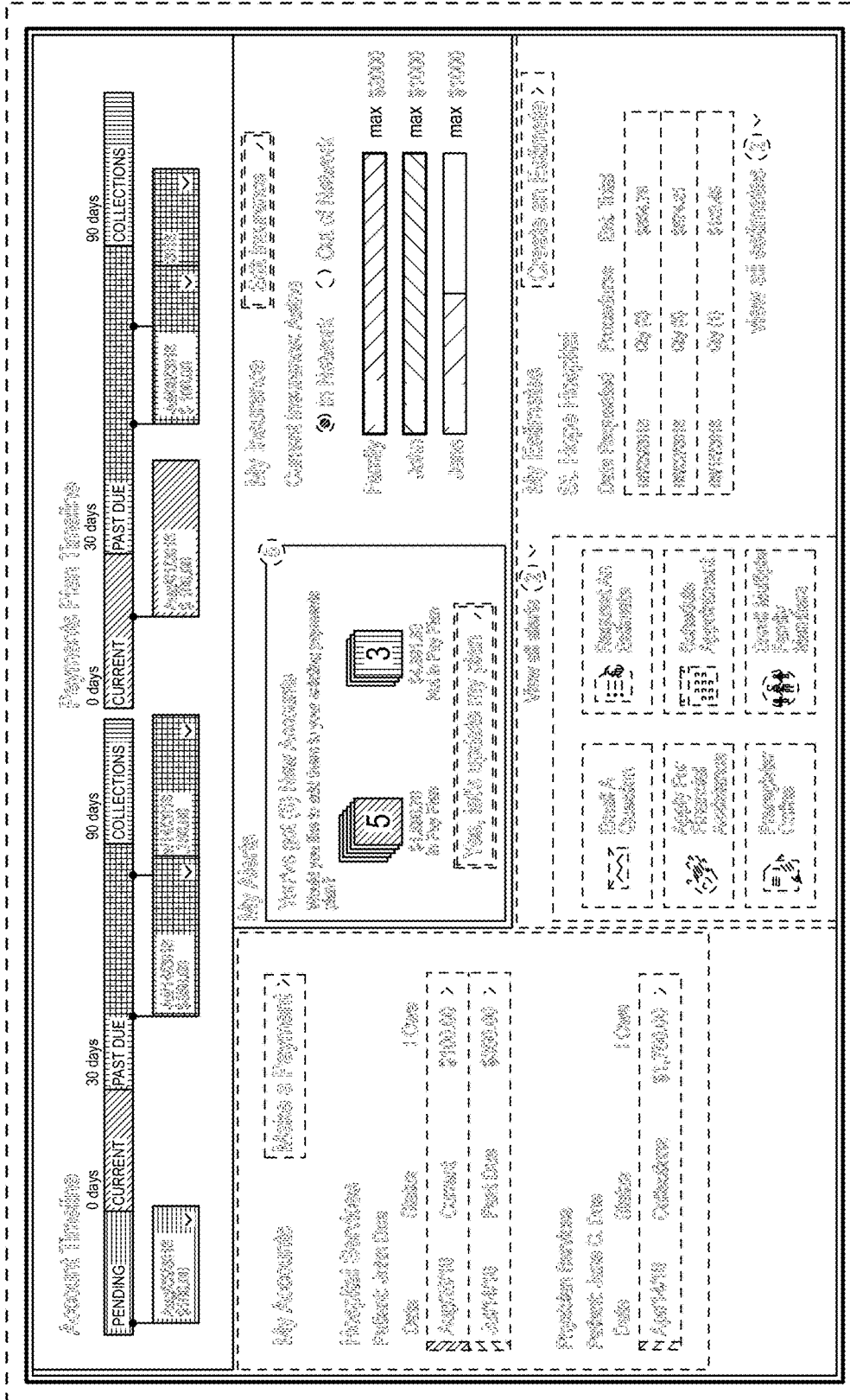

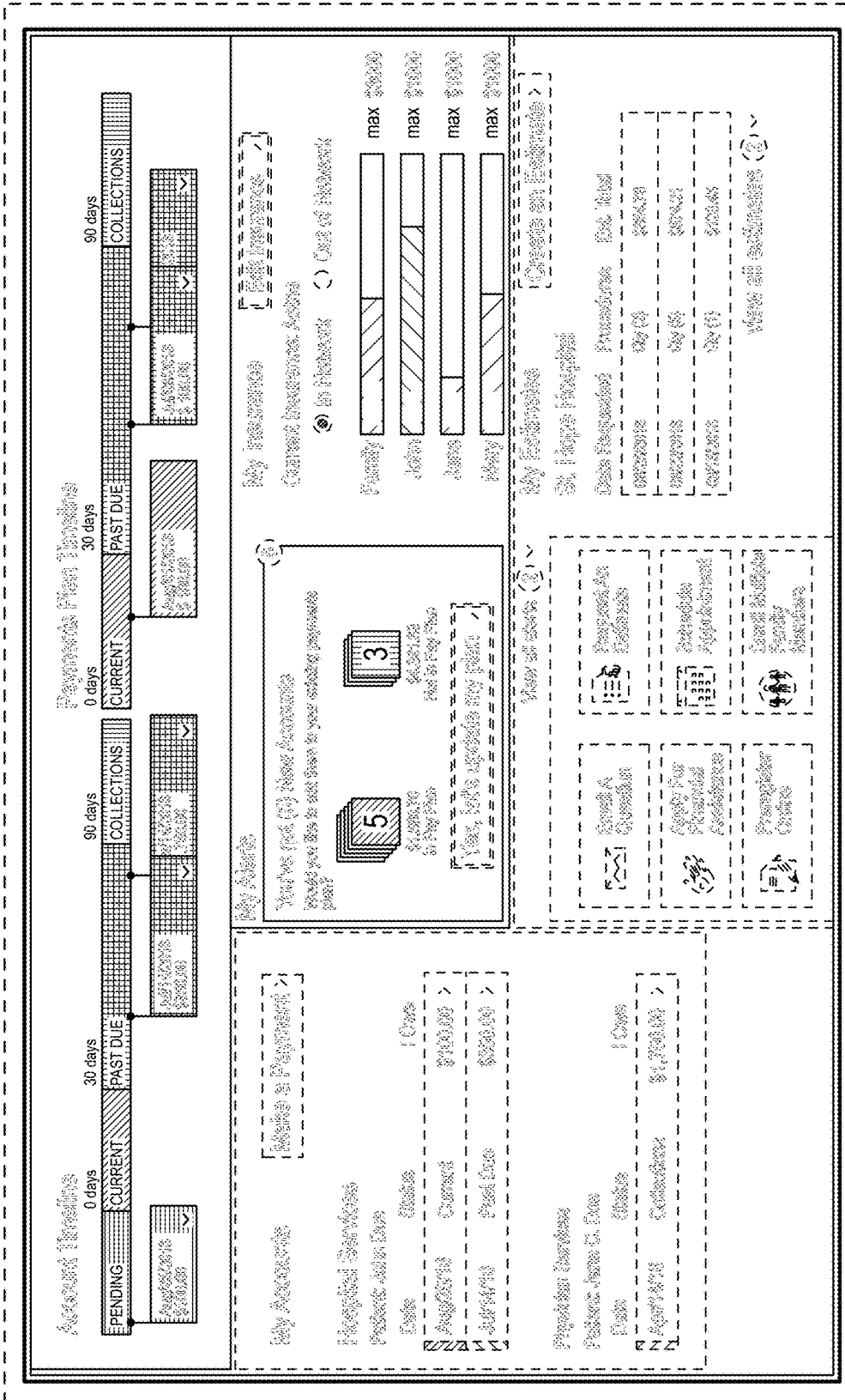

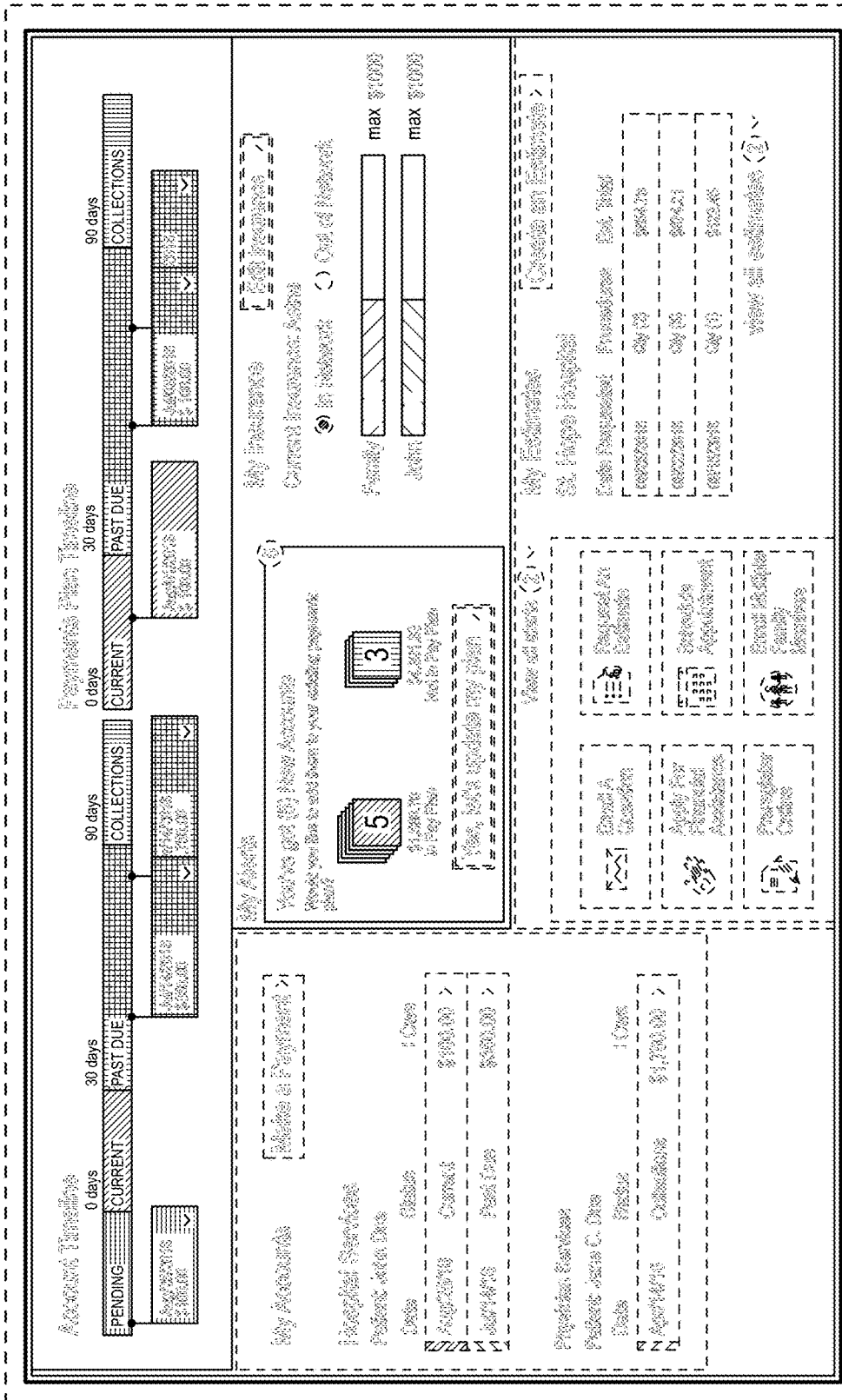
