(57) **CLAIM**

The ornamental design for a dispenser for refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of a dispenser for refrigerator showing our new design; FIG. 2 is the front-side elevational view thereof; FIG. 3 is the rear-side elevational view thereof; FIG. 4 is the left-side elevational view thereof; FIG. 5 is the right-side elevational view thereof; FIG. 6 is the top-side elevational view thereof; and FIG. 7 is the bottom-side elevational view thereof; and, FIG. 8 shows the dispenser for refrigerator is installed on an unclaimed environment.

The surface treatment of the dispenser for refrigerator shown in the figures forms no part of the claimed design, a dispenser for refrigerator according to the claimed design may have any surface treatment.

The broken lines in the drawing show unclaimed environment only and form no part of the claimed design.

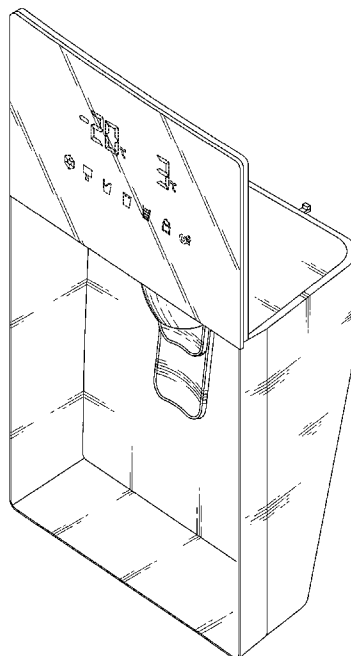

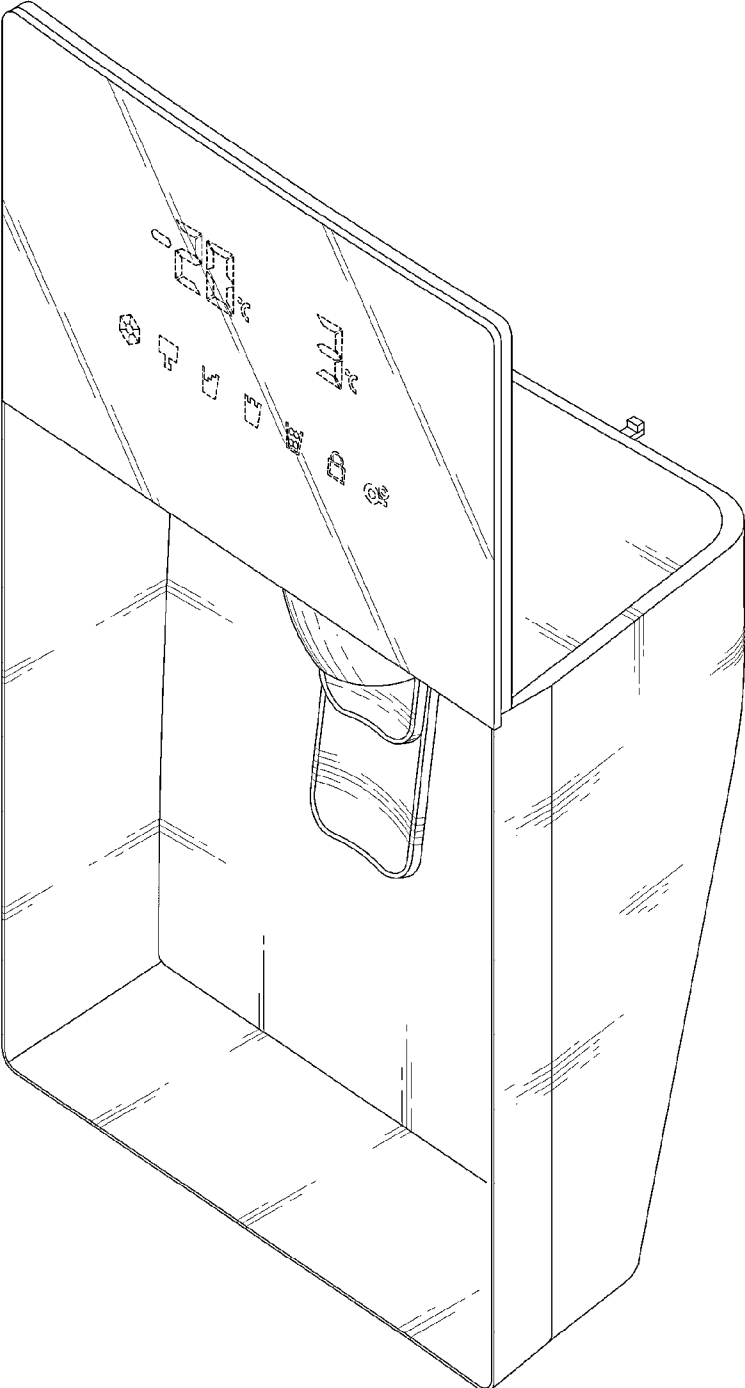

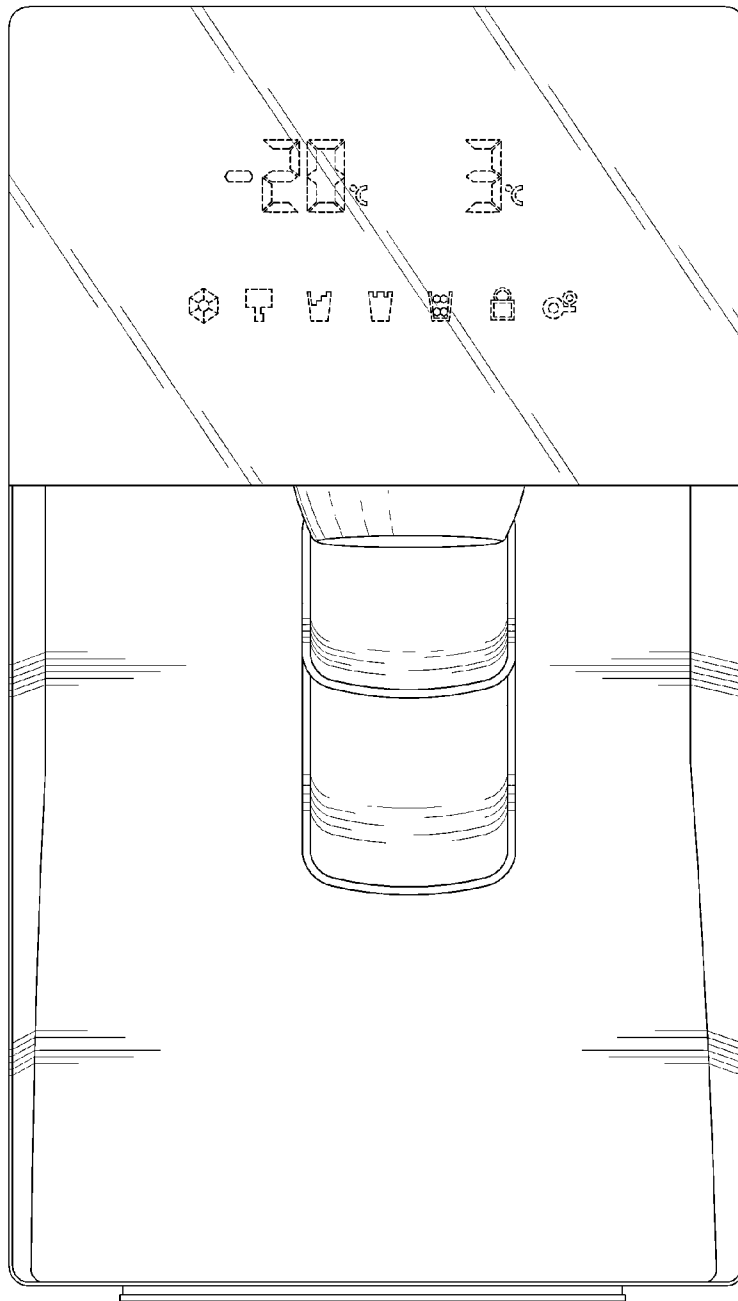

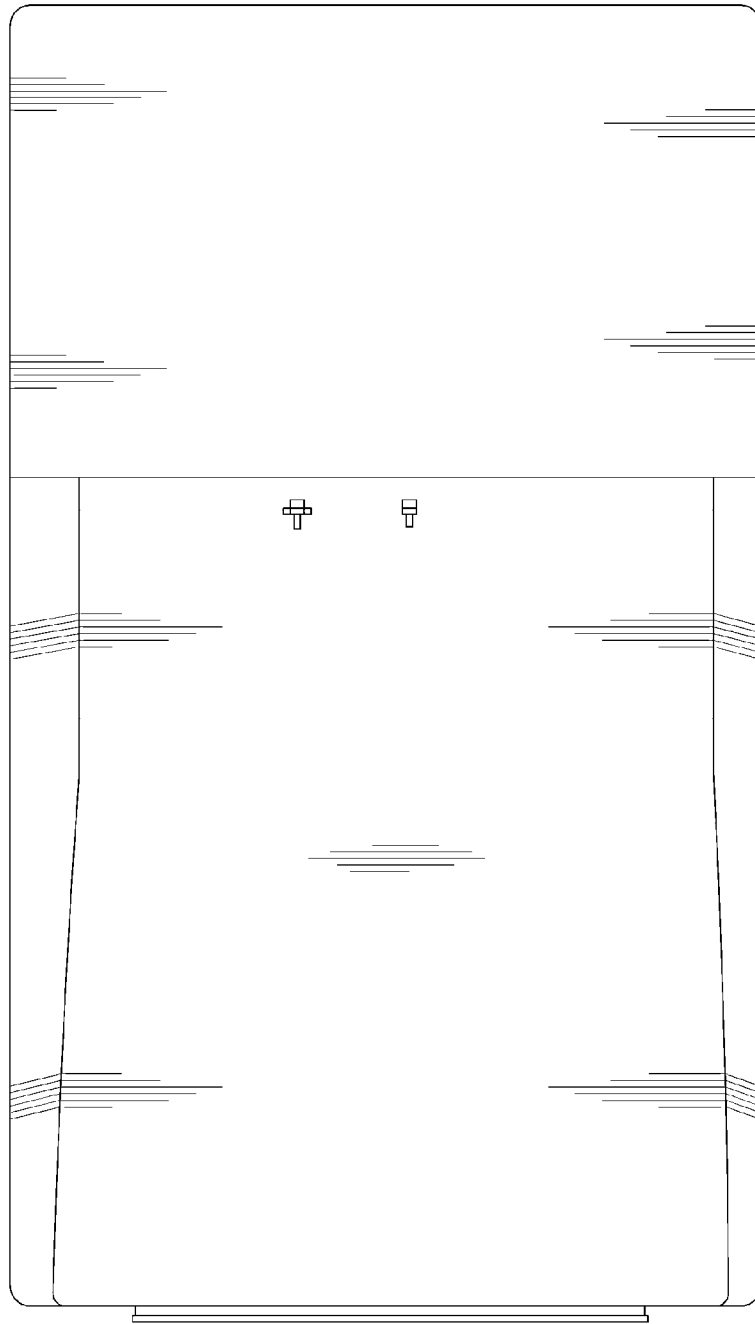

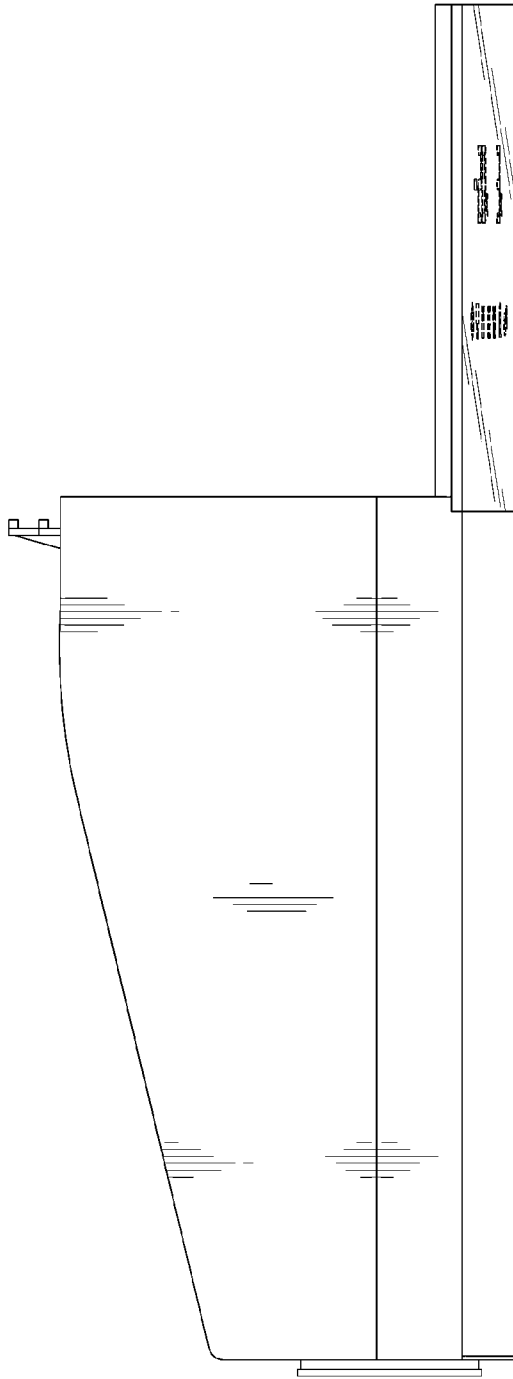

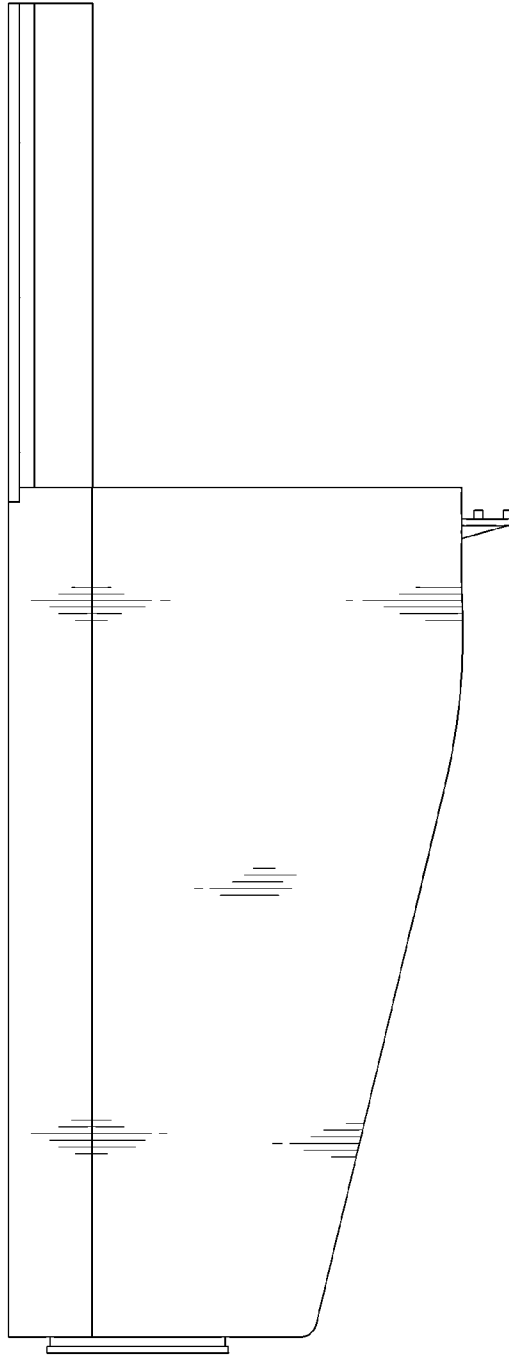

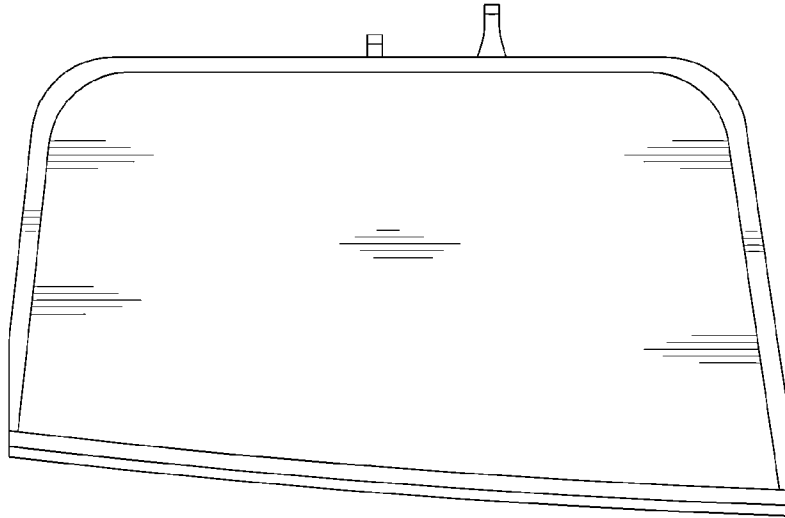

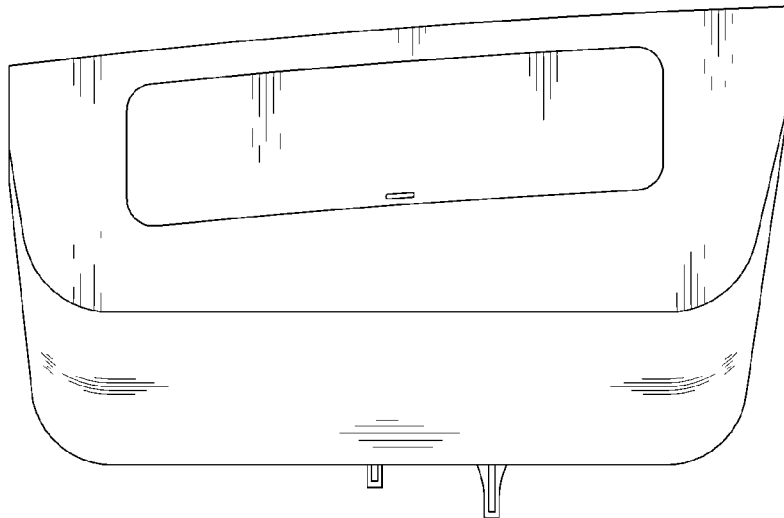
