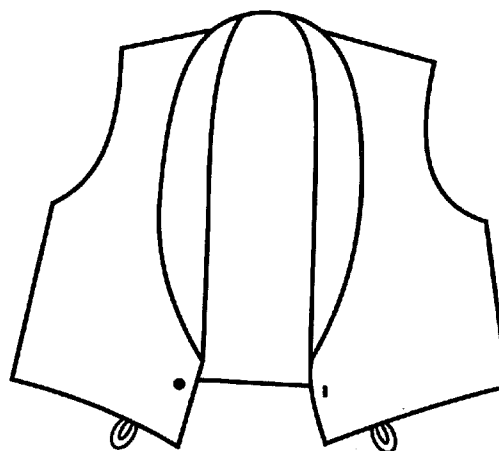
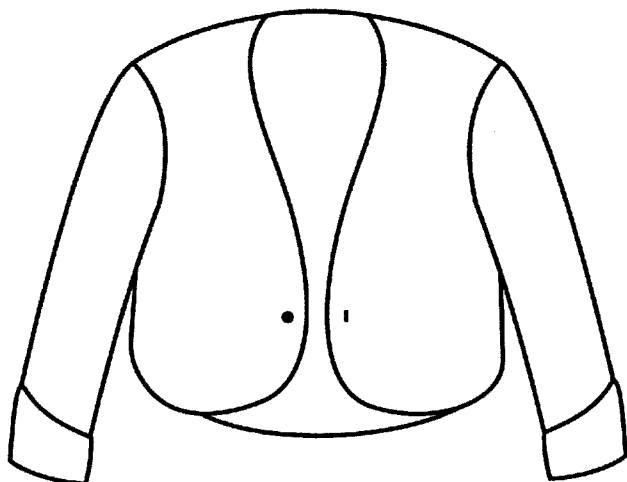
(57) **CLAIM**

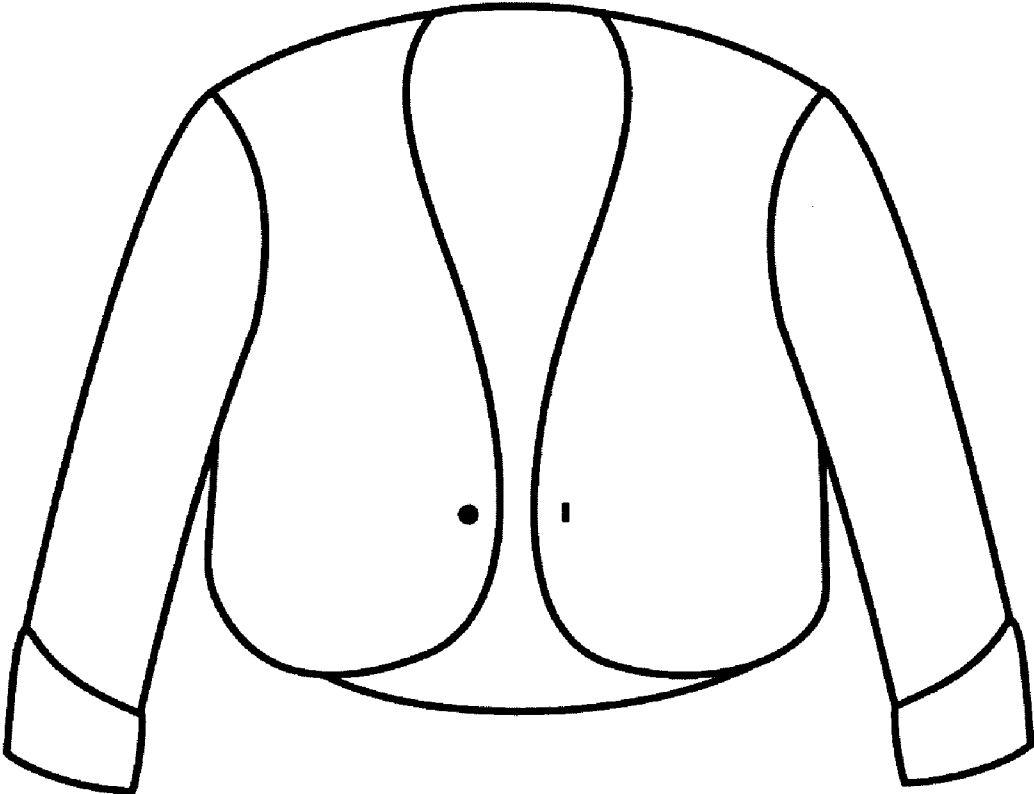
I claim the ornamental design for a Mariachi suit, as shown and described.

**DESCRIPTION**

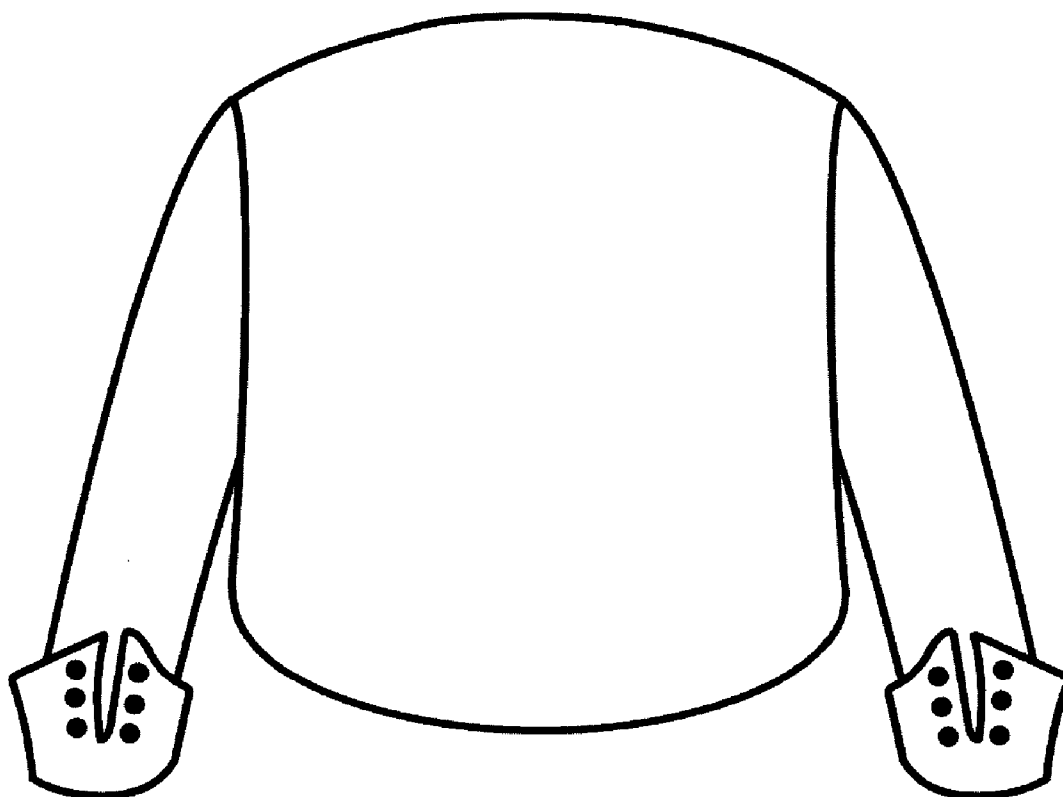
FIG. 1 is a front view of the jacket portion of a Mariachi suit showing my new design;

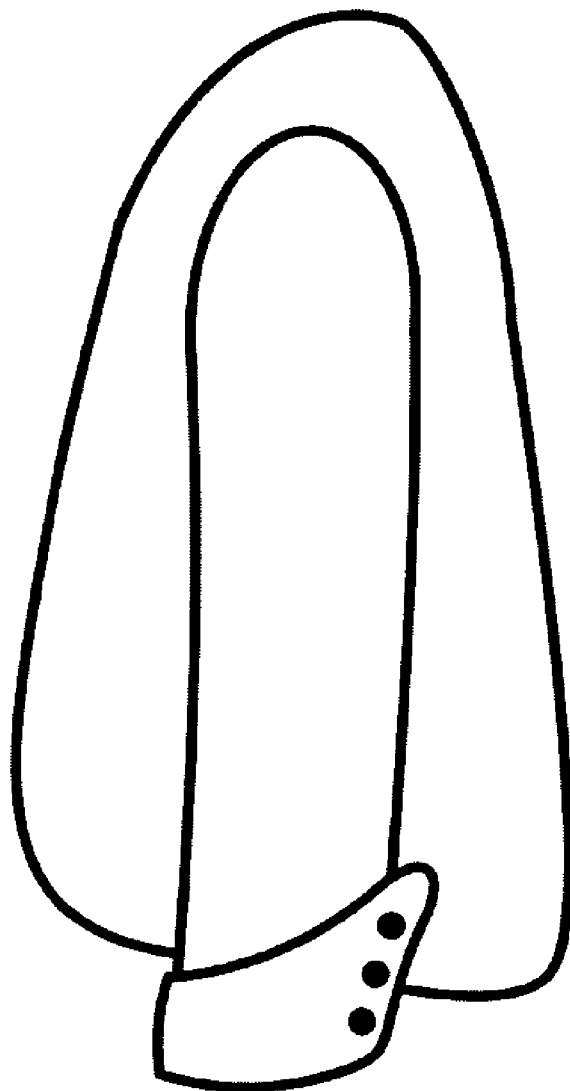




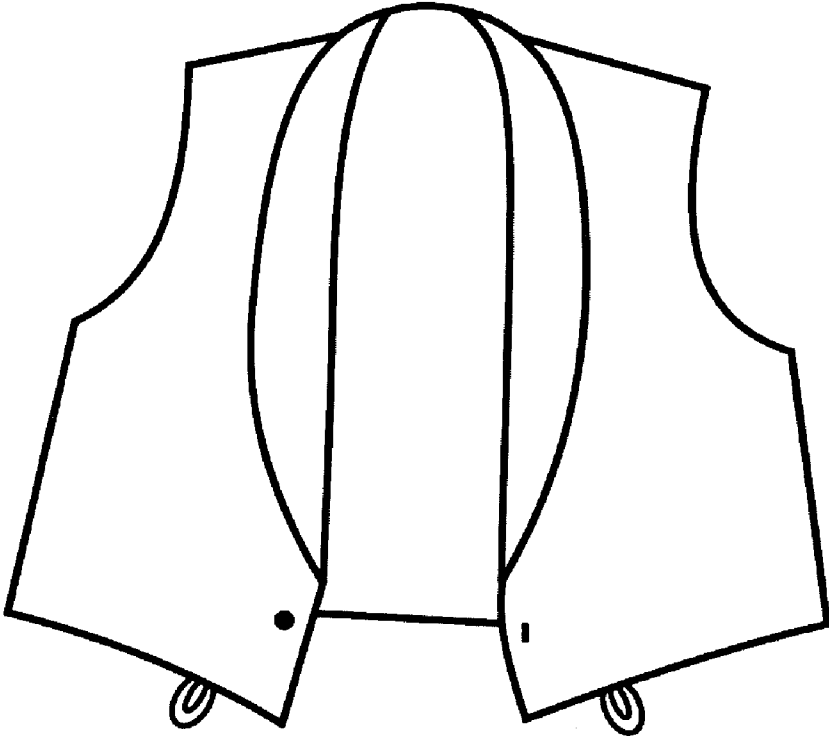

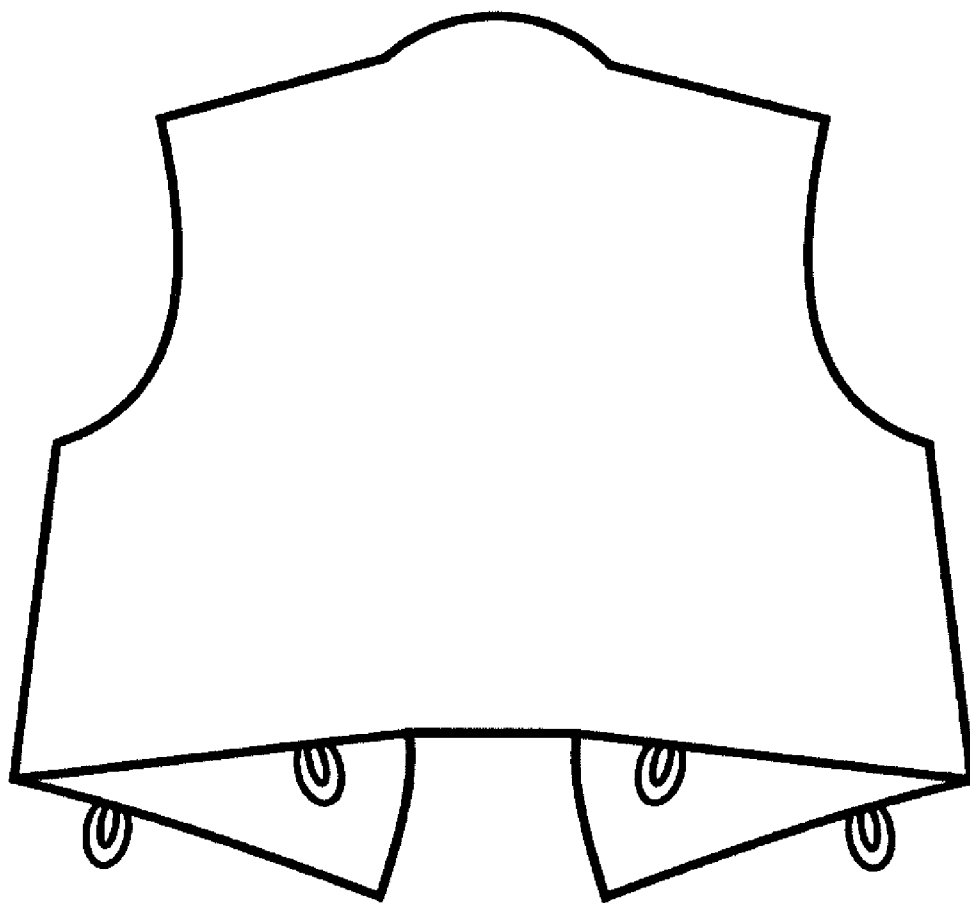

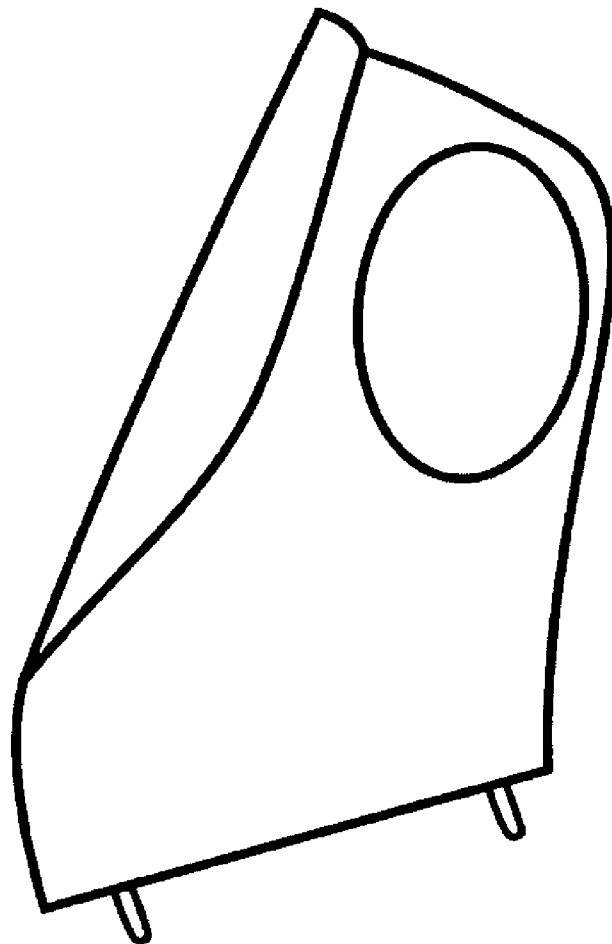

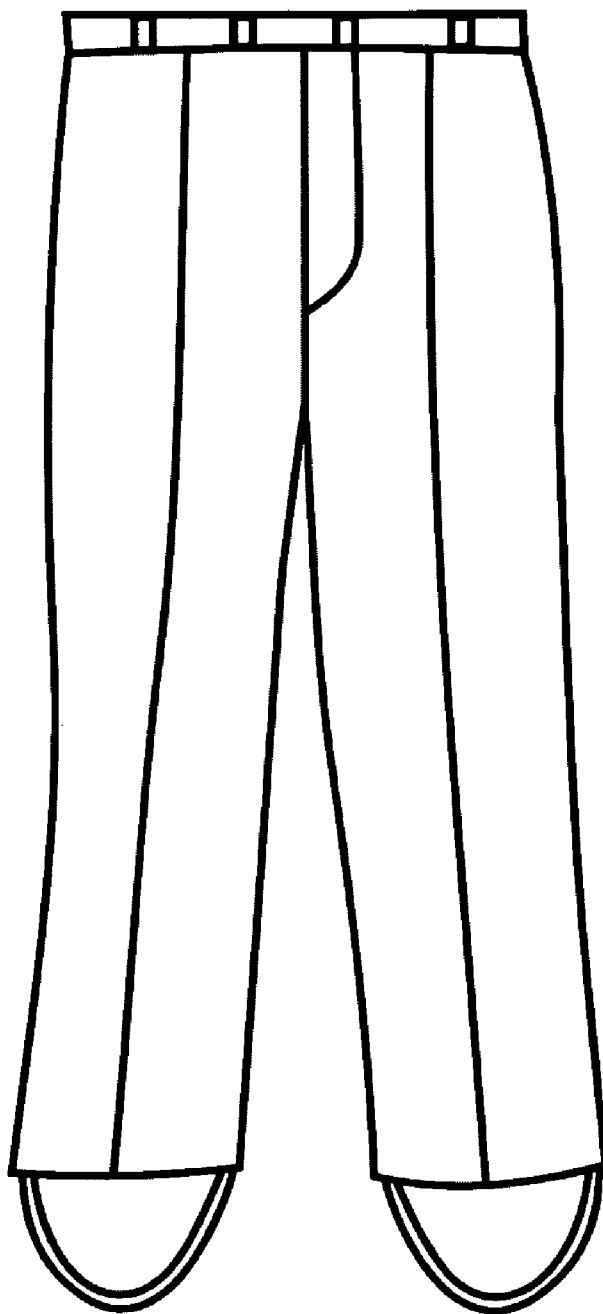

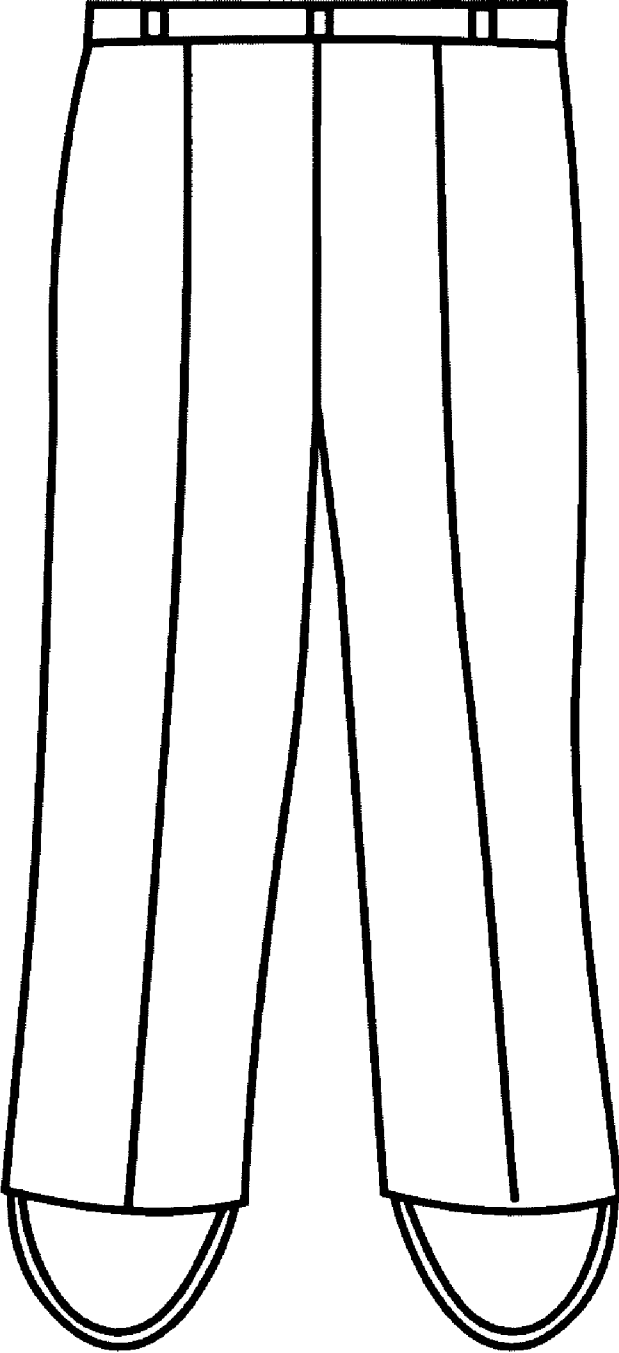

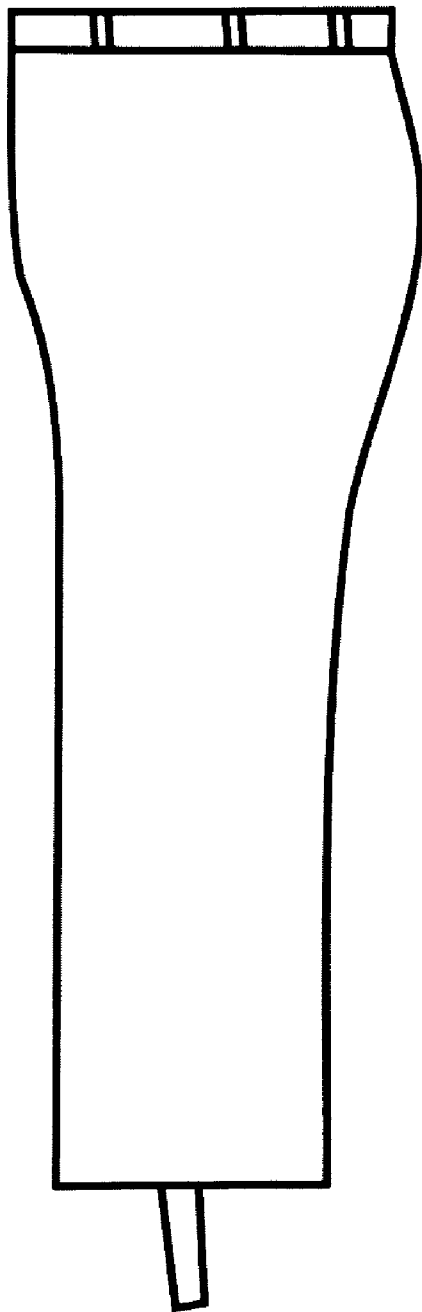

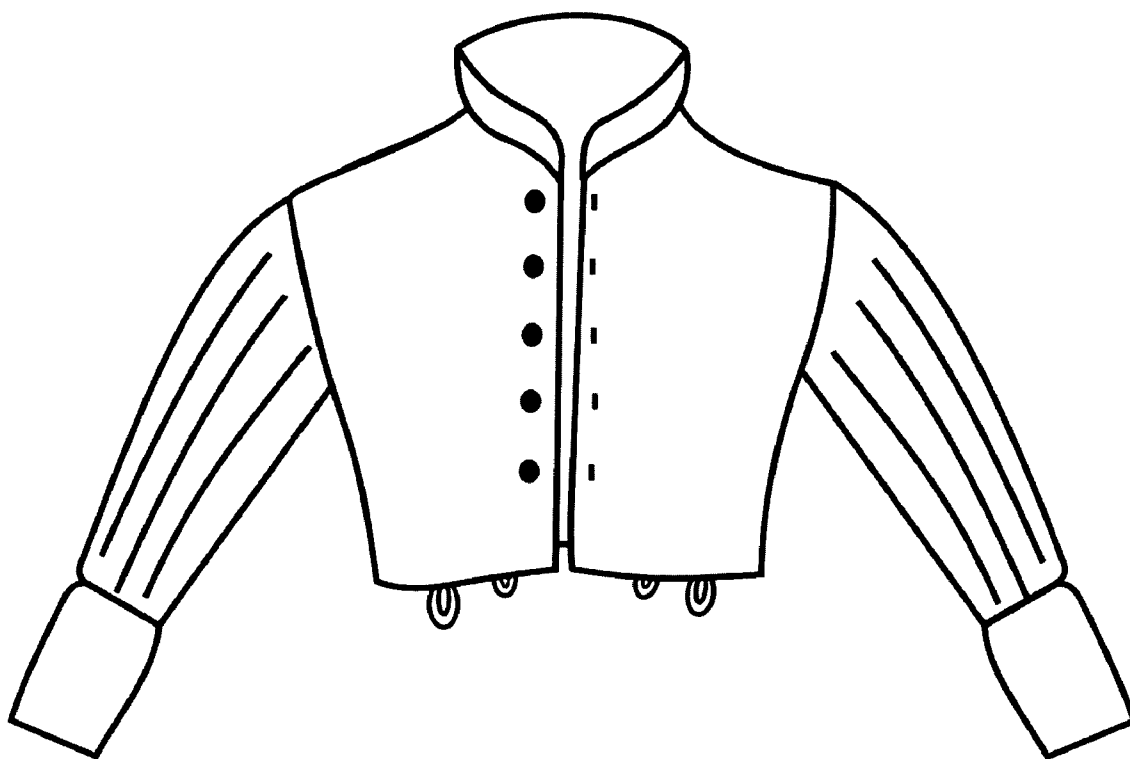

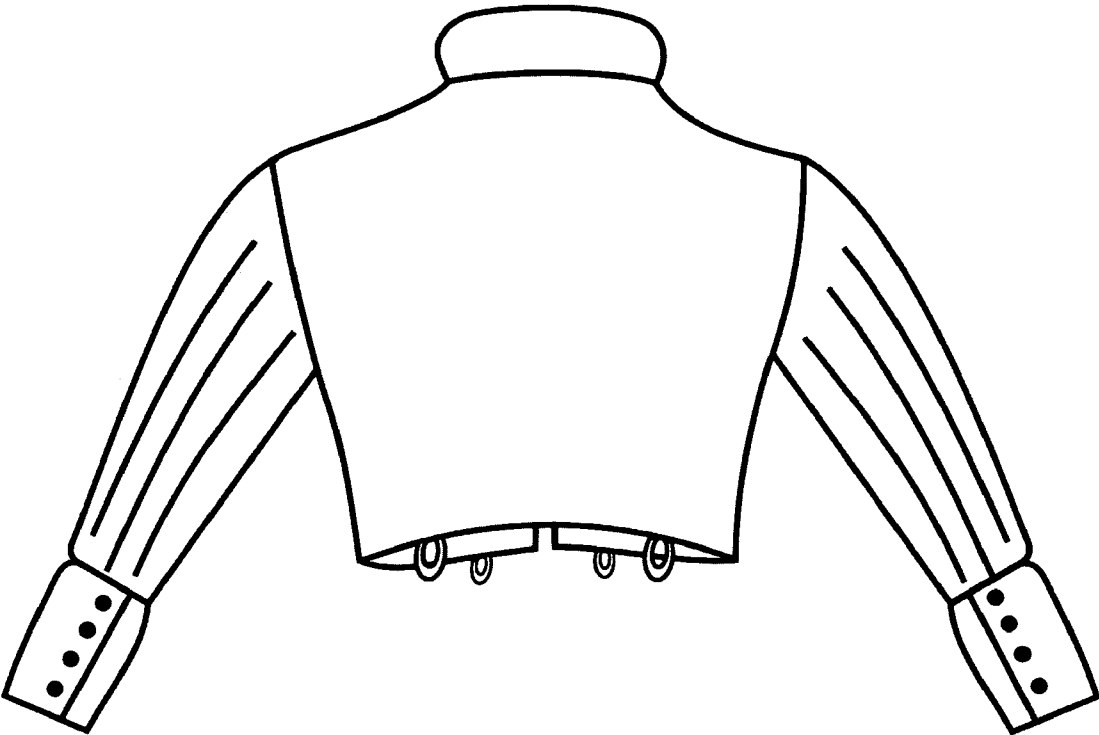
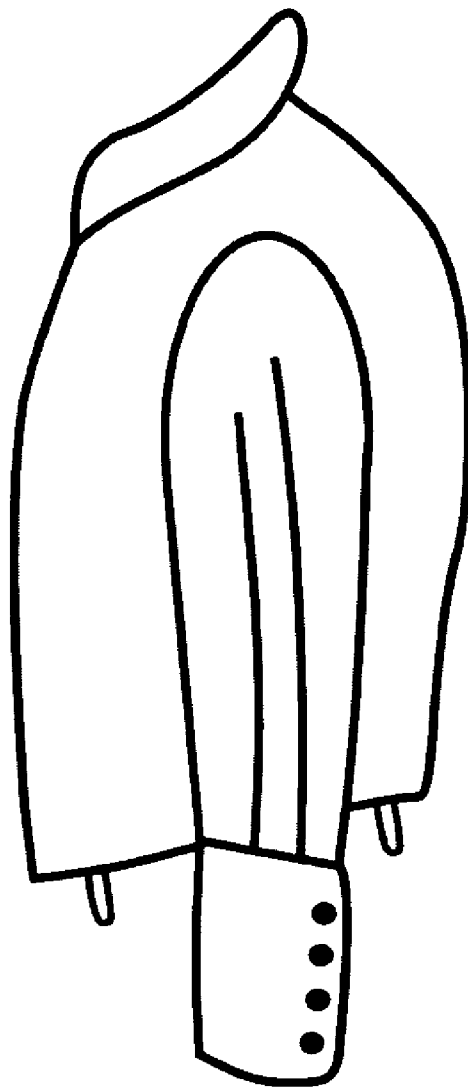
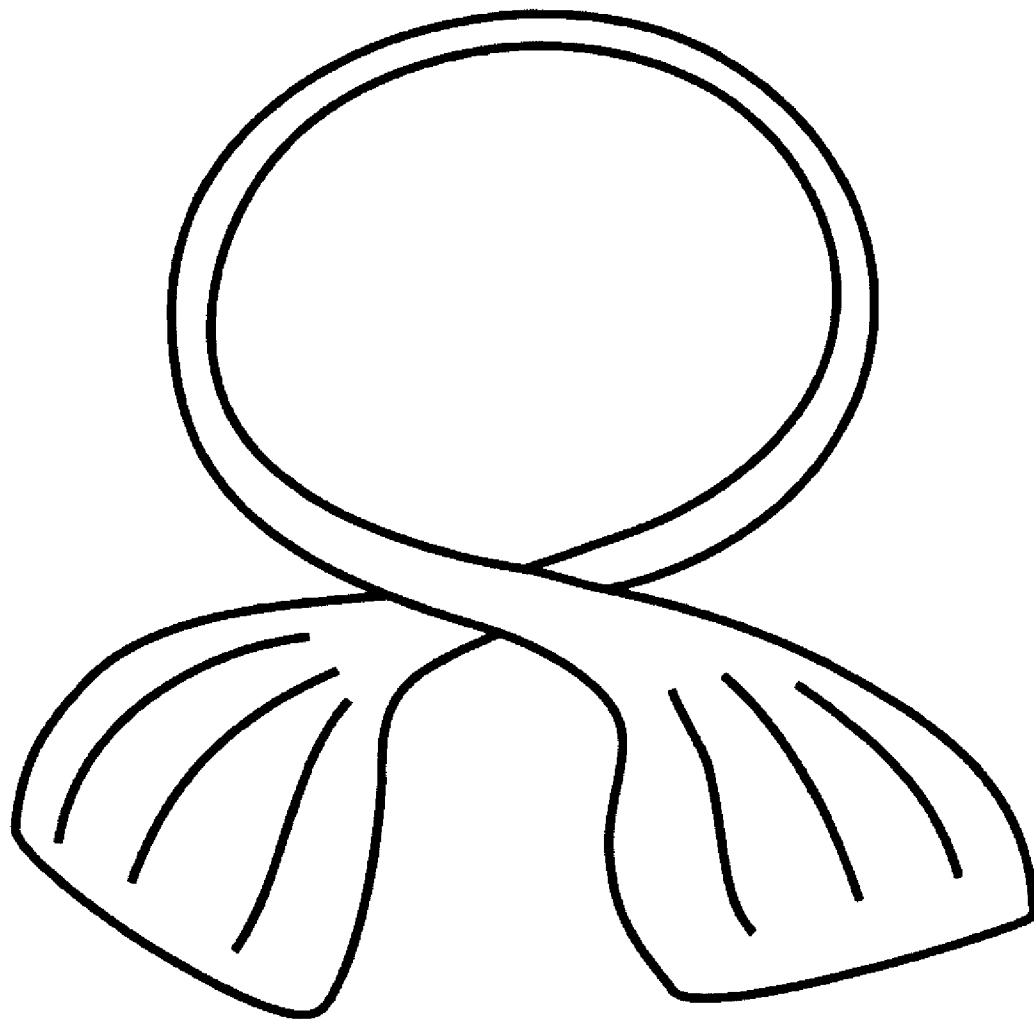


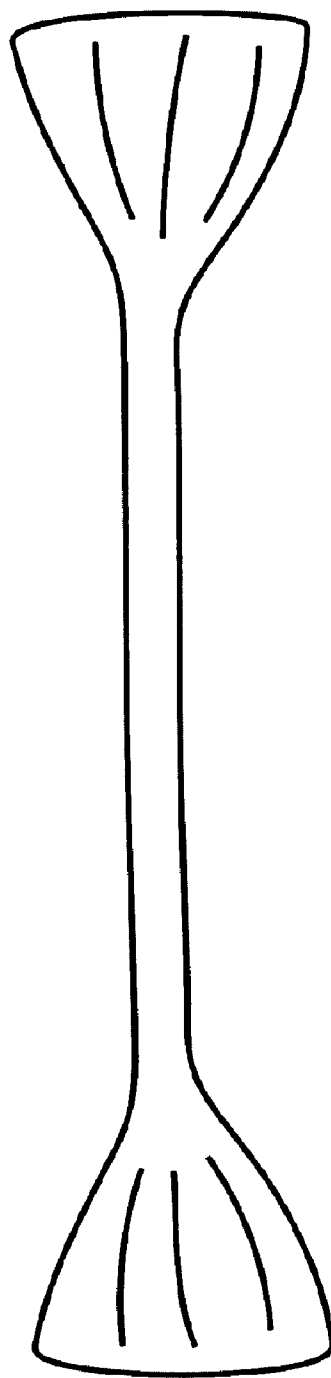
