(57) Abstract: The invention provides the use of a compound for the manufacture of a medicament for the treatment of pain, wherein the compound is a compound of the formula (VI); or a salt, solvate, tautomer or N-oxide thereof; wherein the bicyclic group: is selected from the structures (C1), (C5) and (C6); wherein n, R¹, R^{2a}, R³, R^{4a}, R⁸ and R¹⁰ are as defined in the claims. The invention also provides the use of a compound of the formula (VI) for the manufacture of a medicament for the prophylaxis or treatment of a fungal, protozoal, viral or parasitic disease state or condition (other than a disease state or condition due to Plasmodium falciparum) or for use in the prophylaxis or treatment of Ewing's sarcoma, atherosclerosis or lupus erythematosus.
