DESCRIPTION

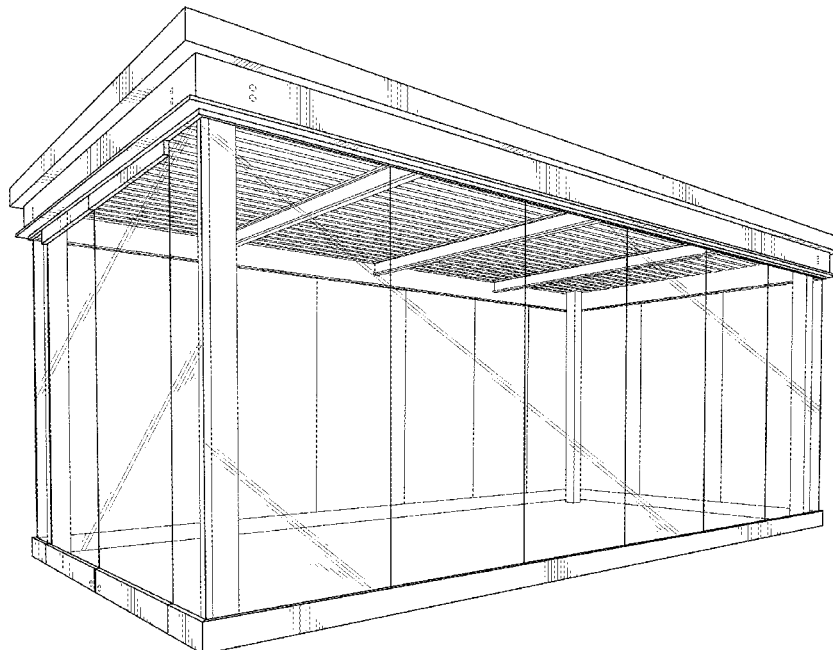
FIG. 1 is a perspective view taken from the front and first side of the transparent enclosure of my new design;
FIG. 2 is a perspective view taken from the front and second side thereof;

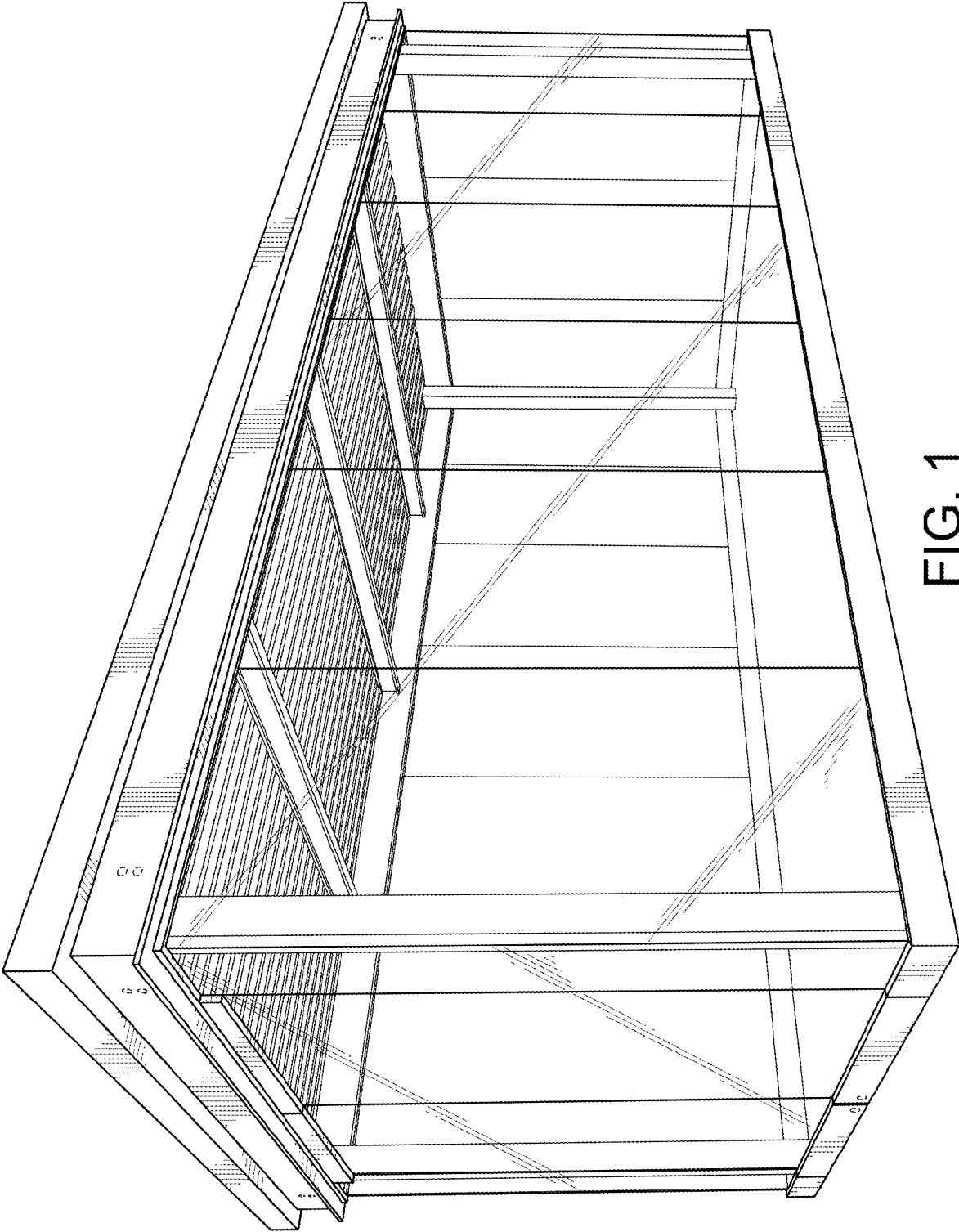

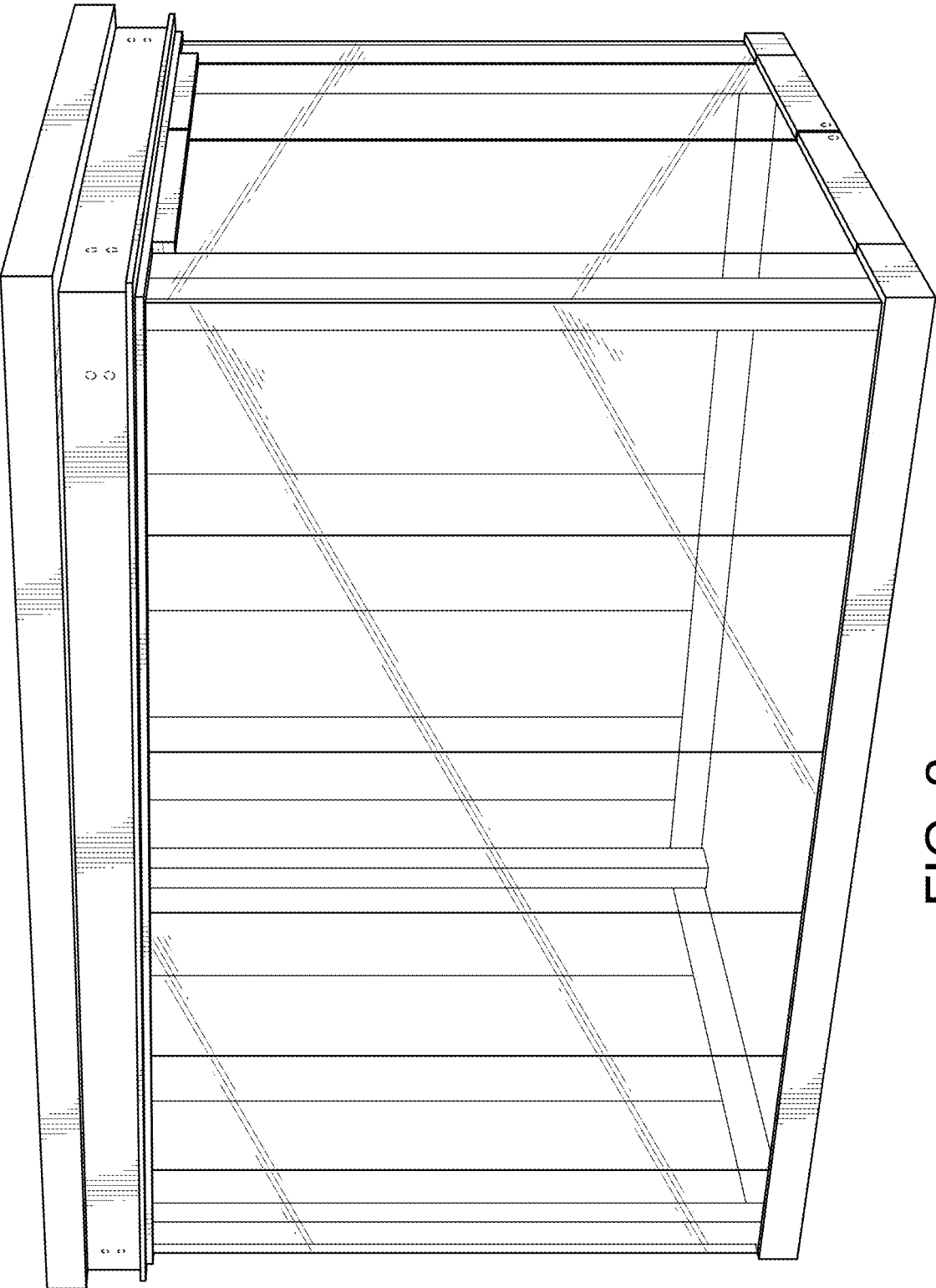

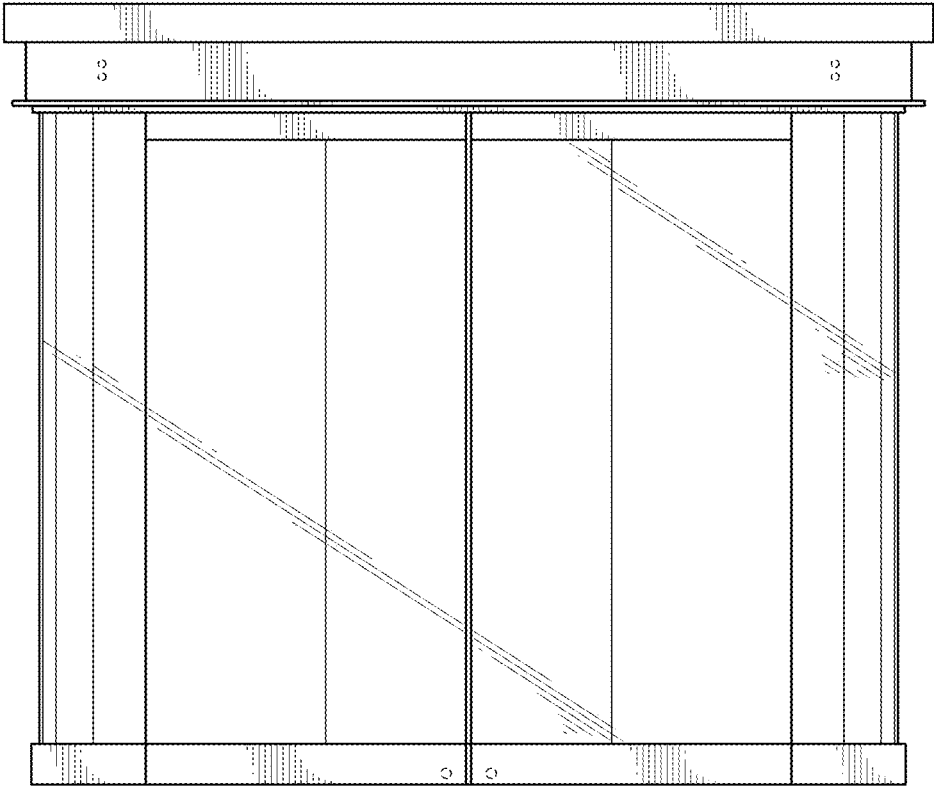

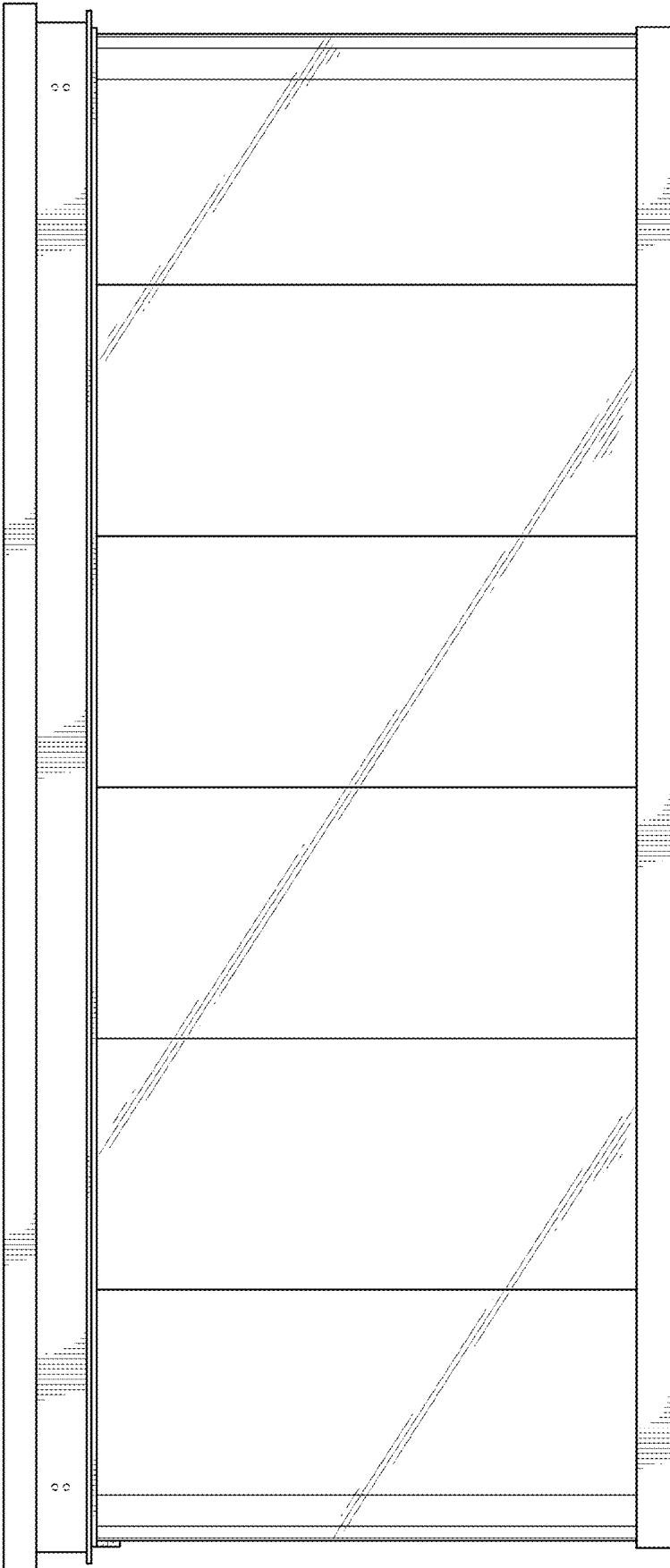

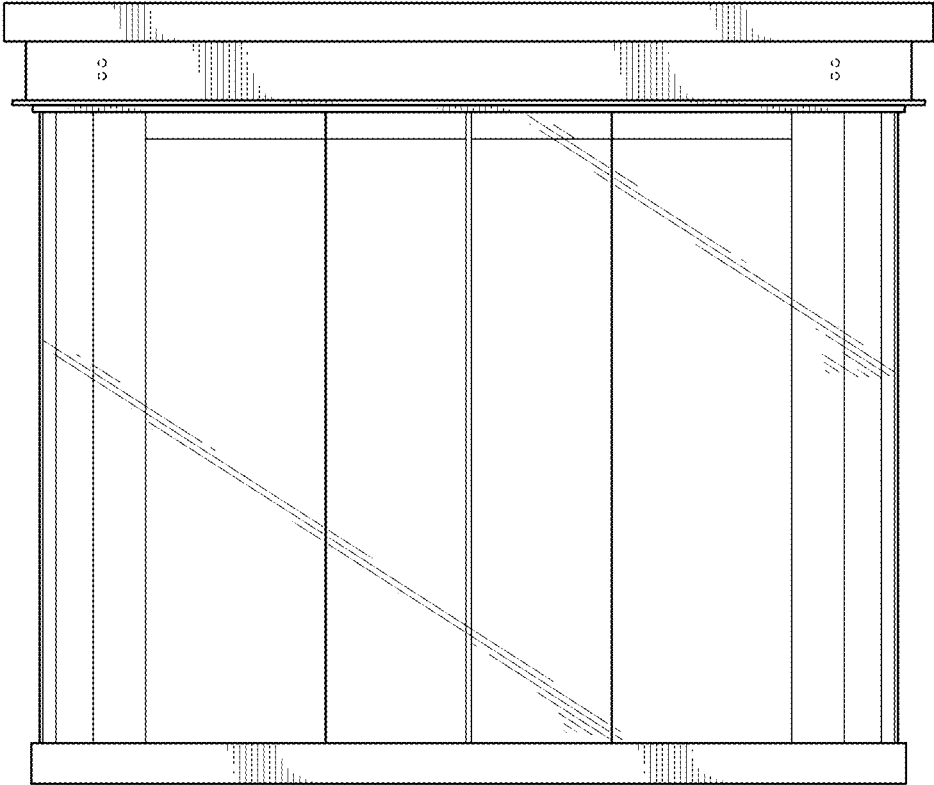
