(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The sole FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The broken lines in the FIGURE show portions of the display screen or portion thereof with graphical user interface which form no part of the claimed design.
