





(57) Abstract: The invention indexes an audiovisual recording to enable navigation within the audiovisual recording. In particular, the invention provides indexing within a "show" of a recording of an audiovisual broadcast (e.g., a television broadcast or a radio/satellite audio broadcast) that enables navigation within the show, in contrast to indexing among shows (i.e., identification of locations corresponding to the start and/or end of shows) that can enable navigation between shows. The invention also enables navigation among one or more intelligently selected segments of the recording in a non-linear manner. A graphical user interface can be implemented to effect navigation in accordance with the invention of a recording of audiovisual content.
