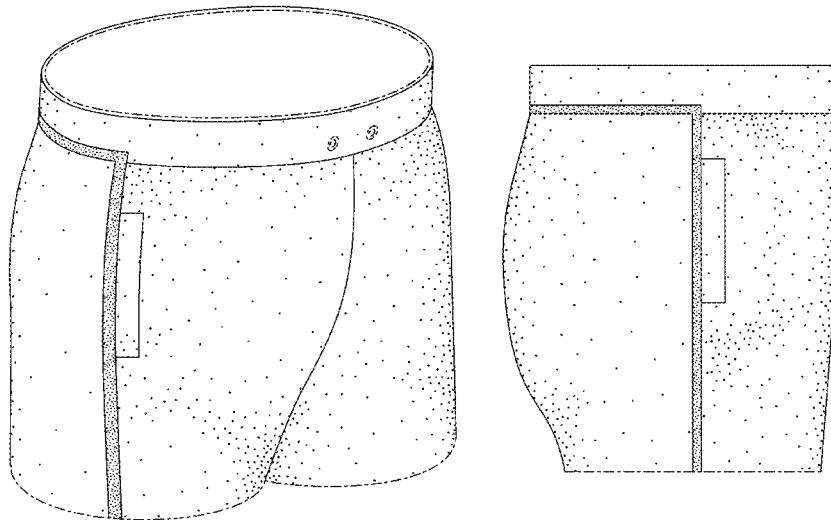
The ornamental design for shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of shorts showing my new design in an in-use configuration;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a side view thereof;
 FIG. 5 is a second side view thereof;
 FIG. 6 is a top view thereof; and,
 FIG. 7 is a bottom view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the shorts and form no part of the claimed design. The contrast in stippling represents a contrast in appearance only and does not represent any particular color, material, texture and finish.

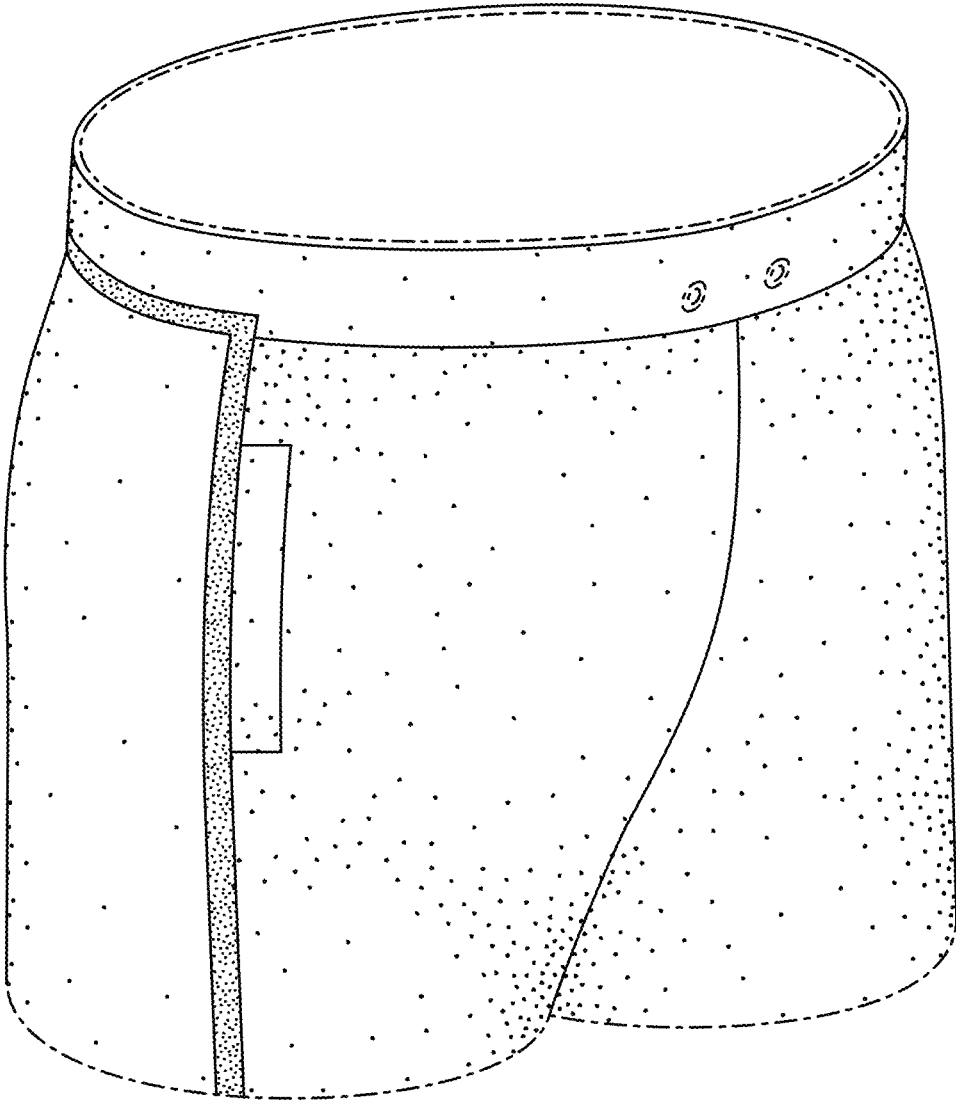

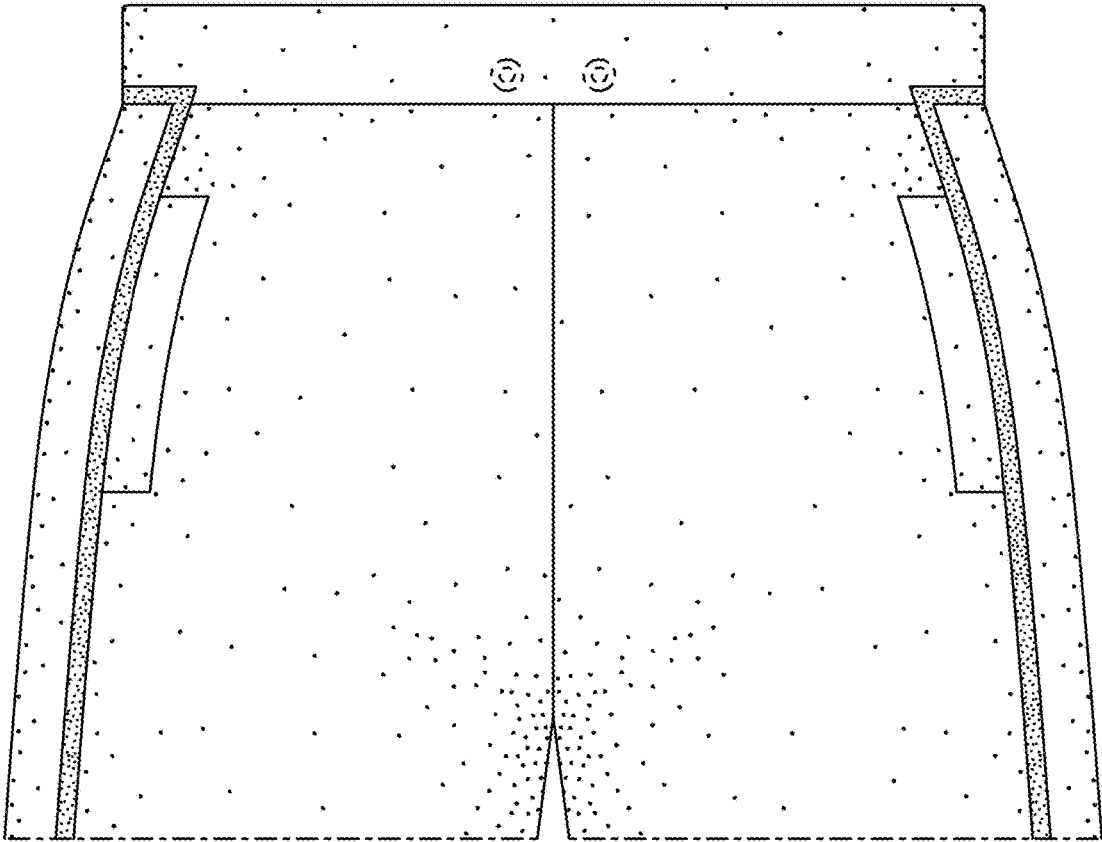

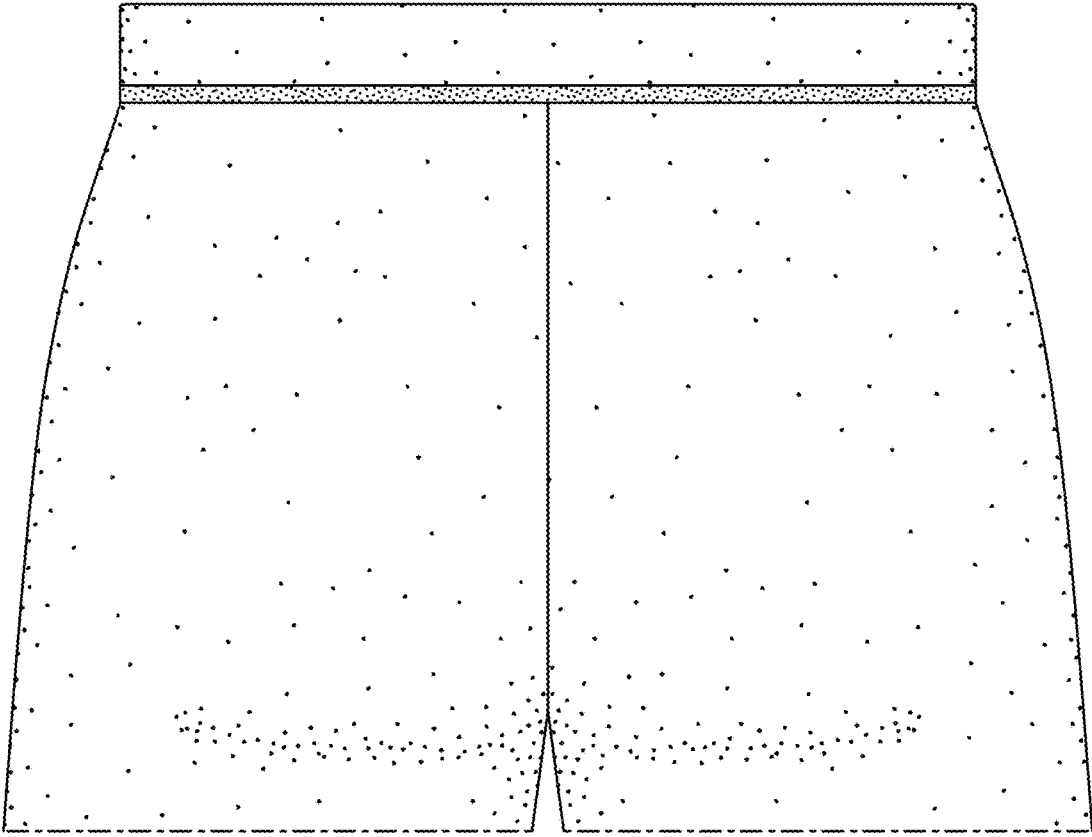

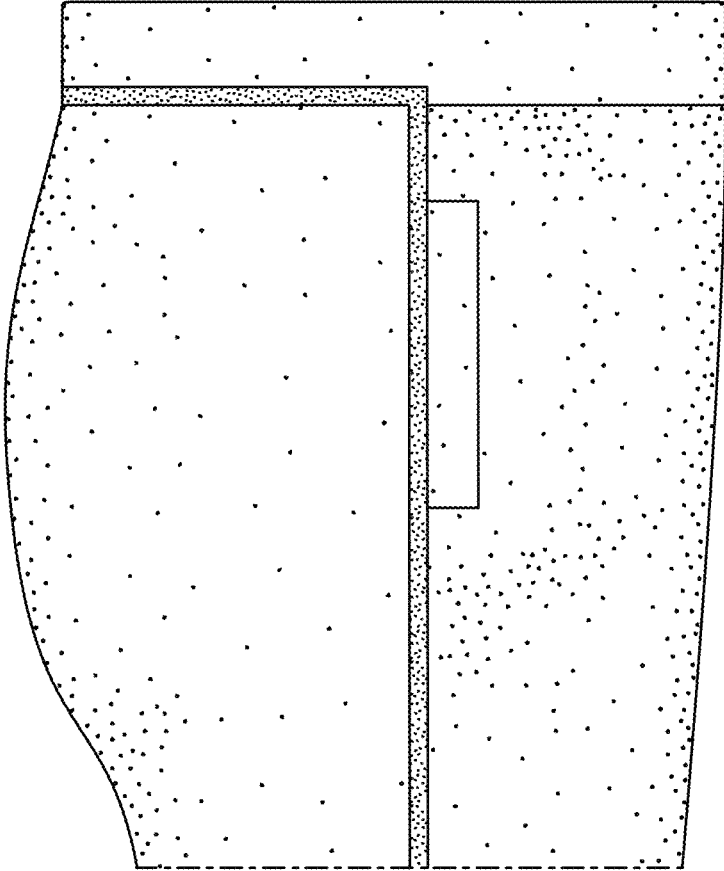

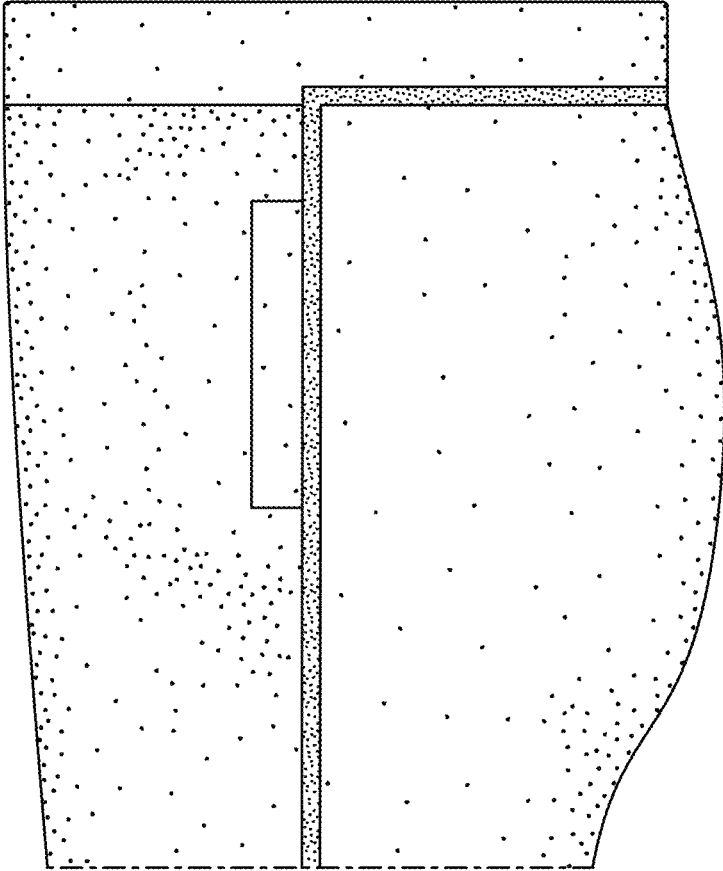

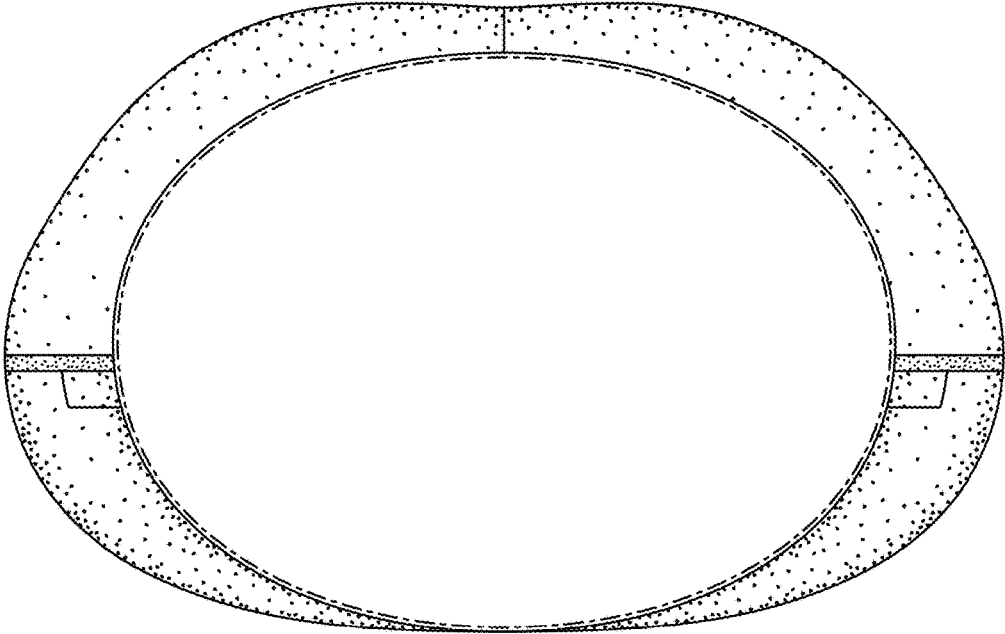

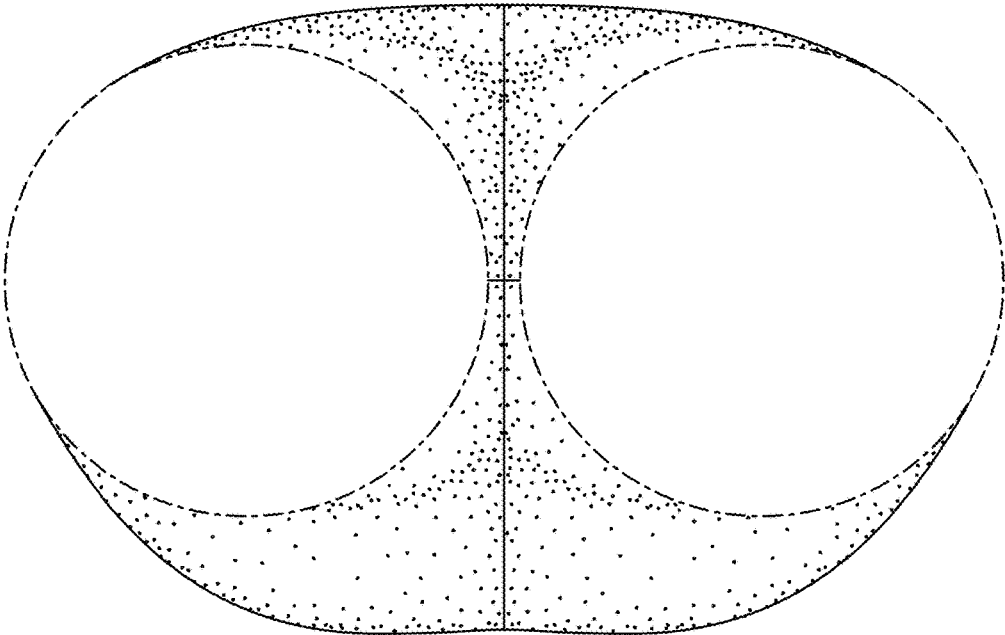
