I claim, the ornamental design for a boot, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a boot, showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 4 is a side elevation view thereof, taken from the left of FIG. 3;

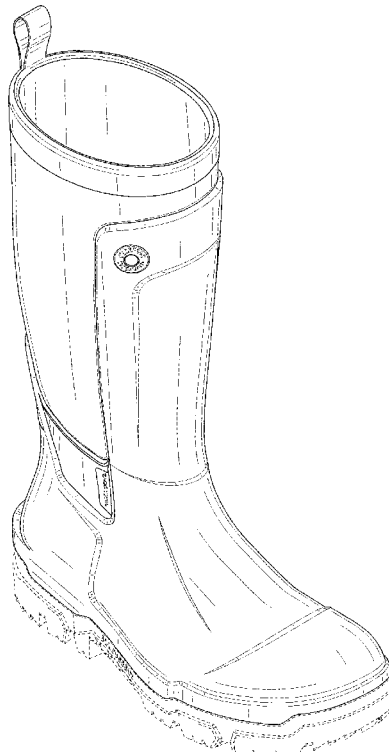
FIG. 5 is a side elevation view thereof, taken from the right of FIG. 3;

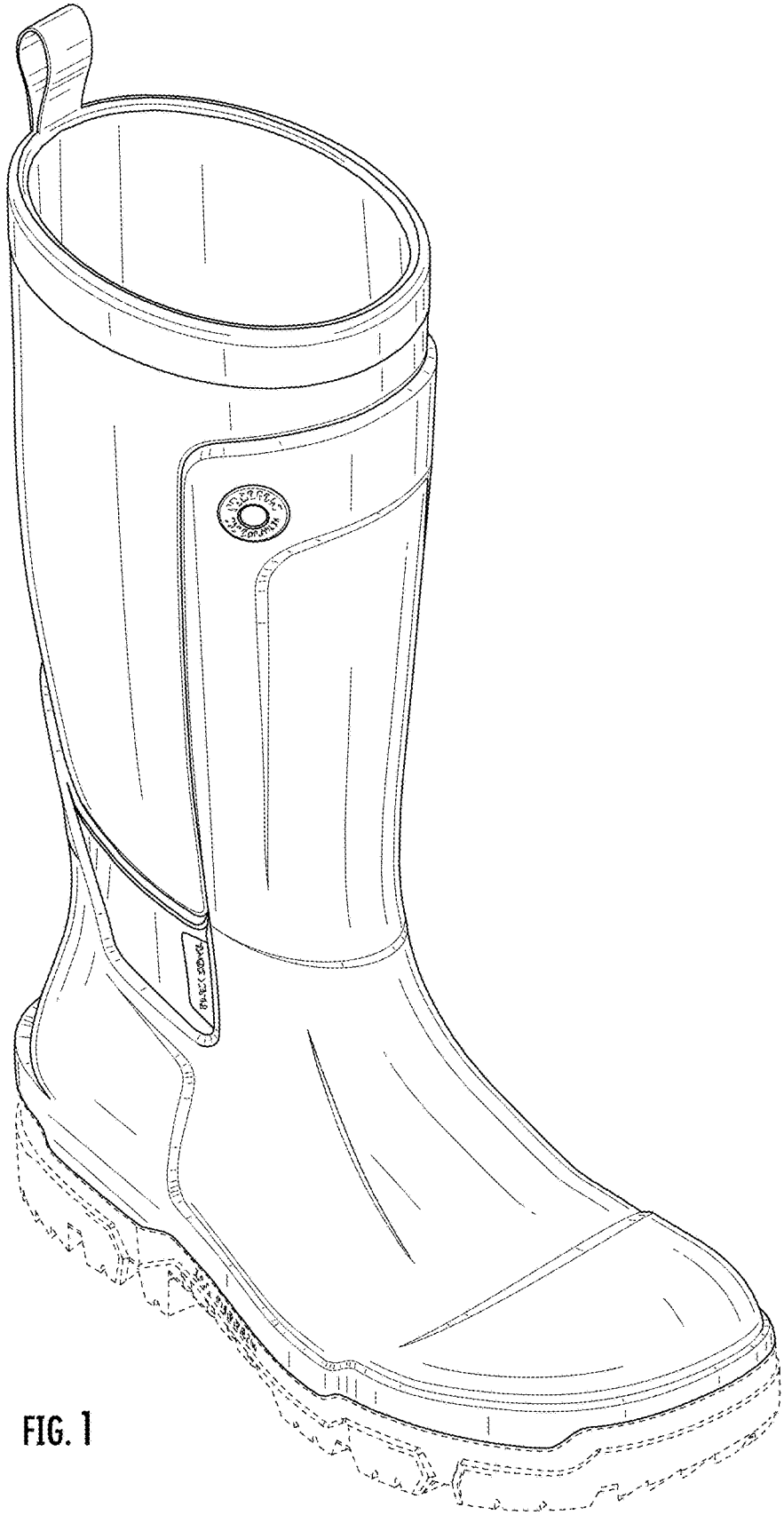

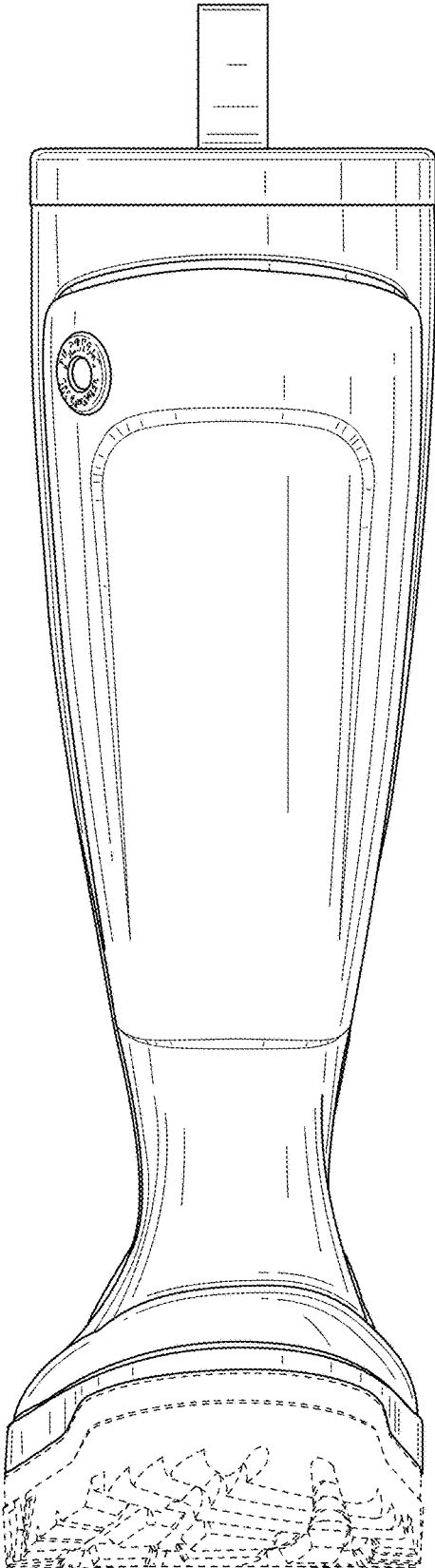

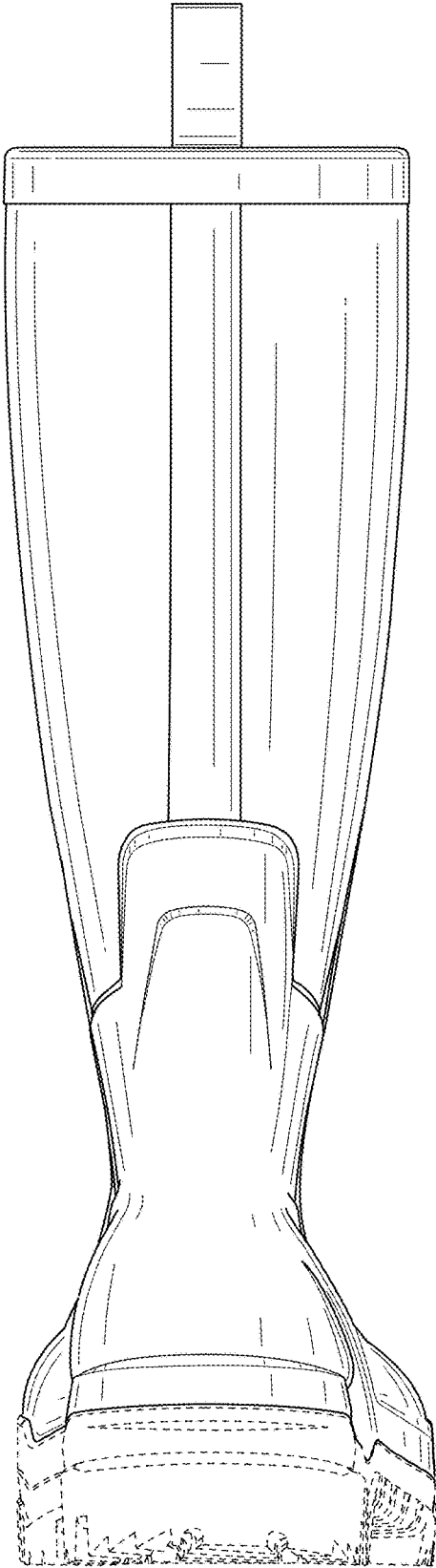

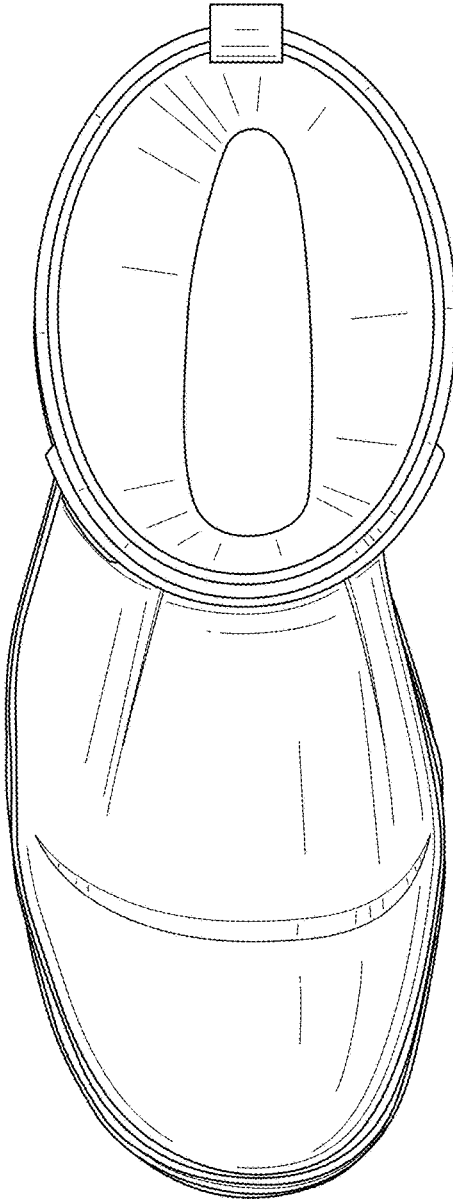
