#### Steps for determining dates for submission of Fifth-Year Interim Reports

- 1. <u>Determine next reaffirmation date</u>. If you are unsure regarding your institution's next reaffirmation date, look up the date by accessing SACSCOC's web page by clicking <a href="here">here</a>. Click on your state on the map of the main page, click on your institution in the list of institutions in your state, scroll down to see "accreditation information" on your institution's page, and looking under "next reaffirmation."
- **2.** <u>Determine if Track A institution or Track B institution</u>. Track A institutions are those that offer only undergraduate degrees; Track B institutions offer graduate degrees.
- 3. Referring to the Charts below, find next reaffirmation date and then follow the timeline for your institution's respective Track.
