

## INTEGRATED POLICY

This document collects the ethical and social principles and values underlying the corporate policy of **Blink S.r.l.** and is aimed at employees, shareholders, customers, suppliers, external collaborators, business partners, and any other person who may act in the name and on behalf of **Blink S.r.l.** which have always been part of the corporate policy of **Blink S.r.l.**

An organization that takes care of the protection of the Environment, Quality, Safety in the workplace, respect for the person, legality, and has as its aim the continuous improvement of its performance in these areas can be competitive and flexible in a constantly evolving current market.

**Blink S.r.l.** carries out periodic (annual) checks to ascertain that the principles set out in this policy are effectively and effectively implemented and respected.

### 1. Quality Policy

The Management of **Blink S.r.l.** undertakes to make available the Economic, Human, and Infrastructural Resources necessary to ensure adequate management of the QUALITY Organizational System. In this task, the management is very clear that the success of its activities passes through the full satisfaction of the Customer, the Stakeholders, and its employees.

## 2. Human Rights Policy and Social Policy

**Blink S.r.l.**, in addition to compliance with the reference legislation to which it is subject in all the Countries in which it operates, is committed to identifying, mitigating and, where possible, preventing potential violations of human rights related to its activities. To this aim, **Blink S.r.l.** declares to:

- undertake to support the protection and protection of human rights and fundamental freedoms according to the principles stated in the Universal Declaration of Human Rights of 1948 and in subsequent international conventions on human rights;
- recognize and respect the principles established by the fundamental conventions of the ILO "International Labour Organization" and specifically the right of the association through the free registration of workers in trade unions, the prohibition of forced and child labor through employment relationships exclusively related to C.c.n.l.
- not tolerate any form of discrimination in the workplace in terms of hiring, pay, overtime, access to training, promotion, termination of employment, or retirement based on race, ethnicity, caste, nationality of origin, religion, different ability, gender, sexual orientation, union membership, political affiliation, marital status, pregnancy, physical appearance, AIDS, or age, or any other applicable basis prohibited by applicable labour and workers' rights legislation.
- undertake not to practice corporal punishment and prohibit degrading treatment, abuse, coercion, and intimidation.
- undertake not to procure material in areas where there are armed conflicts, widespread violence, or other risks of harm to human rights.

**Blink S.r.l.** is committed to supporting the development of the communities where it operates, with the aim of contributing to the economic and social well-being of the area. The Company promotes charitable and solidarity initiatives and provides its contribution and support to projects for the redevelopment of the community's artistic and cultural heritage.

### 3. Commercial, Anti-Corruption, Anti-Bribery and Anti-Money Laundering Policy.

**Blink S.r.l.** undertakes to carry out and conduct its business with the utmost respect for ethical standards, ensuring integrity, transparency, and compliance with applicable laws. To this purpose, the Company declares its commitment to:

- not to practice subordination, corruption, extortion and contribute to the fight against such crimes and unfair practices;
- not to accept payments, gifts, discounts, advantages or promises and/or other utilities that may even be interpreted as exceeding normal commercial or courtesy practices and that may influence the independence of judgment or induce to ensure any advantage or treatment of favor;
- not to carry out transactions and/or operations that may compromise the principles of fair competition and competition or that may constitute an attempt to influence business or decision-making processes;
- avoid conflicts of interest;
- not tolerate money laundering and the financing of terrorist activities;
- apply adequate due diligence that takes into account the risk associated with the counterpart before starting any business relationship and carefully monitor our supply chain and exercise "Know Your Counterpart" activities;
- make known in full and in detail the characteristics of the precious metals sold and ensure the correspondence of weight, functionality, finish and title of their products, ensuring compliance and quality through systematic checks with effective and cutting-edge precision tools;
- adopt adequate systems and measures to ensure the integrity and safety of product shipments as well as to prevent theft, damage, and replacements;
- respect consumer rights by applying fair business, advertising, and marketing practices and by taking the necessary measures to ensure the safety and quality of its products;
- respect the principle of confidentiality and protection of personal data based on current legislation.

### 4. Environmental Policy

**Blink S.r.l.**, aware that the commitment to environmental protection and sustainable development represents an important value of business ethics, undertakes to carry out its activities in full respect of the environment and in compliance with current legislation to have an effective emergency plan in case of harmful consequences for the environment deriving from its activity.

With this in mind, the Company undertakes to responsibly and correctly dispose of the waste produced, to use energy efficiently, and in any case, to minimize the impact of its activities on the environment.

## 5. Occupational Health, Safety and Hygiene Policy

## 6. Security Policy

**Blink S.r.l.** undertakes to protect both its own and others' industrial property. In this regard, **Blink S.r.l.** has prepared special procedures to protect against theft, damage, or replacement of products within its premises and during shipments.
