- is a Canadian television series, each episode of which has either been certified by the Canadian Audio-Visual Certification Office (CAVCO) as a "Canadian film or video production" with a minimum of 8 out of 10 points under the provisions of the *Income Tax Act* (Canada) or is eligible for such certification.
- is an extended reality (XR) project produced in Canada for which at least 75% of the eligible expenses are Canadian and whose underlying rights are sufficiently and meaningfully owned and developed by Canadian citizens as defined in the *Citizenship Act*, or permanent residents as defined in the *Immigration* and Refugee Protection Act.
- I acknowledge that making a false declaration is considered as an event of default for the Corporation and its related parties<sup>1</sup> under Telefilm's policies.
