

# Item 3 Recent developments, challenges and opportunities in sustainable economic diversification

- 3. The Trade and Development Board approved the topic for the current session on 15 February 2023.
- 4. Green technologies provide transformative solutions for countries to diversify their economies in a sustainable manner with cleaner and more efficient production. In the UNCTAD *Technology and Innovation Report 2023: Opening Green Windows Technological Opportunities for a Low-Carbon World*,¹ opportunities presented by the green revolution are analysed and pathways are examined for developing countries to strategically position themselves to seize green windows of opportunity to build a smarter, more inclusive and more sustainable society.
- 5. Responding to the renewed call made by member States at the fifteenth session of the United Nations Conference on Trade and Development (TD/541/Add.2, paragraph 127 (kk)), at the Multi-year Expert Meeting on Investment, Innovation and Entrepreneurship for Productive Capacity-building and Sustainable Development, participants will discuss the opportunities for developing countries to diversify their economies towards sectors associated with lower carbon emissions. Discussions will address what policies, instruments and institutional reforms are needed at the national and international levels to promote more sustainable diversification in developing countries to bring about innovation that is good for people and planet.
- 6. To facilitate the discussions, the secretariat has prepared a background document entitled "Recent developments, challenges and opportunities in sustainable economic diversification".
