

DECLARATION OF COMMITMENT

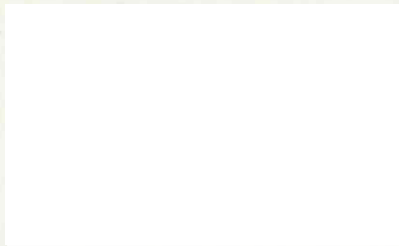
