The National Commercial Agreement requires Producers/Engagers to provide preference of audition and engagement to ACTRA mer	mbers. If a Producer/Engager has made reasonable efforts to comply and has
established that a person who is not a member of ACTRA is required for a Production, an application for a work permit must be made to th	ne local ACTRA office. Where ACTRA is satisfied that the requirements for a work
permit under the National Commercial Agreement have been satisfied, a work permit may be issued. All Canadian non-member Performe	ers, who qualify above, will be issued up to three (3) work permits. ACTRA invites
performers to join ACTRA as Apprentice members with the first qualifying or subsequent two qualifying permits. Additional work permits v	vill only be granted under exceptional circumstances by the ACTRA Branch/Local
and pursuant to the ACTRA Constitution and By-laws.
