# Advocacy & Other Milestones

2005 - 2010 • ASMA worked toward passage of medical liability reform in Alaska to drastically lower the caps on non-economic damages.

• Successfully sponsored an effort to have the Alaska Legislature modify the Advanced Health Care Directive law.

• Assisted with the passage of legislation to increase the number of Alaska seats in the WWAMI medical school from 10 to 20.

• Worked on the Medicare access crisis as part of a coalition of medical groups under the banner of "Alaskans for Access to Health Care."

• Worked with Alaskans for Access to Health Care toward the establishment of a Medicare clinic in Anchorage.

• Medicare clinic funding approved by the Legislature. ASMA participated in site selection and initial staffing.

2011 Alaska Medicare Clinic opened in June and by December had seen more than 1,000 patients.

#### 2012

Partnered with MIEC to provide ASMA members free access to a secure, HIPAA-compliant mobile app, to expedite communication between physicians.

2013 Began offering group purchasing discounts to members through Intalere.

#### 2014

Lobbied successfully for passage of "I'm Sorry" legislation.

## 2015-16

Protected WWAMI funding in Legislature and successfully lobbied for physicianfriendly changes to Prescription Drug Monitoring Program.

# 2017-18

Launched a medical "truth in advertising" campaign on social media, fought back efforts by insurers to eliminate the "80th percentile" rule, and arranged for free MACRA/MIPS Navigator support for ASMA members, sponsored by MIEC.

# 2019

Convinced state officials to exempt physicians from the 72-hour rule, worked to save pediatricians from Medicaid rate cuts, and started a leadership training program for Alaska physicians.

### 2020

Maintained physicians' voice with state health officials during COVID-19 pandemic, disseminated ever-changing information and mandates to the medical community, and organized efforts to distribute much-needed PPE.

# 2021

Continued to support physicians and state public health officials in efforts to provide care and resources combatting COVID-19. Continued support of WWAMI. Successfully worked for passage of "curbside consult" legislation to help preserve the free and open communication among physicians offering expertise in helping another provider care for his/her patients.
