About These Terms And Conditions

In these Terms and Conditions "we" and "us" mean Best Exhaust Pty Limited ABN 70 136 483 460 of Suite 174, M Centre, 11 Palmerston Lane, MANUKA, ACT 2603 Australia, and "you" means you the customer.

These Terms and Conditions together with your Order constitute the entire Contract between us and you for the supply of Products. No other Terms and Conditions will apply. The Contract cannot be varied unless we agree to vary it in writing or by email.

Legal Capacity To Transact

If you are under the age eighteen (18) years you can not place orders with Best Exhaust.

By accepting these Terms and Conditions you acknowledge that you are over the age of eighteen (18) years.

Should Best Exhaust suffer any damage or other losses as a result of a transaction entered into by a minor, Best Exhaust reserves the right to seek compensation for such losses from the parents or guardians of the minor who caused any order(s) to be placed with Best Exhaust.

Placing Your Order

You may place an Order by filling in the Order Form on the Best Exhaust Web Sites and clicking the "Submit My Order" button.

When you place your Order, we will issue you with an Order Number. We will do this by email.

By placing an Order, you make an offer to us to purchase the Products you have selected based on these Terms and Conditions. Information contained on the Best Exhaust website constitutes an invitation to treat. No information on our website constitutes or should be deemed as an offer by us to supply any Products, however Best Exhaust will make every effort to supply Products to you. We will notify you that your order is being processed by sending you an Order Confirmation and tax invoice via email, however, we do not formally accept your offer until your order has passed our internal validation procedures for verifying the bona fides of each order placed, for the purpose of preventing credit card or payment fraud. Best Exhaust and its affiliates reserve the right to refuse service, terminate accounts, remove or edit content, or cancel orders in their sole discretion. We will confirm acceptance of your order when we send you an email confirming shipment of the goods you have ordered. If we cannot process or accept your Order after payment is received we will contact you by email or telephone.

Payment Methods And Processing

Best Exhaust currently accepts Credit Cards (including Mastercard, Visa, American Express), PayPal, Bank Deposit / Transfer and cheque only. Best Exhaust reserve the right to surcharge for payment methods that incur a cost to Best Exhaust.

Order processing will not begin until we receive all the information we need.

Orders placed on a weekend or a Public holiday may not begin processing until the next business day.

Business days are Monday through Friday (Canberra, ACT, Australia time), excluding ACT Public holidays.

We process credit card payments up to 48 hours after you click the "Submit My Order" button, and all payments will be charged in Australian dollars.

Where you pay by Bank Deposit / Transfer you must pay the price payable in Australian dollars as indicated on your Order Confirmation within 7 days from the date that you receive your Order Confirmation.

If a Bank Deposit / Transfer payment is not received within 10 days from the date that you receive your Order Confirmation, Best Exhaust reserves the right to cancel the transaction.

For credit card payments we will email a tax invoice to you with your Order Confirmation. Where you pay by Bank Deposit / Transfer a tax invoice will be sent to you via email after your payment has been confirmed. Your tax invoice is your proof of purchase.

Please Note:

- Debit cards and cheque cards have daily spending limits that may substantially delay the processing of your order.
- You may be required to provide further identification for additional security reference checks.

Prices

Best Exhaust always seeks to list Products with the most competitive prices.

Best Exhaust reserves the right to change prices for Products displayed at Best Exhaust at any time.

Published prices include Australian import fees and duties as well as delivery to you. For deliveries outside Australia, published prices may not include taxes, duties or import fees. Best Exhaust is not responsible for taxes and customs fees and duties outside of Australia.

Supply Of Your Products

Subject to these Terms and Conditions, we will supply to you the Products indicated on your Order Confirmation.

When your Order items have been dispatched, we will email you to confirm shipment of each item including a tracking number for each item.

Unless otherwise specified, products we supply are for offroad-use only, and are not compliant with Australian or New Zealand Design Rules for road registered vehicles. Products that claim to be road legal or EEC Homologated may be suitable for road use, but the customer accepts the risk that the product may not be suitable for their specific purpose.

Delivery Of Your Products

Delivery time takes up to 10 working days from the date your payment is received. Please note that Bank Deposit / Transfer payments take 1-2 business days to process. Express delivery is available at additional cost.

Product listings will indicate whether the item is "In Stock" in Australia or "Not in Stock – Available for Order" where the item is not in stock in Australia, but is available for order from the manufacturer. For availability details and timeframes, please use the "When can I get it?" button on the product page.

Where you have purchased a Product that is dispatched from the manufacturer, delivery time after payment processing may take up to 3 weeks in addition to delivery time.

In all instances estimated delivery times will be displayed at the check out for your Product.

Best Exhaust makes every effort to deliver your Product according to the estimated delivery times provided by Best Exhaust at checkout. The estimated delivery times are in business days (Monday through Friday) excluding Public holidays.

Although every effort is made to ship your Order according to the estimated delivery times provided, estimated ship times may change due to changes in supply or circumstances beyond our control. If your Product has not arrived after the estimated delivery time, please contact us [here](#)

We encourage you to visit the "My Account" section on our website to view the delivery status of your Products.

Unless otherwise agreed by us, we will deliver your Products to the address indicated on your Order Confirmation or if paying by PayPal, to the registered PayPal address. If no-one is available to take delivery of your Products, our carriers (FedEx, UPS, TNT or DHL Express) will leave a card so you can arrange alternative delivery or pickup from the local depot.

We will use our reasonable efforts to deliver your Products to you within the estimated delivery time indicated on your Order Confirmation; however, we do not guarantee that we will deliver within this time frame.

Title and risk of loss to all Products will pass to you on delivery. All orders are insured for loss or damage during delivery.

Returns and Refunds

At our discretion, we may agree to returning a new or as-new item for a refund.

If you wish to return the goods due to change of mind or due to unsubstantiated fault, a 25% or \$750 restocking fee (whichever is more) will be charged against the refunded purchase price. Any refund will only be given after the goods are returned and assessed to be in resalable condition. Any damage or wear that is found will be debited from the balance of the refunded amount. Cleaning fees may apply.

Returns due to Warranty will be handled as per the manufacturer warranties' terms and conditions. Best Exhaust will attempt to act for you in this situation, but is not responsible for fulfilling the manufacturers' warranty obligations.

Best Exhaust does not store card details, and destroys any details upon completion of payment processing.

Best Exhaust utilises Commonwealth Bank and PayPal credit card payment processing, with American Express integration, and Best Exhaust will not be responsible for any damages, consequential losses (whether direct or indirect) suffered by a customer whose credit card is fraudulently used or is used in an unauthorised manner due to failure of Commonwealth Bank, PayPal or American Express system security measures, or any other occurrence outside the control of Best Exhaust.

No Best Exhaust employee or agent has the authority to vary any of the Terms and Conditions governing any sale.

Force Majeure

Governing Law

These Terms and Conditions shall be governed by and construed in accordance with the laws of the Australian Capital Territory and shall be subject to the non-exclusive jurisdiction of the courts of the Australian Capital Territory.
