Effective for stamp purchases made after January 9, 2014

SECTION 1: Handstamps

- LINE 1. Enter the number of packages of cigarettes for which stamps are being purchased.
- LINE 2. County and City tax rate.
- LINE 3. Tax due (Multiply line 1 by line 2).

SECTION 2: Machine rolls (Multiples of 30,000 only)

- LINE 4. Enter the number of packages of cigarettes for which stamps are being purchased.
- LINE 5. County and City tax rate.
- LINE 6. Tax due (Multiply line 4 by line 5).
- Line 7. Total Amount Paid (Add line 3 and line 6).
