This year, we marked our 60th Anniversary with a memorable Masquerade Gala that united CRT board members, staff, elected officials, donors and supporters. It was truly a wonderful night of celebration, underscoring the strength and unity of our community.

We were honored to receive proclamations and congratulatory letters from elected officials including the Governor, Lieutenant Governor, Hartford Mayor, Middletown Mayor, Senators and Representatives from our great state. These elected officials have been our partners in advocating for socio-economic programming, ensuring that all Connecticut residents, including seniors, veterans, children and families, have access to essential services such as early education, housing support, behavioral health and more.

Our legacy is robust, built on decades of programs that address the diverse needs of our community. It is a history that gives us the right and responsibility to offer bold innovative solutions to some of our communities most pressing problems. This year, we proudly opened the doors to The McKinney, a newly renovated men's shelter in a former hotel. It is an innovative approach to housing the homeless, we provide a dignified and personal environment, complete with on-site behavioral health services, medical support, GED programs, and employment search assistance. The positive impact on our clients has been tremendous.

CRT has expanded our community partnerships significantly. We forged valuable relationships through our Center for Healthy Families, partnering with pediatric offices to better reach the youth population, providing essential behavioral health services to address their needs. Our partnership with the Justice Education Center transforms the lives of young people by providing them with valuable experiences on a farm, teaching them economics and life skills. We will persist in enhancing our community partnerships to deliver services that change lives and create opportunities for decades to come.

This year, we faced a significant challenge when CRT's elderly nutrition budget was slashed by 30 percent. Thinking outside the box, we launched Windsor Street Kitchen catering business, a social enterprise designed to generate revenue. We hope that all our partners in the community will support this business. We will serve delicious food for all types of meetings and events. All proceeds from this venture will go directly back into our Elderly Nutrition Program, Meals on Wheels. CRT is committed to finding ways to persist in bringing services to those who need them most.

We are committed to building upon the foundation established over 60 years ago, ensuring that we continue to provide vital support and advocacy for our community. Thank you for being an integral part of our journey. Together, we can make a meaningful difference in the lives of those we serve.

From Shadows to Shelter

Peter's journey off the streets

Peter K. stood hesitantly outside the doors of **The McKinney**, his heart heavy with reluctance. After an exhausting eight-year battle with non-Hodgkin's lymphoma, he felt defeated and alone, grappling with not only the aftermath of his illness but also the weight of overwhelming medical debt. Having lost his home and employment, he found himself in a spiral of addiction to the pain medication doctors prescribed to get him through his treatments to save his life.



"I thought about giving up entirely," Peter recalls, "When every day is about surviving the night, you don't truly understand that struggle until you live it." Living in his car, and eventually on the streets, Peter faced a bleak reality, but something deep inside him pulled him to seek help.

Upon stepping into The McKinney, Peter was greeted not just by staff but by a community dedicated to transforming lives.

The McKinney is not merely a place to sleep; it's a sanctuary that offers dignity, and a comprehensive array of services tailored to help men reclaim their lives. It is a refuge.

At the shelter, Peter discovered a world of support that included CRT's **Behavioral Health Services**, an on-site medical clinic, case management, and counseling – all designed to help him regain

control of his life. With renewed motivation Peter met regularly with his case manager and began to set personal goals. As part of the comprehensive care at The McKinney, CRT has partnered with Community Health Center to bring a mobile health unit to the underserved population on a weekly basis. Peter takes advantage of their mobile medical unit as part of his effort to regain control of his health after many years of neglect due to his unstable living situation.

One of the most recent turning points for Peter was securing employment with the help of a CRT case manager. "The services at The McKinney were the key to crossing the bridge to independence for me," Peter states, his determination shining through. Peter utilized the services at The McKinney to prepare a resume and successfully apply for the job. Peter walked into his interview not only armed with a resume but the restored confidence he needed to successfully land employment.

As he embraced the resources available to him, Peter began to see a future. With the help of CRT's comprehensive services, he is rebuilding his self-esteem and confidence. The transformation is palpable; he is no longer just a man in need; he is a man with a purpose.

Today, Peter stands as a testament to triumph over adversity. His journey at The McKinney embodies the resilience of the human spirit and the profound impact of a supportive community. When he arrived at The McKinney he was "dirty, tired and hungry." Now he is slowly regaining his dignity and working toward a brighter future where he can give back to others. With the help and support of CRT, he is focused on securing permanent housing and achieving the dream of having a place to call home, where he can also give back to others in need.

CRT partners with Community Health Center to offer on-site mobile health services to underserved populations including at The McKinney and CRT's Multi-Service Center. Here clients are provided with services to help them achieve overall well-being and begin to lead healthier lives.

A Veteran's Resilience

Joe's triumph over setbacks

CRT collaborates with the Department of Veteran's Affairs (VA), the CT Department of Correction (DOC), and connects every Veteran with the VA for additional services.

Joe, a Navy Veteran, faced a series of challenges that led him to a difficult situation: homelessness. After his divorce, he found himself “couch surfing,” relying on the hospitality of friends as he grappled with the weight of child support obligations. There just wasn’t any money left for him to find housing.

Working part-time at the Department of Social Services, Joe endeavored to make ends meet. Despite his dedication, the financial strain left him with little to cover basic living expenses, let alone secure a safe place to call home. The burden of his circumstances compounded his health struggles, prompting him to reach out for assistance.

Through the encouragement of the Veteran’s Administration, Joseph connected with the Community Renewal Team. CRT offered him a lifeline by providing bridge housing at **Veteran’s Crossing**, a supportive community designated specifically for homeless Veterans. Feeling settled and in an environment with other Veterans, gave Joe a sense of belonging. While at Veteran’s Crossing Joe enrolled in CRT’s **Supportive Services for Veterans Families Program (SSVF)** Program, which helps Veterans find and pay for more affordable housing.

Joe was paired with a CRT Case Manager who, being a Veteran himself, understood the complexities of Joe’s situation. This knowledgeable mentor helped him navigate the processes involved in accessing essential services and facilitated his transition into a more stable housing arrangement and fulfilling life. With CRT’s Case Manager’s extensive connections, Joe secured his own apartment and received guidance on navigating various services including medical and mental health resources.

A year after Joe walked through the door at Veteran’s Crossing, he continues to work with his CRT Case Manager, benefiting from ongoing support and guidance.

With the stability of a safe and comfortable home, Joseph could finally invite his three children over, fostering a nurturing environment for them to reconnect. The anxiety and stress he had experienced during his period of homelessness began to dissipate, allowing him to focus on rebuilding his life. This newfound sense of security significantly improved his work performance and overall mental health. “CRT made it possible for me to get my life back on track.”

As Joe transitioned from part-time to full-time employment, he found himself in a better financial position. He was now able to save money and invest time in enriching his relationship with his children. “I was exhausted and stressed all the time, working a second job, living on a couch. CRT took that away!”

Today, Joe, a Navy Veteran, stands as a proud example of resilience and gratitude. He knows the power of community and is working hard to build a better life for himself and his children.

Kaden's transformation from reluctant learner to leader

CRT served **27,667** families

Every Saturday morning, for the entire school year. September through June, Kaden Mahdi faced a struggle, the reluctance to leave the comfort of his bed and head to a rural farm. Initially, he didn't fully grasp why his parents insisted he participate in this program especially when his friends in the program began to miss weeks.

CRT served **17,443** children

Kaden is part of CRT's **Project Moo**, a collaborative initiative between the Justice Education Center, Community Renewal Team, and Auerfarm that offers inner-city youth the chance to experience farm life. This program provides a fun and interactive environment where participants learn about farming, the benefits of crops, and the economic aspects of agriculture in Connecticut.

Through hands-on activities, Kaden learned valuable lessons about teamwork, responsibility, and the importance of following through with commitments. "He didn't always want to get up on Saturdays, but that's when discipline outweighs motivation," shared Kaden's mom. Since joining CRT, she has noticed significant improvements in his self-discipline.

His parents were eager to find activities that would engage Kaden positively amidst his teenage challenges. They believed that the benefits of Project Moo would outweigh his initial reluctance. Each Saturday, Kaden returned home with a newfound sense of achievement and satisfaction, showcasing the enriching impact of the program on his life.

The activities allowed Kaden to shift his focus from excessive video gaming and sibling disputes to meaningful experiences that enhanced his personal growth. His parents are grateful for the program and the positive changes they've witnessed in him.

This year, Kaden is taking the involvement to the next level by returning to CRT's Project Moo as a Peer Support Assistant. In this leadership role, he will assist other youth, serving as role model and guide. His commitment unwavering, he now attends every Saturday without complaint, embodying the leadership qualities he has developed through the program.

Heartfelt Appreciation

The generosity of our donors (monetary and in-kind) continue to play a crucial role in transforming lives and fostering opportunities within our community. This year, we have been able to provide essential resources and services that empower individuals and families to overcome challenges.

The numbers speak volumes. This year CRT provided 250 Thanksgiving meals and distributed 900 holiday gifts to children in CRT's programs, including CRT's **Early Childhood Education Center**. One of the parents at CRT's Ritter Center expressed her gratitude, "I am so thankful for the gifts for my children. I am struggling financially, and my children were able to receive more than I can provide."

Additionally, CRT distributed 4,500 winter coats and other apparel, providing essential warmth and protection to those facing harsh weather conditions. We gave over 3,000 pairs of socks to homeless clients at CRT's shelters, **East Hartford Shelter**, **The McKinney and CRT's HEARTeam** and other outreach programs, offering comfort and relief to unhoused people. We delivered more than 200 care packages to seniors at CRT's **The Retreat** and **Behavioral Health Services** clients, showing them that their well-being is of the utmost importance.

Several local businesses and corporations participate in CRT's Corporate Volunteer Days, giving employees an opportunity to engage in community service, build teamwork, and make a meaningful impact while reinforcing their company's commitment to social responsibility. While at CRT, Volunteer groups of 3 to 30 people take on various projects, including assisting in the Elderly Nutrition Kitchen, painting building exteriors, gardening during the spring, completing outdoor cleanup in the fall and more!

Every donation, whether financial or in the form of time and resources, has contributed to a ripple effect of positive change. Together, we are not just providing aid; we are creating pathways to opportunity, dignity, and hope.

Socktober The 7th Annual “Socktober” is a “kid-inspired” community event hosted by Glastonbury Newcomers’ and Neighbors’ Club that teaches compassion and kindness. Local children collected 4,000 of pairs of socks for men, women and children at CRT’s homeless shelters.

Thanksgiving Dinner Donations Several community groups donated the makings of Thanksgiving meals for our clients. The meals included turkeys, non-perishable items for all the side dishes, cooking tins, paper goods, juice, and rolls.

The Hoffman Family Foundation Presented CRT with funding to provide 200 CRT families with gift cards to put food on their table for the holiday. This generous donation is a blessing for our clients who struggle during this time of year. This holiday season, our clients don’t have to worry about choosing between a delicious holiday dinner or toys for their children.

Toys for the Holidays We provide opportunities for our clients to have a joyful holiday, even during financially challenging times. Donated toys fill the shelves of the CRT “Toy Store” in the Women’s Empowerment Center at 330 Market Street, where CRT clients are invited to have a holiday shopping experience and select presents for their children. Toys and other presents are put on tags on the CRT Giving Tree, where donors sign up online to donate and brighten up the holidays for children throughout CRT’s programs.

McKinney Shelter Ribbon Cutting CRT proudly opened the doors of The McKinney for a Ribbon-Cutting Event. The 80 bed shelter, formerly the Days Inn Hotel, has undergone extensive renovations to provide a safe and welcoming environment for men experiencing homelessness.



Back to School Events CRT's East Hartford Shelter and Generations Campus held back-to-school events for families to help them kick off another successful school year. Donated backpacks and school supplies were distributed, and the kids had a blast!



Generations Campus Summer Camp (Six Flags)

CRT's Generations Program's Summer Camp provided weeks of fun and adventure for the children. Campers enjoyed a trip to Six Flags New England, crafts, and daily activities all designed to keep the children busy over the summer.
