Eligibility:	This is a cooperative purchase contract that can be extended to political subdivisions, counties, school districts counties and municipalities.
	State agencies shall be defined as all departments, divisions, offices, universities, vo-tech schools, boards, commissions, etc. Political subdivisions are defined as all local and regional governmental and tax supported organizations, which operate independently of the state, such as police juries, cities, towns, councils, hospitals, etc.
	A listing of <u>state agencies</u> and <u>approved cooperative participating entities</u> for Louisiana (not all inclusive) is available.
	John Deere dealers must appear on the State's authorized distributor list in order to utilize this contract.

Quotes and Purchase Orders:

Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local John Deere Dealer. Submit your purchase order to the dealer. The John Deere Dealer will submit the purchase order to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Contract Details

Delivery Obligations

All electric units must have fully charged batteries at time of delivery. All gas or diesel units must have a full tank of fuel at time of delivery.

Remove all dealer identification or dealer advertising from the equipment prior to delivery. The vendor shall also service and adjust the equipment to include as a minimum the following:

- Focusing of lights.
- Tuning of engine.
- Adjustment of accessories.
- Checking of electrical, braking and suspension systems.



	 Charging of battery(ies). Alignment of front end. Inflation of tires. Balancing of all wheels, including the spare. Complete lubrication of engine, chassis and operating mechanisms, with recommended grades of lubricants for the ambient temperature at the point of delivery. Appropriate additives.
Fees	Waste Tire Fees must be included on the quote or purchase order <u>as a separate line item</u> for utility vehicles (including ProGators – 2020A, 2030A) sold on this contract. Utility Vehicles (including ProGators) - \$2.25 per New Tire

Manuals	An operator's manual is included with the delivery of the equipment at no charge.
	One technical manual must be provided at no cost to the agency. The manual must appear as a separate line item on the quote and/or purchase order in order for the dealer to be reimbursed.
Miscellaneous	The agency must not be charged the title fee for the utility vehicle. John Deere will reimburse the dealer for the title fee. The dealer is still responsible for registering the title.
