<p>Delivery Obligations</p>	<p>Remove all dealer identification or dealer advertising from the equipment prior to delivery. The vendor shall also service and adjust the equipment to include as a minimum the following:</p> <ul style="list-style-type: none"> • Focusing of any lights. • Tuning of engine. • Adjustment of accessories. • Checking of electrical, braking and suspension systems. • Charging of battery. • Inflation of tires. • Complete lubrication of engine, chassis and operating mechanisms, with recommended grades of lubricants for the ambient air temp at the point of delivery. • Servicing of any cooling system with permanent type antifreeze and summer coolant for MINUS 20 DEGREES FAHRENHEIT protection. <p>Check all belts and blades on mowers for correct tightness.</p>
