## 2. **General objective**

To ensure the implementation of the Black Sea JDP 2023, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex II of the implementing Decision (EU) 2018/1986.

## 3. **Summary of activity**

This report is a statistical snapshot of JDP activity between January and March 2023 (quarter 1).

In total, there were 19 inspections carried out at sea resulting to 4 suspected infringements, and 291 land inspections carried out with 2 apparent infringements reported in 2 inspections. In addition, 8 sightings were reported by the Member States.
