## **BIDDING PROCESS 1/2023**

The administrative committee of the Embassy of Brazil in Kathmandu shall conduct a bidding process for the sale of one (1) of its vehicles, according to the following terms and conditions.

- 1. This bidding is open to participation from any person and/or legal entity, except for Embassy of Brazil staff and their relatives, provided the participant follows all conditions stated bellow.
- 2. The vehicle is offered as it is, and no further repairs or alterations shall be provided by the Embassy prior to or after the vehicle's delivery. Interested applicants are welcome to inspect the vehicles before submitting an offer. Inspections can be scheduled by calling the Embassy at (1) 4721-462/463 upon appointment.
- 3. The vehicle is currently registered to the Embassy of Brazil (blue plate) and, upon approval of the sale process by the Ministry of Foreign Affairs (MOFA), the buyer will be solely responsible for all necessary clearances and bureaucratic procedures deriving from the purchase, including the payment of duties and taxes (if applicable).
- 4. Participants must submit their offer by sealed letter to the Embassy's address (Chun Devi Marg, H 155, Marahajgunj, Kathmandu, Nepal); or via e-mail to brasemb.katmandu@itamaraty.gov.br, with the following information: participant's full name, address, phone number, e-mail address, and value of the bid, to be stated in Nepalese Rupees (NPR) both in numerals and in full words.
- 5. Bids may be submitted until 18th January at 12:00pm. Bids submitted later than that will be disregarded.
- 6. On 18<sup>th</sup> January at 15:00pm a public session will be held at the Embassy's premises for the disclosure of the proposals, for which all interested parties may be present or send a representative. Social distancing regulations should be followed, to avoid mass gatherings. The bids will then be ranked from highest to lowest and the winner shall be declared to be the highest bidder. In the case of a tie, the winning bid will be the one that was submitted first.

- 7. The highest bidder will be immediately notified by the Embassy of the result by phone and/or e-mail and will have a period of fifteen days to transfer the funds to the Embassy's bank account in Nepal. If the winning applicant fails to fulfill this requirement, it will be disqualified, and the vehicle will be offered to the next highest bidder.
- 8. Delivery of the vehicle can be immediate once the Embassy gets payment confirmation.
- 9. By submitting a bid, applicants declare that they agree with all conditions stated on this term.
- 10. All unforeseen situations not covered in this document shall be arbitrated by the Embassy's Administrative Committee.
