Dates and venues of upcoming meetings of the Board

Summary

This document has been prepared to assist the Board in confirming the dates for the thirtysixth meeting of the Board.



I. Introduction

1. This document has been prepared to assist the Board in confirming the dates of its thirty-sixth meeting (B.36).

II. Dates for upcoming meetings of the Board

2. By decision B.32/12, paragraph (d), the Board decided that the thirty-sixth meeting of the Board (B.36) will take place from Monday, 10 July to Thursday, 13 July 2023.

3. Paragraph 17 of the Rules of Procedure of the Board provides that at each meeting, the Board will confirm the date and duration of the following meeting. It is recommended that at B.35, the Board confirm the agreed dates for B.36.

III. Offers to host a GCF Board meeting

4. By decision B. 34/24, the Board decided and confirmed that B.35 will take place from Monday, 13 March to Thursday, 16 March 2023 in the Republic of Korea. This was on the understanding that Rwanda would host B.36 from 10 to 13 July 2023. The Secretariat conducted a technical assessment in Rwanda and has since signed a privileges and immunities agreement with the Government of the Republic of Rwanda. However, due to other international events taking place in Rwanda in 2023, the country will be unable to host any Board meeting this year, unless the previously agreed dates were changed, which is not possible. Thus, the Government of Rwanda, through email correspondence, expressed its interest in hosting B.38 in 2024.

5. In 2021 and 2022, the Secretariat had received expressions of interest from the Governments of Mongolia and Tajikistan to host Board meetings in 2022. The Government of Mongolia expressed its interest through a letter signed by the Director-General of the Mongolian Climate Change Department, Mr Enkhbat Altangerel, dated 4 October 2021, which was communicated to the Board at B.30, and is appended in annex IV. In addition, the Government of Tajikistan expressed interest in hosting a Board meeting in 2022 on the margins of the Second International High-Level Conference on the International Decade for Action — Water for Sustainable Development, 2018–2028, in Dushanbe through a letter signed by H.E. Sirojiddin Muhriddin, the Minister of Foreign Affairs of Tajikistan, and dated 25 November 2021, appended in annex V.

6. The Secretariat contacted both governments to check whether their offers to host Board meetings were still valid. The Government of Mongolia confirmed its interest in hosting B.37 from 23 to 26 October 2023, and the Government of Tajikistan confirmed its interest in hosting either B.36 from 10 to 13 July 2023, or B.37 from 23 to 26 October 2023.

IV. Recommendation

7. Given the short timeframe to enter into an agreement with the Government of Tajikistan, it is recommended that the Board confirm the dates of 10–13 July 2023 for B.36 in the Republic of Korea, by adopting the draft decision in annex I.

<u>Re</u>: Expression of interest to host the Thirty Third Board Meeting of Green Climate Fund (GCF) in Rwanda

On behalf of the Government of Rwanda, I have the honour to express the Rwanda's interest to host the 33rd Board Meeting of the GCF planned for 2022. Hosting of the GCF Board meeting woud be a great opportunity for Rwanda to echo the commitment of developing countries to implement the Paris agreement but also underscore the significance of building national capacities to access the available climate finances. Rwanda become the first African Country to update its Nationally Determined Contribution to Paris Agreement as a demonstration of the committment to combat the impacts of climate change.

Rwanda was among the first developing countries to have a government institution (The Ministry of Environment) accredited for direct access to the GCF. In addition to this, Rwanda has a track record of successful hosting of regional and international meetings, all attributed to the government commitment of delivering quality services, availability of state of the art conference facilities, assured security and above all, the Rwandan hospitality. Furthermore, since January 2018, nationals of all countries in the world, can receive their visa upon arrival at Kigali International Airport and all land borders which makes travelling to Rwanda much easy. We should also mention that major airlines (such as KLM, SN, Qatar, Turkish, Ethiopian, Rwandair, Kenya Airways, etc) are connecting Kigali to different cities in the world.

Among the hosted meetings we can mention the Regional Workshop for Africa on Nationally Appropriate Mitigation Actions in August 2015, the 10th Africa Carbon Forum in June 2016, the 28th Meeting of Parties to the Montreal Protocol which ended up with Kigali Amendment in October, 2016 and the 10th Extraordinary Summit of Africa Union in March 2016, Africa Green Growth Forum in 2018 and the upcoming CHOGM June 2022 among others. We are therefore, confident that our country has sufficient capacity to make the Board meeting very successful.

We look forward to your highest consideration of this request.

For the past two decades, Tajikistan, alongside with international community, has been actively promoting water issues worldwide, thus becoming a strong advocate of this vital cause. Eight water-related United Nations General Assembly's resolutions, two international years, and two international water decades initiated by Tajikistan are the testimony of our productive and fruitful cooperation with all UN member states and other stakeholders. As you are aware, water and climate are inextricably linked, as climate change affects our lives and our economy mainly through water resources. Unfortunately, we observe accelerated ice melting in various parts of the planet - in the Arctic, Antarctica and Greenland. The glaciers in Tajikistan are melting rapidly. To date, more than 1,000 of Tajikistan's 13,000 glaciers have completely melted. Over the past few decades, the total volume of glaciers in our country, which make up more than 60% of the water resources of the Central Asian region, has decreased by almost a third. Given the serious consequences of continuing this process, Tajikistan has previously proposed proclaiming 2025 as the International Year for Glaciers Preservation and setting a date for World Glaciers Day. In this regards we have also working with United Nations for the creation of the International Fund for Glaciers Preservation.
