Agenda item 16: Updated Strategic Plan for the GCF 2024-2027

Background: Following B.34 decisions and adoption of an ad referendum draft, a DRF.01 of the Strategic Plan 2024-2027 was released for Board consultation between 24 December 2022 – 27 January 2023. A comments response matrix was prepared by the Secretariat and circulated to the Board in advance of a hybrid Board Workshop held in Paris on 1 March 2023. During the workshop the Board engaged in sequence on the main chapters of DRF.01, covering an in-depth overview of comments received and responses on the document structure, long-term strategic vision and mid-term goals, strategic programming objectives and the operational and institutional priorities. The workshop began outlining main areas of convergence and divergence, with the CCs also introducing a timeline of key milestones towards B.36.

B.35 discussions on this item will be based on: a CC summary of discussions in Paris, an updated comments response matrix and the timeline introduced in Paris. B.35 is expected to



lead to further focused interventions on key areas of convergence and divergence to inform preparations of DRF.02.

Background: At B.34, the IRM submitted a compliance review report for IRM Case C-0006-Nicaragua relating to FP146 "Bio-CLIMA: Integrated climate action to reduce deforestation and strengthen resilience in BOSAWÁS and Rio San Juan Biospheres." The compliance report contains findings and recommendations following the IRM's compliance investigation into issues raised in the complaint: (i) conflict between non-indigenous settlers and indigenous and Afro-descendant communities, (ii) informed consultation and free, prior, and informed consent (FPIC), and (iii) the usurpation of lands of indigenous communities and restrictions to access natural resources. By decision B.34/23 the board decided to:

- (a) Take note of the findings and recommendations presented by the Independent Redress Mechanism in document GCF/B.34/15 ("Compliance Review Report");
- (b) Further consider the Compliance Review Report at its thirty-fifth meeting in order to take an informed decision on this matter;
- (c) Request, for the purposes of taking an informed decision on the Compliance Review Report at its thirty-fifth meeting pursuant to paragraph 63 of the Independent Redress Mechanism's procedures and guidelines, the Secretariat to provide for the Board's consideration: (i) A management response from the Secretariat in respect of the Compliance Review Report, annexing any relevant written comments provided by the relevant accredited entity; and (ii) A legal assessment on any potential action, including remedies, which GCF may take under the related funded activity agreement, based on the information provided in the Compliance Review Report;
- (d) Confirm that the Independent Redress Mechanism and Secretariat may share the Compliance Review Report with the relevant accredited entity on a strictly confidential and redacted basis in order to allow for the accredited entity to provide any relevant written comments, and for the accredited entity to share the Compliance Review Report with the executing entity in order for the executing entity to provide its written



comments to the accredited entity, and for the Secretariat to consult with the accredited entity when preparing its management response;

- (e) Take note of the interlinkages between the findings and recommendations of the Compliance Review Report and the conditions set out in decision B.27/01, annex I (List of conditions and recommendations) in respect of FP146; and
- (f) Request the Secretariat to temporarily suspend its review of the Monitoring Framework provided by the accredited entity in connection with the Board conditions until the Board has further considered and taken a final decision on the Compliance Review Report.
