The Administration for Children and Families (ACF) will host the annual **Tribal Consultation** meeting on **Wednesday**, **September 18**, **2024**, from **1:00-4:30 EDT**. During the meeting, ACF leadership will provide updates on program and regulations concerning Native children and families and be available to discuss issues of importance to Tribal leaders.

Agenda Planning:

The final agenda for the ACF Tribal Consultation will be developed through planning calls with tribal leaders. I invite you or a representative to participate in these calls to identify specific topics of interest for discussion.

Below is a list of potential topics for discussion at the ACF Tribal Consultation based on previous engagement with tribal leaders and program administrators and Administration priorities.

- Processes for 477 integration across ACF programs.
 - Public Law 102-477, known as the Indian Employment, Training and Related Services Demonstration Act (25 U.S.C. 3401 et seq), was established to enhance the ability of federally recognized tribes and Alaska Native entities to address

their employment and training needs. The primary intent of the 477 program is to streamline and consolidate various federal grant programs related to employment, training, and related services into a single, cohesive plan, budget, and reporting system.

- ACF implementation of <u>Executive Order 14112- Reforming Federal Funding and Support for Tribal Nations to Better Embrace Our Trust Responsibilities and Promote the Next Era of Tribal Self-Determination</u> (see more below)
 - Sec. 4. Embracing Our Trust Responsibilities by Assessing Unmet Federal Obligations to Support Tribal Nations.
 - Sec. 5. Agency Actions to Increase the Accessibility, Equity, Flexibility, and Utility of Federal Funding and Support Programs for Tribal Nations.

Meeting Logistics:

The ACF Tribal Consultation is being held immediately following the Great Lakes Tribal Economic Summit, scheduled on September 17-18, in New Buffalo, Michigan.

The in-person Tribal Consultation meeting will be held on September 18th at the Silver Creek Event Center, owned by the Pokagon Band of Potawatomi Indians, from 1:00-4:30 EDT, with a virtual option available for those unable to travel.

Written Comment Period:

In addition to the Tribal Consultation session, ACF will accept written comments by email sent to Jeff Hild, Principal Deputy Assistant Secretary, performing the delegable duties of Assistant Secretary, at: tribalaffairs@acf.hhs.gov. The testimony record will be kept open for 30 days after the date of the consultation.

Consultation Questions

ACF is considering ways to estimate unmet needs, which will be used to administer and design policy recommendations that reflect ACF's commitment to self-determination and implementing Executive Order 14112 – Reforming Federal Funding and Support for Tribal Nations to Better Embrace Our Trust Responsibilities and Promote the Next Era of Tribal Self-Determination. The executive order requires federal agencies to take action to ensure federal funding for tribes is accessible, flexible, and equitable, creates a one-stop-shop for federal funding available to tribes, and better embraces our trust responsibilities by assessing unmet federal obligations to support tribal nations.

ACF invites tribal leaders to provide input on the following questions related to the implementation of Executive Order 14112, and specifically, sections 4 and 5.

- 1. What suggestions do you have regarding a methodology to calculate and assess unmet federal obligations to support tribal nations?
- 2. What information or data would ACF need to assess tribal unmet need in competitive grant programs and grant programs where funds are distributed using a formula?
- 3. The Department will be asked to report on the funding needed for existing programs and the funding needed to better live up to the federal government's trust responsibilities and help address the needs of tribal nations. What budgetary, statutory, regulatory, or other changes do you recommend for the Department to take steps toward upholding the U.S. Government's trust responsibilities and help address the needs of tribal nations?
- 4. What administrative requirements create burden during the application process and subsequent implementation of the grant? (e.g., cost-sharing, matching, draft agreements, requirements applicable to all grants, such as HHS Administrative National Policy Requirements or OMB's Uniform Guidance at 2 CFR 200, etc.)?
- 5. How can ACF use its efforts to design, revise, provide waivers for, and otherwise administer federal funding and support programs for tribal nations, to minimize administrative burdens?
- 6. How can ACF improve outreach on grants that are not directed specifically at tribes but for which tribes may be eligible?

I look forward to our continuing partnership with you to build healthy and thriving communities.
